Charles Henry Miller 1st Texas Cavalry Co. D Enlisted: May 2. 1898 Discharged: April 18, 1899



Charles Henry Miller was 92 years old when he died on September 18, 1965 at Brooke General Hospital on the grounds of Ft. Sam Houston in San Antonio, Texas. Charles joined in army on May 2, 1898 and served until his discharge on April 18, 1899. He was born on December 12, 1873 in Cuero, Texas. After his return from the service, he lived in Yoakum, Texas for 75 years working has a painter and paperhanger most of his life, but later operated a grocery store in Yoakum. He was married to Maggie L. Grandberry and had two daughters and one son, all who survived him.

### Volunteers in the Spanish American War

Otto Richter 1st Texas Cavalry Co. K Enlisted: May 2, 1898 Discharged: April 17, 1899



Otto Richter was born in Weimar, Texas on September 28, 1878. The family moved to Shiner in the early days of Otto's childhood. As a youth he worked at the Shiner Gazette newspaper under the ownership of C.C. Ward and was later employed by the United States Post Office.

Otto enrolled at Texas A&M College, but at the outbreak of the Spanish American Was, he left college and enlisted in the United States Army. He served in Company K as a corporal in Cuba until his discharge.

After his return from Cuba, Otto traveled extensively and told a Shiner reporter that the skills he learned at the Gazette helped him defray the cost of his traveling expenses.

Later in life, he located in Spokane, Washington where he resided for 22 years, serving as a ticket agent for a western railroad until his retirement. Otto met and married his wife, Zoe Ann Curtis< a native of Wisconsin, in Idaho where they resided for several years before moving to Washington.

Otto was buried in Forest Cemetery in Coeur d'Alene, Kootenai County, Idaho.
