Student Rules of Conduct

The Kalkaska Area Transit will provide the best possible care, welfare, safety, and security for every student. Any acts of violence or destruction of property will be reported to law enforcement.

All students are subject to the following rules for safe bus riding:

- KAT has a zero-tolerance policy that prohibits fighting, arguing, acts of intimidation, threats, rudeness, or any form of bullying on all KAT buses.
- All students should be at the designated stops and ready to board the bus on time.
- The bus operator is in charge of the bus at all times. Students are expected to obey the directives of the operator at all times.
- Once seated, students are required to remain seated until the bus stops. Students who fail to remain in their seats will be assigned a seat.
- No Public Displays of Affection (PDA) allowed on any KPTA buses.
- All items are to be kept out of the aisle, including your feet.
- No objects or body parts will be extended outside of the bus windows.
- Throwing of objects inside or out of the windows of the bus is not permitted.
- Horseplay, pushing, shoving, or fighting will not be tolerated on the bus or at the bus stops.
- Drinking, eating, smoking, and use of profanity or foul language is prohibited on the bus.
- Personal audio equipment is permitted, but only with a headset.
- All trash must be placed in the container provided on the bus.
- . Weapons of any kind are not allowed on the bus.

Payment Policy (Woodland)

- A Student pass paid on or <u>before the 1st</u> of the month will cost \$30.00. If a student pass is received <u>after the 1st</u> of the month, the cost will be \$35.00. If a student pass is received <u>after the 15th</u> of the month, the cost will be \$40.00.
- Any student pass <u>not paid by the 20th</u> of the month that service was provided by KPTA will no longer have a reserved seat on the bus.
- All payments must be mailed to KPTA, PO Box 1046, Kalkaska, MI 49646, or paid at the KPTA office at 1251 Island Lake Road, Kalkaska, Michigan. Drivers will not accept payments.

The route begins at the Municipal Parking Lot on Third Street, across from the Post Office in downtown Kalkaska. It travels south on Highway 131 to the American Legion in South Boardman. From Woodland School, riders will have the option to connect with a BATA bus for transportation to various locations within Grand Traverse County.
