I. Purpose of the Form

This form grants permission for the above-named youth to participate in all activities related to the N-Spire Track and Field Club (“NTFC”) program and outlines necessary participation acknowledgements. NTFC by definition encompasses the ownership and management, coaching staff, and volunteers of the club when referenced as “we” or “our” or NTFC as an entity. This Form shall be interpreted under the laws of the State of Nevada and any action hereunder shall be brought in Nevada courts. By signing this form, I acknowledge and agree to the following:

II. Consent and Acknowledgements

- **Participation Consent:** I give permission for my child to participate in all practices, meets, and team events organized by NTFC.
- **Coaches:** Coaching staff will be required to hold a USATF membership, complete required USATF training, be in good standing with USATF, and clear background check to gain membership.
- **Athlete Membership:** I understand that all participants in the NTFC must hold a USATF individual membership in order to participate. I also acknowledge general liability insurance will be afforded under the USATF membership(s) and will warrant separate paperwork and claim filing with that/those organization(s).
- **Financial Commitment:**
 - **Membership Fee:** I understand that participation in the NTFC requires payment of a membership fee to support operational expenses and overhead. These fees are collected for at the beginning of each season the athlete participates in (indoor or summer), annually.
 - Examples include: USATF membership fee, access to the training facility and equipment, jersey, and costs to keep the club operational (i.e. licensure, USATF club fees).
 - **Coaching Fee:** I understand that participation in the NTFC requires me to pay for the coach/coaches’ time monthly regardless of how many sessions the said athlete

attends from the beginning of the season until the conclusion of the season of participation. The athlete will be assessed a coaching fee if no withdrawal, dismissal or release occurs as discussed in the Charges Related to Withdrawal, Discontinuance or Dismissal clause.

- **Participation:** NTFC requires all members to pay their membership fee and first month of the coaching fee up front prior to participating in the club.
- **Timing of Charges:** After the initial membership and 1st month of coaching fees have been charged, the coaching fee will then be charged monthly by the 1st of the month for the remainder of the season, or until the athlete finishes participation (voluntarily or involuntarily), whichever occurs sooner.
- **Late Payments:** Payments must be made by the first of the month, and no later than the 5th of the month. Late payments will not be tolerated and may result in the athlete's dismissal from the team.
- **Refunds:** Membership dues are non-refundable.
- **Charges Related to Withdrawal, Discontinuance, or Dismissal:** All withdrawals must be submitted in writing to NTFC at coachnux@nspiretrackandfield.com. If withdrawing prior to the 1st of the month, the next month's coaching fee and any remaining coaching fees will not be charged. If the athlete is dismissed, released, or withdraws after the 1st of the month, the coaching fee will still be charged and will not be waived or refunded. Definitions of dismissal, release and withdrawal can be found in the NTFC Club Handbook.
- **Fee Changes:** The fees are subject to change at the discretion of club ownership and reasonable notice will be provided when such changes occur. Members will pay the membership fee and coaching fees timely and in accordance to the club rules and code of conduct as a requirement to participate.
- **Code of Conduct:** I have read and understood the club team's rules and code of conduct within the Team Handbook and ensure my child will follow team rules and the code of conduct. I acknowledge that if my child is in violation of the club team's rules or code of conduct, at the sole discretion of the coaching staff and ownership, my child may be dismissed from the team, and fees will follow the Refund and Dismissal clauses.
- **Communication:** I acknowledge that I will be required to utilize and adhere to the team's communication platform (e-mail, third party app like Teams, Remind, or Band) and respond to communications timely and respectfully.
- **Transportation Waiver:** I authorize my athlete to be transported by designated team personnel or volunteers in their personal vehicles for official team activities, practices, meets, and other team-related events. I understand and acknowledge that transportation is a voluntary arrangement, and I understand that there are inherent risks associated with motor vehicle travel, including but not limited to the risk of accident, personal injury, illness, or death. With full knowledge of these risks, I voluntarily consent to my child participating in this form of transportation and assume all risks of injury or harm to my child associated with this travel. In consideration for my child being permitted to participate in this transportation arrangement, I hereby release and forever discharge NTFC and its ownership, coaching staff, and volunteers, from any and all liability, claims, and

demands of any nature for any loss, damage, or injury, including death, that may be sustained by my child while traveling to or from team events in a personal vehicle. This release extends to any acts of negligence on the part of the coach or organization, to the fullest extent permitted by law

- **Acknowledgement of valid driver's license and automobile insurance:** This confirms that the designated team personnel or volunteers have a valid Nevada driver's license and automobile insurance, but that NTFC is not responsible for verifying it. The parent's health insurance, and the coach's automobile insurance will be the primary sources of coverage in case of an accident.
- **Media Release:** I give permission and grant NTFC the right to take photographs and videos of my child for any legitimate purposes, including but not limited to training and education, illustration, promotional materials, advertising, club websites, social media, without any payment, compensation, or recognition. I hereby grant the irrevocable, perpetual, worldwide, and royalty-free right and permission to use, publish, and license the athlete's name, voice, image and likeness captured in photographs, videos, or other recordings during club activities. I further waive any right to inspect or approve the finished product, its use, or any written copy. I hereby release and discharge NTFC from any and all claims and demands arising out of or in connection with the use of the photography, videos, audio recordings, including and without limitation any and all claims for libel, invasion of privacy or any expectation of confidentiality.
- **Assumption of Risk:** I understand that participation in track and field involves physical activity and inherent risks, including injury and death. I understand and voluntarily accept that participation in running club activities include minor injuries (including but not limited to: scrapes, bruises, sprains), more serious injuries (including but not limited to: joint, muscle, bone injuries, concussions), heat-related issues, catastrophic injuries like heart attacks, and hazards like falls, contact with others or objects, traffic, adverse weather, and exposure to communicable diseases. I assume full responsibility for any risks associated with participation, and release NTFC team, coaches and affiliated organizations from liability for these risks, injuries or accidents. I also acknowledge that an athletic trainer will not be onsite, nor available for practices, and the coaches will follow the Health and Emergency Information Form filled out for said athlete in the event of an emergency.
- **Release and Indemnification:** In exchange for participating in club activities, I hereby release, indemnify and agree not to sue the NTFC or its affiliates, officers, directors and any persons affiliated with said club and/or team (such as but not limited to coaches and volunteers) upon which said player participates for or on account of any and all claims for liability, injury, or death whether caused by negligence, strict liability, or otherwise, while the athlete is practicing on the track or field or facility in any event or activity sponsored by or associated with the club. Participants agree to indemnify and hold harmless the club and its representatives from any claims, suits, costs, and liabilities, including attorneys' fees, resulting from their membership and participation. Participants also agree to defend the club against claims related to their own negligence or actions during club activities.
