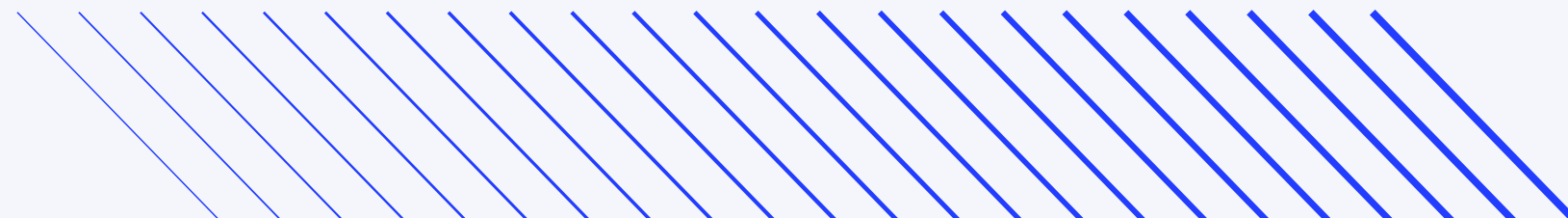
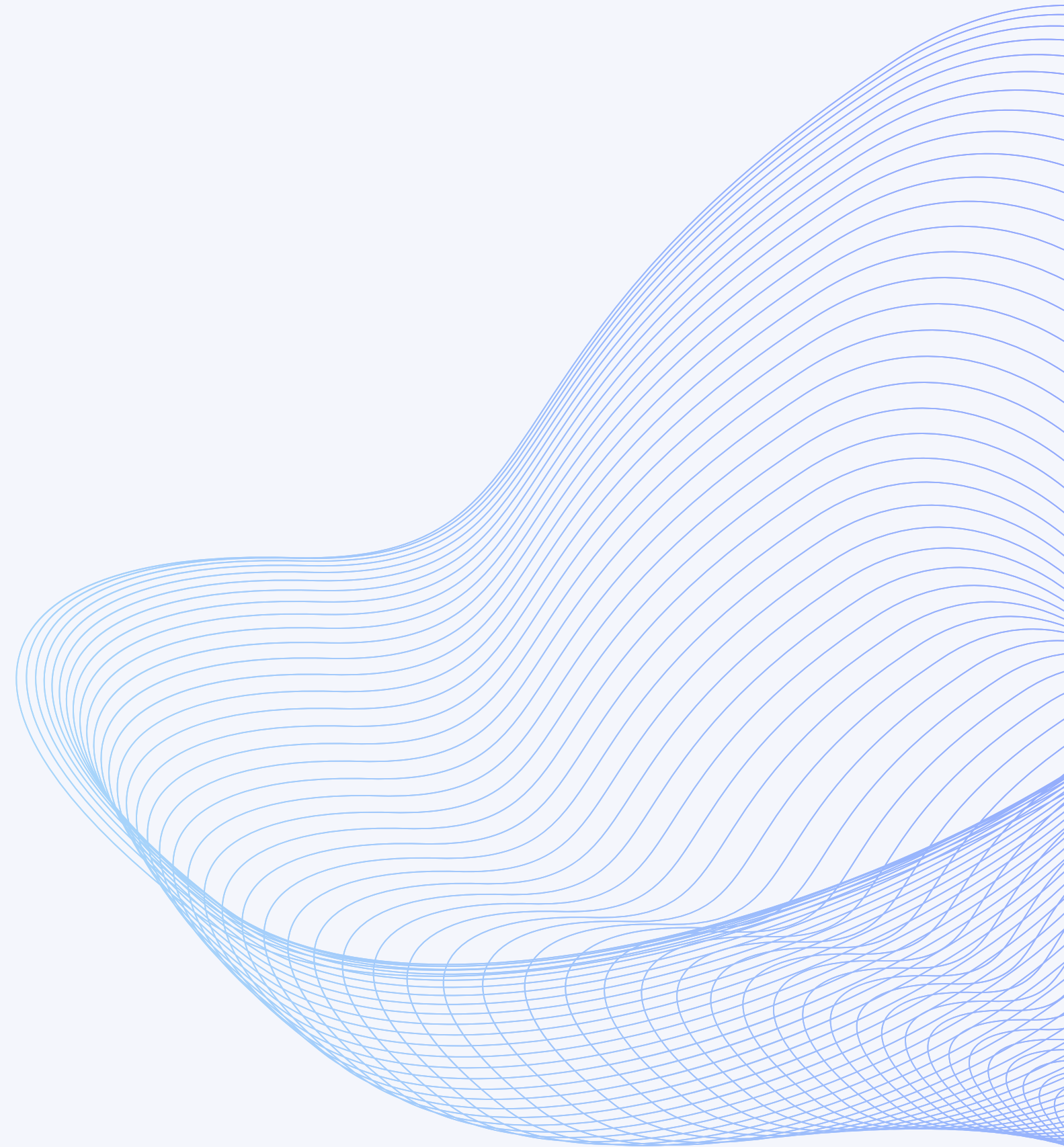

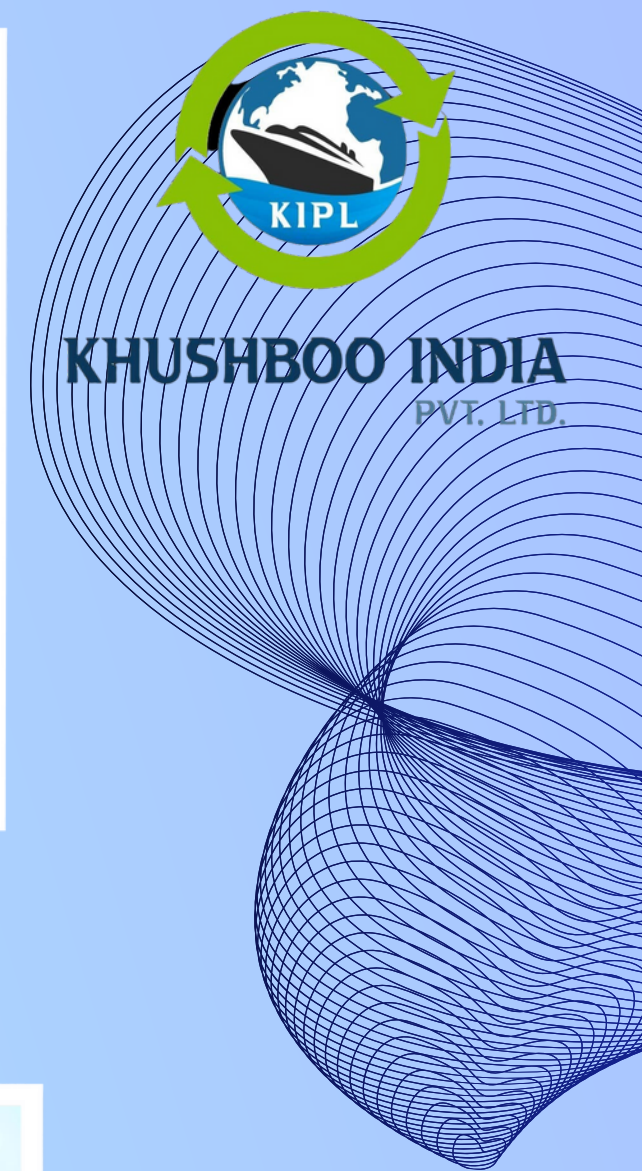

- **100% RCC**

KIPL has 100% impermeable floor on front and back yard.

- **PNG SUPPLY**

KIPL has ensured that no LPG cylinders will be used for tertiary cutting that reduces the risk of cylinder explosion.

- **HEAVY LIFT CRANES**

KIPL has 208-tonner crawler crane & 30-tonner escort crane which allows to lift all blocks without inter-tidal contamination.

- **CMT SEATING FACILITY**

KIPL has separate seating facility for the compliance monitoring team that helps to identify non-compliances from a far view.

post beaching of the ship custom clearance, breaking of radio equipments & man-entry permission is being granted.

IHM REMOVAL PROCESS

Post seeking man-entry permission loose materials including battery paint and chemical is being safely removed from the ship. Additionally HAZMAT is being safely removed from the ship as per IHM & additional sampling report.

CUTTING PROCESS

Post IHM removal & GPCB inspection, safe dismantling of vessel begins.

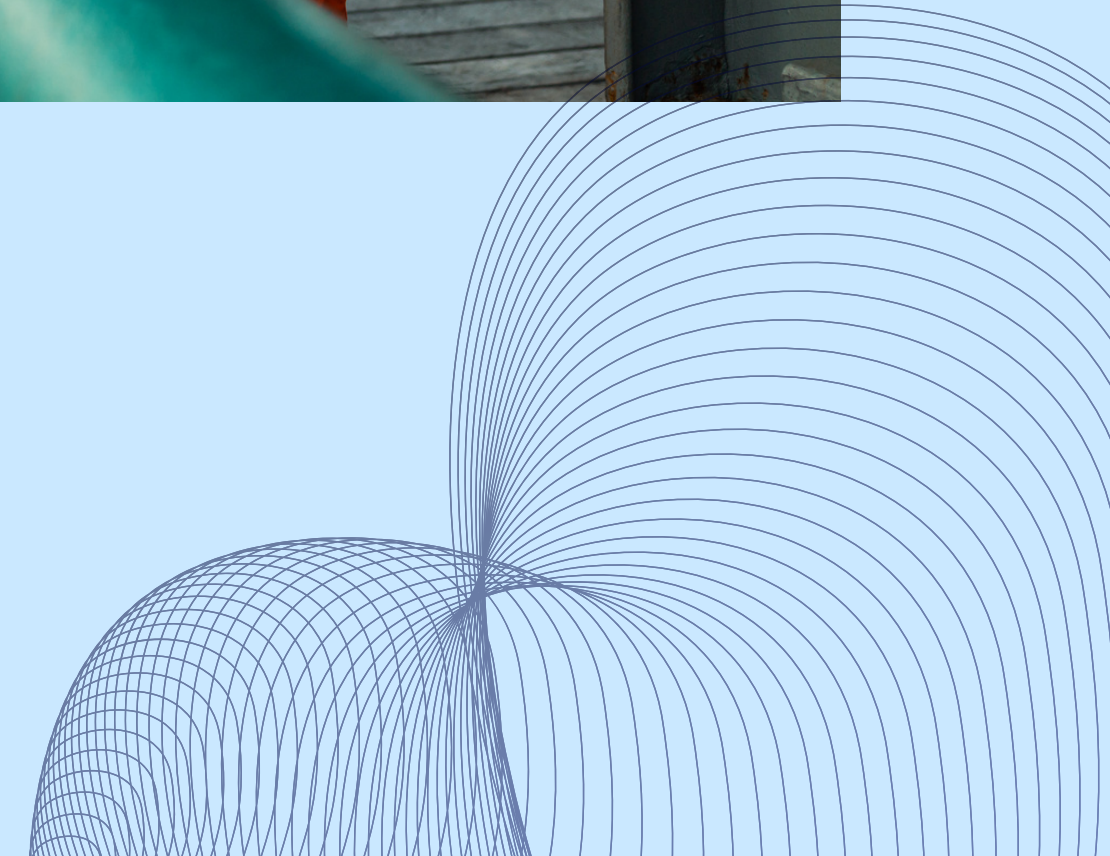
