



Privacy Policy

Our policy is to protect your private information. This privacy policy applies to customers and online individuals using **ConDeck Corporation's** website. For the purpose of this privacy policy, unless otherwise made clear, all references to "website" will refer to **ConDeck Corporation's** business web location www.condeck.com . By using **The Website**, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect personal information about you unless you voluntarily provide it to us. However, you may be required to give certain personal information to us when you choose to use certain services available on our "website" or in person. Use of your Personal Information

Sharing Information with Third-Parties

ConDeck Corporation may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: conform with official lawful orders, complying with legal process served on **ConDeck Corporation** or on the “website”, protect and defend the rights or property of **ConDeck Corporation**, and/or act under exigent circumstances to protect the personal safety of users of the “website”, or the public.

Right to Deletion

- Debug to identify and repair errors that impair existing functionality;

- Exercise free speech, ensure right of another consumer to exercise their right of free speech, or exercise another right provided for by law;
- Comply with existing and new laws;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children under thirteen

ConDeck Corporation does not knowingly collect personally identifiable information from children under the age of thirteen (13). If you are under the age of thirteen (13), you must ask your parent or guardian for permission to use **The Website**.
