

BGMRC DUES STRUCTURE

As required by the BGMRC Bylaws under Article VI DUES section 1 and defined in ARTICLE IX ASSOCIATED DOCUMENTS

These dues will be effective for the 2020 period and remain in effect until membership approves an alternative dues structure. Beginning for 2020 the Dues structure will be as follows:

- \$30.00 For a single **Full** Membership
- \$20.00 for a single **Associate** Membership
- \$40.00 for a **Full** Family Membership
- \$25.00 for a Family **Associate** Membership

ADDITIONAL PROVISIONS AND MEMBERSHIP OPTIONS

- ~~● Newly licensed individuals who join the BGMRC will be offered membership into the BGMRC at **NO CHARGE** for the remainder of the year in which they are initially licensed (New hams only; determined by call-sign grant date)~~
- ~~● Licensed Ham operators under the age of 22 will have the option to join the BGMRC at **NO CHARGE** until the age of 22. **NO CHARGE** BGMRC memberships for young hams will remain available until December 31st of the year in which their 22nd birthday occurs.~~
- ~~● Any person who qualifies for a membership at **NO CHARGE** will have the option to choose their Membership level (Full or Associate) based on their anticipated involvement in the Club. Individuals who qualify for their dues to be eliminated are NOT required to utilize the **NO CHARGE** membership and can pay dues if they prefer.~~

(THE THREE BULLETED PROVISIONS ABOVE WERE STRUCK BY THE MEMBERSHIP AND HAVE BEEN REMOVED FROM THE DOCUMENT BY MAJORITY VOTE AT THE 7/25/19 MEETING)

Membership renewals for the next year will begin on October 1st. of each year and dues are due by January 1st. (As outlined in the BGMRC Bylaws.) of the next year. New members (*person(s) who were not a member at any point during the current year*) who join the BGMRC after October 1st. of each year will immediately become BGMRC members (per their chosen membership level) and will be considered paid until December 31st. of the next year.

The BGMRC will strongly urge those members who are geographically located in a way that would prevent them from being active club members to choose the Associate Member option. Those who have limited time due to work or other personal commitments and cannot dedicate the time needed to be a Member would be encouraged to choose the Associate Member option. Those who want to support the BGMRC and its repeater network or the club but, do not intend on attending meetings or participating on a regular basis should choose the Associate Member option.

The membership options will be voluntary and chosen by the member when joining or renewing his/her membership. No Member will be forced to choose an associate membership however, Full Membership does have an expectation of participation in Club events and meetings.

The Dues for all level(s) of Members and Membership will be outlined in this document and the BGMRC Dues structure as approved by the Club's Members.
