## APPROVAL OF THE MINUTES OF THE AUGUST 27, 2019 BOARD MEETING

## **FINANCIALS**

The proposal from Supreme for power washing was signed by Ms. Vicedomini. Ken Hess was asked to send an email to owners regarding options they have for having their own property power washed.

Gate transponders that are "first generation" no longer work with the newest reader. Owners are being given "third generation" transponders at no cost to them when replacing the old transponders. More transponders are needing to be ordered.

## **OLD BUSINESS**

The Capital Contribution is now able to be implemented for all sales of properties going forward. The contribution is equal to two (2) quarterly assessments. This will be included as part of the estoppel process when buyers are working with the title company.

Ken Hess was instructed to send the remaining balance to the holiday decoration vendor, Giolis Illumination, in order to complete this year's payments.

It was noted that two lights have been knocked over at the gate entrance and are in need of repair.

## **NEW BUSINESS**

Ken Hess reported on property matters. Repairs were made to the lawn at the north circle where a truck had driven into the grass and made large ruts in the lawn. No charge was incurred for the repairs.

Dorrill Management is up and running with AppFolio. Currently both the old and new systems are being maintained to provide a backup.

Ken Hess will work on the initial budget for 2020 for the next meeting.

The Social Calendar has had some revisions and an updated version is being sent to all owners.
