NOTICE OF PROPOSED CLASS ACTION PARTIAL SETTLEMENT, FAIRNESS HEARING AND RIGHT TO APPEAR

If you are a Missouri resident who signed a lease with KM-T.E.H. Realty 8, LLC or Ruskin Place Apartments and rented at Ruskin Place Apartments between July 2015 and the present, you could get a payment from a class action settlement.

A partial settlement of a class action lawsuit affects you if you signed a lease with KM-T.E.H. Realty 8, LLC or Ruskin Place Apartments and rented at Ruskin Place Apartments between July 2015 and the present. If you qualify, you may send in a claim form to ask for payment, or you can exclude yourself from the settlement, or object.

The Circuit Court of Jackson County, Missouri at Kansas City authorized this notice. The Court will have a hearing to consider whether to approve the partial settlement, so that the benefits may be paid.

WHO'S AFFECTED?

Missouri residents who signed a lease with KM-T.E.H. Realty 8, LLC or Ruskin Place Apartments and rented at Ruskin Place Apartments between July 2015 and the present are included in this partial settlement. *If you fit the above description, you are a 'Class Member.'*

WHAT'S THIS ABOUT?

A lawsuit in <u>Fuentes</u>, et al. v. <u>KM-T.E.H. Realty 8</u>, <u>LLC</u>, et al., Case No. 2016-CV19826, claims that Allied World Assurance Company (U.S.), Inc. ("Allied") provided insurance that might

satisfy part of a Judgment in <u>Fuentes</u>, et al. v. <u>KM-T.E.H. Realty 8</u>, <u>LLC</u>, et al., Case No. 1916-CV29273. The suit claims the insurance money should be available to satisfy the Judgment. Allied denies all allegations and has asserted many defenses, including that it never received notice of the claim and therefore, no insurance funds are available. The partial settlement is not an admission of wrongdoing or an indication that any law was violated.

WHAT CAN YOU GET FROM THE PARTIAL SETTLEMENT?

The partial settlement will result in a payment of \$1,675,000.00 to be divided up as the Court may direct.

HOW DO YOU GET A PAYMENT?

In the event the Court approves of this partial settlement, the court will also determine class counsel's fees and expenses to date, and whether excess funds are available for class distribution.

WHAT ARE YOUR OPTIONS?

The Court will hold a hearing in this case, <u>Fuentes</u>, et al. v. <u>KM-T.E.H. Realty 8</u>, <u>LLC</u>, et <u>al.</u>, Case No. 1916-CV29273 on November 17, 2025 at 10:00 a.m. CST, via Webex (available at this link <u>mocourts.webex.com/meet/joel.fahnestock</u>) and by phone at 1-408-418-9388 and access code: 966278533, to consider whether to approve the partial settlement, which includes payment of attorneys' fees and expenses.

You may appear at the hearing, but you do not have to. You may seek legal representation for the hearing. You may object to the partial settlement in writing to Class Counsel by November 6, 2025. You may exclude yourself from the partial settlement by writing to Class Counsel by November 6, 2025.
