1. This Competition is promoted by Manorite T/A EH Hassim Hardware Mokopane (Registration Number: 2018/278866/07) and Eisocento (Pty) Ltd T/A EH Hassim Hardware Polokwane and Seshego (Registration Number: 2015/086039/07), duly incorporated in the Republic of South Africa, trading as "EH Hassim Hardware" (the "Promoter"), as part of its promotional campaign in partnership with participating partners. In this document they will be referred to collectively as "the Promoters".
