Festival schedule:

Festival hours are Saturday, August 29th, 2020, 9 a.m. – 6 p.m.

Setup will take place Saturday, August 29th, 2020 7 a.m. – 8:30 a.m.

Breakdown will begin at 6 p.m. on Saturday, August 29th, 2020 and **must** be completed by 9 p.m. on Saturday, August 29th, 2020.

Check-In:

All vendors must sign in at the ‘Vendor Sign-In Tent’ on Saturday, August 29th, 2020 beginning at 7 a.m.

This is where vendors will receive space assignments and hospitality packets. Space assignments will ***not*** be given out prior to the event. Special requests for locations can not be guaranteed and are based on availability and layout.

Restrooms:

Public restroom facilities will be located throughout the event.

Inclement Weather or Public Health Access:

This event will go on rain or shine; however, if public safety officials, Hog Happenin’ Foundation, Inc, and/or American Legion Post 380 representatives dictate cancellation of the event due to severe weather, COVID 19, or any other public health crisis neither Hog Happenin’ Foundation, Inc, American Legion Post 380, nor any partnering agencies will be bound to reschedule the event, nor will the aforementioned entities be bound to reimburse any fees.

Electric:

Electricity is not available. If you need electricity, please plan to bring a QUIET generator. Loud generators will not be allowed, violators will be asked to leave.

Parking:

Vehicles will be allowed within the event area as pre-approved by Staff.

All vendors are responsible for providing their own equipment; example: tents, tables, etc.

IMPORTANT—Please keep in mind the organizer of this event does NOT own the property where the event is held. We ask that you take all of your waste and belongings back home with you and leave your site as it was when you arrived.
