EQUIPMENT TYPICALLY AVAILABLE: During holidays and through the summer please call ahead. Bedside commodes, crutches, canes, hospital beds with rails, knee scooters, shower chairs and benches, toilet risers, walkers; folding and 4 wheeled with seat and Parkinson walkers, wheel chairs and transport wheel chairs.

The LOAN CLOSET is a non-profit service of the Estes Park Quota, whereby sick room and hospital equipment is available for loan to area residents & visitors. We are located on Estes Park Health's, Parking lot in the NORTH- WEST corner next to the Foundation office. **Quota is in the two adjacent garages.** THE HOSPITAL ADDRESS: 555 Prospect Ave. Estes Park CO 80517

POLICIES

CHECKOUT:

Equipment may be checked out by telephoning any Loan Closet representative on call. A list of names and phone numbers for each day of the month will be posted near the Loan Closet door and with local physicians, hospital emergency room and nursing stations.

HOURS: Committee members are ON CALL from 9 AM to 6 PM seven days a week.

RETURN OF EQUIPMENT:

All loaned equipment is to be properly checked in at the Loan Closet with a representative by calling a scheduled member to make arrangements.

EQUIPMENT IS NOT TO BE LEFT IN THE HOSPITAL OR OUTSIDE THE LOAN CLOSET

RESPONSIBILITY FOR EQUIPMENT: Equipment is loaned in an As Is Condition. The borrower is responsible for equipment loaned until it is properly returned to an authorized Loan Closet representative.

Equipment should be returned in clean condition, please

TERM OF LOAN: Loans are intended to be on a temporary basis, generally up to three months. Longer periods may be permitted by special arrangements.

IN-STATE USE: Loans are intended for use **only** within the State of Colorado for Estes Park residents or visitors. Other arrangements should be made for use out of state.

PROPER USE OF EQUIPMENT: Loan Closet representatives are not medical professionals. All users of borrowed equipment should seek instruction on the proper use of any equipment from a Doctor or medical professional.

DEPOSITS AND DONATIONS: A deposit is required on all equipment loaned. Cash or Check will be held until the equipment is returned and checked in. Deposits will then be returned in full or a donation of all or part will be gratefully accepted to help maintain the equipment or purchase new. DONATIONS of new or gently used equipment in good condition may also be accepted and for all gifts, a tax deduction receipt can be issued.
