POLICIES

#### CHECKOUT:

Equipment may be checked out by telephoning any Loan Closet volunteer on call. A list of names and phone numbers for each week will be posted near the Loan Closet door and with local physicians, hospital emergency room and nursing stations, as well as online. www.estesparkquota.com

HOURS: Quota Volunteers are on call from 9 AM to 5 PM seven days a week, by appointment only.

RETURN OF EQUIPMENT: All loaned equipment is to be properly checked in at the Loan Closet with a volunteer by calling a scheduled volunteer to make arrangements.

# EQUIPMENT IS NOT TO BE LEFT IN THE HOSPITAL OR OUTSIDE THE LOAN CLOSET

## RESPONSIBILITY FOR EQUIPMENT: PLEASE NOTIFY US IMMEDIATELY IF EQUIPMENT MALFUNCTIONS

Equipment is loaned in clean condition. The borrower is responsible for equipment loaned until it is properly returned to an authorized Loan Closet representative.

### Please return Equipment in clean condition.

#### **TERM OF LOAN:**

Loans are intended to be on a temporary basis, generally up to three months. Longer periods may be permitted by special arrangements.

### **IN-STATE USE:**

Loans are intended for use only within the State of Colorado for Estes Park residents or visitors. Other arrangements should be made for use out of area or out of state.

### PROPER USE OF EQUIPMENT:

Loan Closet representatives are not medical professionals. All users of borrowed equipment should seek instruction on the proper use of any equipment from a Doctor or medical professional.

### **DEPOSITS AND DONATIONS:**

A deposit is required on all equipment loaned. Cash or Check will be held until the equipment is returned and checked in. Deposits will then be returned in full or a donation of all or part will be gratefully accepted to help maintain the equipment or purchase new. DONATIONS of new or gently used equipment in good condition may be accepted and for all donations, a tax deduction receipt can be issued, on request
