FUN FACTS #6 - #13

- #6 In the spring of 1965, a private water district was incorporated to provide service to the Trails End lots, with Ira Edwards as president. This water district subsequently purchased by the Trails End Water District.
- #7 In May 1966, the Trails End Community Club was approved as a non-profit corporation, with membership being voluntary. The first president was George Milnor.
- #8 In May 1966, a gift deed was received by the Trails End Community Club, from the Suth Kitsap Investment Co., for the following lots:
 - (a) Lot 14, Block 2, Div. 1 (Friendship Beach)
 - (b) Lot 33, Block 2, Div. 1 (Sold in 1994)
 - (c) Lot 16, Block 5, Div. 2 (North Beach)
 - (d) Lot 17, Block 5, Div. 2 (Snag Beach—sold in 1991)
 - (e) Portion of Happy Hollow 5 acre tracts—tracts nos. 10 and 11 (Olympic View Beach OHod Canal property)
- #9 By the summer of 1969, there was a second selling of the lots still unsold by the original developers
- #10 In August or September 1969, by quit-claim deed, the Club acquired Lot 45, Block 2, Div. 2 (gift deeded to the Trails End Water District in 1984)
- #11 In 1992, the Club purchased Lot 3, Block 2, Div. 2 for the site of a future clubhouse.
- #12 In 1994, the Club purchased Lot 4, Block 3, Div. 2, for use as a parking lot for the clubhouse.
- #13 In 1995, work began on the clubhouse, which is now completed, and used for Club and community activities.
