**EDC RULES**

1. Arrive promptly to class in the proper uniform.
2. No food or drinks in class.
3. We ask that all people in the waiting area speak softly while class isn't in session.
4. Hair is to be worn up and away from the face
  - Ballet/Modern - Neatly in a bun. No bangs or loose hair
  - All other classes - Neatly in a ponytail. No loose hair. No jewelry except small stud earrings.

## **TUITION**

**Class Price** - \$50 per month. Tuition remains the same each month, regardless of scheduled holidays or canceled classes due to weather conditions.

**Registration Fee** - \$25 - New Student Fee \$10 - Returning Student Fee

**June Tuition** - Half of June's tuition is due by October 1, 2018. The final June tuition payment is due by February 1, 2019. If a child discontinues classes before Thanksgiving Recess, a refund of June tuition will be made. After the Thanksgiving Recess, no refunds will be made.

**Payment Plan Options** - EDC offers three payment options:

- Full Year Payment – Due on September 10th
- Semiannual Payments – 2 payments due on September 10th and February 1st
- Monthly Payments – Due on the 1st of each month

**Late Fees - \$10.00 late fees are added to any tuition payments made after the 10th of each month.**

Student's with tuition accounts that are 2 months past due will not be allowed to take classes.

Student's with any outstanding tuition balances in June will not be allowed to participate in the Annual Concert unless full payment is made.

## **PAYMENT POLICIES**

- We accept cash, check, Visa or MasterCard. All checks must be made payable to Effusion Dance Collective.
- A fee of \$2.50 will be added to all credit card transactions
- A \$35.00 fee will be charged for any returned checks.
- Checks will no longer be accepted for payment if an account incurs two returned check fees.
- Post-dated checks will not be accepted for payment
- If you or your child wishes to discontinue class at any time during the year, please notify an EDC Director at least 1-week prior to the start of the new month.

## **COSTUMES**

Costume fees are estimated at \$60.00 - \$75.00 per class.

**\*Please note this fee is an estimate and is subject to change.**

Your child's exact costume costs will be provided in December. **EDC encourages you to make payments toward your costume fee prior to December.** Some dance shoes will need to be dyed to match the student's skin tone. Dye paint may be purchased from the office for \$12.00.

## **ATTENDANCE POLICIES**

- Pick-up/drop-off of students is preferred to minimize congestion in the lobby (This does not apply to students enrolled in classes with 2 ½ - 4 year olds.)
- **Please be prompt in picking up your child. EDC is not responsible for children left unattended before/after their class times.**
- **Please call when your child will be absent or late.**
- No student will be permitted to leave without a parent or guardian.
- We ask that you drop your child off no earlier than 10 minutes before class.
