

## LAST ANNUAL MEETING MINUTES

January 19, 2025

Meeting was called to order by Foundation President Dave Pratt at 11:32am.

Minutes from the previous meeting held January 21, 2024 were read by Janet Erickson. Motion to approve was made by Joyce Vera, seconded by Blayne Watts. Motion was approved.

President's report was made by Dave Pratt. The Foundation non-profit status (501c3) is separate from that of the church. See attached report from 2024 FLC Annual Report.

Treasurer's report was given by Jeff Skidmore. See attached report. The Foundation provided \$1,245.00 to Church and Preschool in 2024 from their invested funds. Foundation income from interest and earnings had a gain of 8.3% in 2024.

1. Election of Board members: Melinda Lynnes, Sandy Rabe and Jeff Skidmore have completed their three-year terms. All have volunteered for another term. No nominations were received from the floor. ## ANNUAL REPORT for the Year Ending 12/31/2025

*The First Lutheran Church Foundation was established in January of 1987 during the Church's Annual Meeting to provide a living fund for the purpose of supporting the mission and programs of the First Lutheran Church (FLC) of Miles City.*

*The Foundation's basic goal is to hold and wisely manage gifts in perpetuity, using only the annual interest and earnings from such gifts to support the various programs and needs of FLC and ministries in the areas of:*

- *Education in the form of Scholarships*
- *Outreach to Miles City*
- *Outreach to rural congregations*
- *First Lutheran Church Growth such as physical plant and grounds improvements, emergencies and helping with unexpected expenses. (Not intended for normal / annual operating/ maintenance costs.)*

First and foremost, on behalf to the Foundation I would like to thank Tom Speelmon and Janet Erickson for their service on the Foundation Board. Tom is retiring from the board after 15 years. Janet continues to serve as a board member but no longer wishes to be the Board Secretary a position she has held since 2009.

2025 was another quiet year from a financial perspective. Total expenses were \$15,281.93. Total assets at the end of 2025 were \$470,098.66, up from last year of \$441,68.94 for a 6.56% gain after expenses. Annual earnings are invested in money market accounts and then reinvested in the bond and equity accounts to keep us balanced with 75% equity and 25% bonds. New gifts to the Foundation total \$2,000.

The Foundation has been managing \$15,000 each for FLC and Let Me Shine Preschool for their future benefit. These funds are not considered part of the gifts held in perpetuity by the Foundation. Interest and earnings are distributed annually to FLC and Let Me Shine Preschool (LMS) - distributions of \$1,245.00 to each were made in January 2025.

2025 Foundation Expenses include \$10,358.43 for the gas line repair, \$500 donation to ST. John's on behalf of the church, \$433.50 for accounting services and a \$1,500 Scholarship to Ashtyn Brugger. Beyond the annual scholarship the Foundation typically supports FLC needs if requested by the Church.

The Foundation was incorporated in October of 1987 under the laws of the State of Montana and in 1988 it was granted 501-C (3) IRS tax exempt status as a non-profit corporation organized for religious purposes. All members in good standing in FLC are members of the Foundation. The Foundation Board of Directors has nine directors who are elected at the Annual FLC Foundation Meeting by the FLC membership to serve three-year terms on a rotating basis.

Gifts to the Foundation are "tax exempt" charitable contributions and tax deductible as allowed by federal and state tax laws. Charitable Gifts can be given directly to the Foundation or through First Lutheran Church. Many individuals discover their spendable income actually can increase by making favored contributions. Contributors are urged to consult an attorney or tax consultant before completing arrangements for major gifts. Please consider naming the First Lutheran Church Foundation in your estate plan. All gifts including Cash, Memorials, Bequests and Wills, Securities and Real Estate, Life Estate Contracts, Deferred Gift Annuities, Life Insurance and Charitable Remainder Trusts among others are gratefully and prayerfully accepted.

# Minutes of the Previous Annual Meeting

A printed 2024 Annual Reports packet was available for all attendees.

Council president Kristine Harding called the meeting to order at 11:45am, upon the conclusion of the annual Foundation meeting.

A quorum was established, as there were 37 voting members out of a current total of 225. The 10% attendance requisite was satisfied.

A huge thank you to Mollie Phipps and Geneal Bott for organizing lunch and providing a main dish!

## **Minutes:**

- Anna Matthews (Council secretary) read the 2024 annual congregational meeting minutes as transcribed by Kris Lohrke. It was noted that some spelling will be fixed. Lillian Ostendorf stated that Carolyn Kimball's name needs to be added to the audit committee.
- **Motion:** Blayne Watts moved to accept the 2024 congregational meeting minutes as amended. Zeda Stairs seconded. Motion carried, unanimous.

**Reports** (refer to the 2024 Annual Reports packet for details)

## **Pastor:**

- Pastor Mike presented the pastoral report.

## **Executive Council:**

- Kristine stated that this has been a year of change for FLC. She thanked Jim Bott and Pam Griffin for their service on the Council, thanked Jan Pratt for stepping in as church secretary and mentioned that the janitorial position is currently open. She also encouraged all congregation members to be involved in the church.

#### **Audit Committee:**

- Carolyn Kimball presented the audit committee report.
- **Motion:** Jeff Skidmore moved to accept the audit committee report. Lillian Ostendorf seconded. Motion carried, unanimous.

#### **Finance Committee:**

- Jim Bott presented the finance committee report and the proposed 2025 budget.
- The gas line repair was a major expenditure this year (approximately \$20,000); fortunately, we were able to hire locally for this repair, which lessened the expense.
- We were very close to our proposed budget for 2024.
- It has been decided that Pastor Mike will go to half time employment to help alleviate the budget.
- The St. John's United donation came from the Council this year, and Lina Moore thought that it had been established that this donation would come from the Foundation. She stated that she would provide the letters establishing as such. Dave Pratt stated that the St. John's donation is not budgeted by the Foundation, but they are happy to consider requests. It was also noted that FLC gave more than other churches this year.
- April Giordanengo commended the finance committee on their efforts compiling the 2025 budget.
- **Motion:** Zelda Stairs moved to accept the 2025 budget as presented. Geneal Bott seconded. Motion carried, unanimous.

#### **Building and Property Committee:**

- Jim Bott presented the building and property committee report.
- The gasline leak was the biggest concern this year. Some concrete still needs to be poured. Thank you to Dave Pratt for repairing the siding on the LMS shed.
- Thank you to Janet Erickson for paying for the fertilizer and weed control.
- The submersible pump for the sprinkler system, along with some valves, needs to be replaced.
- We are currently seeking bids to replace at least two of the fuse panels.
- Our riding lawn mower needs to be replaced.
- The floors need to be waxed soon.
- We also need to replace lights with energy efficient LED ones.

#### **Nominating Committee:**

- Outgoing committee Jim Bott, Pam Griffin, Janelle Notbohm and Jeff Skidmore presented candidates for Council: Dave Pratt and Lea Moore.
- **Motion:** Geneal Bott moved to appoint Lea Moore and Dave Pratt to each serve a three-year term on the Council. Zelda Stairs seconded. Motion carried, unanimous.
- Audit committee: Carolyn Kimball has completed her three-year term and Geneal Bott has completed year 1 of 3. **Motion:** Becky Watts moved to appoint Janelle Notbohm to a three-

year term on the audit committee. Lina Moore seconded. Motion carried, unanimous. The committee for 2025 will be Geneal, Janelle, and a third person appointed by Council later.

- The nominating committee will include Kristine Harding and Anna Matthews as outgoing Council members. Ed Heinle has offered to join the committee. Geneal Bott asked for an explanation of the nominating committee's role (to appoint Council, audit committee and nomination committee members) and subsequently nominated herself. It was clarified that Geneal may serve on the audit and nominating committees concurrently.
- **Motion:** Carolyn Kimball moved to appoint Kristine Harding, Anna Matthews, Ed Heinle and Geneal Bott to the nominating committee. Mike Milmine seconded. Motion carried, unanimous.
- St. John's United: Pam Griffin and Lina Moore would both like to continue as our representatives to SJU. Lillian Ostendorf volunteered to be an alternate. **Motion:** Mollie Phipps moved to appoint Pam Griffin, Lina Moore, and Lillian Ostendorf to be our SJU representatives. Jeff Skidmore seconded. Motion carried, unanimous.

#### **Worship and Music Committee:**

- Pastor Mike presented the worship and music committee report. He thanked Joyce Vera and Sam Giordanengo's faithful service.

#### **Altar Guild:**

- Sandy Rabe submitted the altar guild report. More members are needed to assist.

#### **Social Media:**

- Mike Milmine said the goal is to keep our website and Facebook account up to date.

#### **Let Me Shine Preschool:**

- The Let Me Shine committee submitted their report.
- Becky Watts will be stepping down as director after this school year, so the position will be open. Many thanks to Becky for her service!

#### **BLAST and Fun Faith Fridays:**

- Lina Moore presented the BLAST and Fun Faith Fridays report and provided missions work report handouts. Fun Faith Fridays have not been held this past fall but will hopefully start again soon.
- The VA will move to the old Friendship Villa location. FLC has been very active in supporting the VA nursing home.

#### **Youth Group and VBS:**

- Mollie presented the youth group and VBS report.

#### **Confirmation:**

- Pastor Mike stated that seven were confirmed in FLC this year: Kinley Harding, Nate Muggli, Kash Rosenbaum, Kane Rosenbaum, Keaton Rosenbaum, Kanin Brugger and Peyton Hubbel.

**Men's Fellowship:**

- Mark Joblinske submitted the men's fellowship report. The men meet Saturday mornings at 7am for coffee, breakfast and fellowship.

**Video Study:**

- Mike Milmine stated that the video study of The Chosen will start again this spring with season 3.

**Quilters:**

- Meliss Rolf submitted the quilters' report.

**Meals on Wheels:**

- Janet Erickson presented the Meals on Wheels report. We have completed two out of our four weeks so far.

**Parish Nursing:**

- Janet Erickson submitted the Parish Nursing report. This ministry began in 1997 and has provided office hours and medical support to the congregation. Bonnie Hofer, Denise Singleton and Janet Erickson are the remaining nurses, though Denise is the only one still registered. The nurses have decided to cease office hours but will continue to offer medical advice and medical equipment as needed. Thank you to our nurses for your wonderful service!

**St. John's United:**

- Lina Moore presented the St. John's United report discussing the many services they provide.

## Pastor's Report

Dear Saints of First Lutheran Church,

This past year has placed First Lutheran in a meaningful season of transition. Following the conclusion of Pastor Mike's ministry last spring, and mindful of the faithful thirty-year ministry of Pastor Steve that concluded in January of 2021, this congregation continues to walk a path that calls for patience, prayer, and trust in the Lord's provision.

Seasons of vacancy often invite mixed emotions. There is a desire for stability and normalcy, even as there is anticipation for what the Lord will yet do. In many ways, this season resembles the Church's seasons of waiting—times like Advent or Lent—when God's people are reminded that waiting is not inactivity, but faithful attentiveness. In such seasons, the Lord forms His people not by their strength, but by His promises.

Jesus reminds us that He is the Good Shepherd, and that His sheep are known, kept, and sustained by Him. While the under-shepherd may change, Christ remains present and active among His people. He has not left this congregation without care, nor has He ceased to guide His Church through Word and Sacrament.

Throughout this past year, the life of the Body of Christ has been evident among you. Worship has continued. Teaching and learning have continued. Prayer, service, music, and mutual care have continued as well. Many have served faithfully, often quietly, ensuring that the Church's life together remains centered on Christ rather than on any one person or role.

As you move forward in the call process, this season invites not only confidence, but humility. The Church does not belong to us; it belongs to Christ. Discernment is best carried out not through comparison or certainty, but through prayerful dependence on the Lord, trusting that He alone knows what His Church needs and when it is needed. Humility keeps us attentive to God's leading and open to His work, even when that work unfolds differently than we expect.

Be encouraged. This season is not permanent. God, who has faithfully provided shepherds for this flock in the past, will do so again. Until that time, continue in faithful stewardship, patient prayer, and humble trust, confident that the Lord who has sustained you thus far will lead you forward in His time.

## **President's Report: Executive/Personnel Committee**

*Chm. Sam Giordanengo (Council Pres), Mike Milmine (VP), Mollie Phipps (Sec), Jeff Skidmore (Treas)*

Council officers were elected following the Annual Meeting and were installed during worship February 16. Anna Matthews left Council midyear and Mollie Phipps took over as secretary. Mark Joblinske was appointed to complete this year of Anna's term. Pastor Mike Fiske was released from his call in April, and the Call Committee was activated in June to begin the search for a new pastor.

The council tightened financial controls for purchase orders and credit card use, resulting in the adoption of a formal purchasing policy. New credit cards for FLC and Let Me Shine Preschool were later approved. The finance committee maintained oversight, consolidated bank accounts, and prepared for the 2026 budget.

The council oversaw a transition in Let Me Shine Preschool leadership, culminating in the hiring of a new director, Heather Notsch. The council provided support with budget oversight via continuing resolutions and operational guidance. LMS activities, including Butter Braid sales and Christmas programs, continued successfully.

Significant attention was given to maintaining and improving church facilities. Major projects included replacing two aging electrical panels, repairing plumbing leaks and a broken window, addressing issues with the well and sprinkler system, and planning for future work such as sidewalk repairs and ceiling tile replacement. A dedicated Building and Property Committee, led by Dave Pratt, managed a proactive work plan.

Council committees were active throughout the year. The Worship Committee coordinated pulpit supply, Lenten services, and special events. A standard honorarium for guest pastors was approved. The Education Committee oversaw confirmation classes, baptism and first communion classes, and youth education programs. The Fellowship Committee organized monthly lunches, a chili cookoff, a farewell BBQ for Pastor Fiske, and Christmas events. The Stewardship Committee managed donations to community organizations. The Council focused on improving checks and balances and began discussions of long-term strategic planning and potential dual rostering with the LCMC. The council held several closed executive sessions to address sensitive personnel and legal matters.

The 2025 council year was marked by faithful stewardship amid significant transition and challenge. The council navigated pastoral change and property demands while sustaining the core ministries of worship, education, and outreach. The establishment of stronger financial policies and the activation of a Call Committee have positioned the congregation for a stable and hopeful future.

A huge thank you to the volunteers who always seem to step up when something needs doing at the church. Several critical projects required attention this past year including:

- Cleanup and landscaping after the gas line repair. This included fixing the irrigation line under the playground and replacement of the concrete sidewalk section outside the kitchen.
- Replacement of the electrical panel was completed in May
- Patched the exposed sewer line between LMS bathrooms
- Replaced irrigation pump and replumbed well pit
- Fixed leaking shutoff valve in Pastors office and burst pipe in the hallway
- Replaced Circuit board in stove
- Snow removal by contract is ongoing. Lawn mowing is a big volunteer effort in the summer.
- Fall and spring cleanup days are critical in keeping the church presentable. A huge effort by church members prepared the church and sanctuary for a couple funerals.

As a result of some unexpected expenses and critical needs being addressed the upgrade of a lawn mower has been placed on hold.

Present needs include replacing the ceiling tiles and lighting in the sanctuary and narthex. The curbing and sidewalks along South Cale have deteriorated to the point that they are a safety issue as is the sidewalk from the south Earling to the back entrance of the church. The council is currently exploring funding alternatives to implement part of Phase 2 of the front entrance remodel to address these issues. A setback for angle parking is also being explored along South Cale as part of the curb and sidewalk replacement.

The Building and Property committee has developed an Annual Work Plan and a task punch list (available in the office) if you want to help out. If you see a need or want to help please let someone from council or the building committee know.

## NALC Affiliation

We come together around God's Word and Christ's presence, then go into the world to make disciples, love our neighbors, and live out the gospel. We do this through renewing congregations in disciple-making, equipping disciples for disciple-making, and transforming communities through disciple-making.

NALC congregations are Christ centered, mission driven, traditionally grounded and congregationally focused. Over 500 congregations are divided into "Mission Districts". We are part of the district including western North and South Dakota and Wyoming, directed by Mission District Dean Pastor David Baer of Whitewood, South Dakota. The only other NALC congregation in Montana is New Hope Lutheran in Circle, which Pastor Blayne Watts serves.

## Worship Committee

Malloreay Kassner continued as cantor and as the dedicated operator of our sound system, ensuring proper transmission of our Sunday worship service to KATL Radio.

Let Me Shine Preschool began classes on September 2 with two classes for 3- and 4-year-olds and one class for 4-and 5-year-olds. We kicked off the year with an Ice Cream Social and a chance to meet the teachers on August 27. It was well attended by the excited preschoolers and their families.

Heather Notsch was hired as Director with curriculum and administrative responsibilities . We offered the following classes:

- Lisa Kuntz returned as a teacher and is teaching two 3- and 4-year-old classes (22 students total). Her aide is Sierra Stevenson. Those classes are Mon-Wed AM and Tue-Thurs AM
- Heather Notsch, hired this year, teaches the 4- and 5-year-old class (13 students) on Monday/Tuesday/Wednesday and Thursday Mornings. Alexis Chapmon is the aide in this class.

Automatic payments are being offered to parents again this year, both to cut down on the need for contact, and to provide families with an efficient way to make their tuition payments in a timely manner. A majority of our families are utilizing this service. We have continued to take steps to establish and implement a payment policy making our payment expectations transparent for everyone.

Our Butterbraid fundraiser was very successful for our program once again, selling over 600 items and the top seller selling 46 pastries. The top seller from each class received a Dairy Queen gift card to thank them for their efforts. We had a three-way tie for top sellers in the 4-5 class, and a single top seller for each 3-4 class. The funds from the fundraiser were put on hold at this time until our board can determine the cost for a change in the playground surface. We are looking into changing out all surfaces for one continuous rubber surface. This would improve play and decrease the continued maintenance and clean up needed to maintain our playground. Both age groups prepared and performed Christmas programs for their families during the last week of school before Christmas break. They all worked very hard and had a lot to be proud of. Each child went home with a gift from the Preschool and one from First Lutheran Church.

We will open enrollment for the 2026-2027 school year in February and are excited to welcome another group of eager learners. We appreciate the continued prayers and support of the congregation as we continue this mission of the church.
