

Contestant Participation Agreement

CONTESTANT PARTICIPATION AGREEMENT

This Agreement is entered into between Top Floor Baddies Productions ("Producer") and _____ ("Contestant").

1. VOLUNTARY PARTICIPATION

Contestant voluntarily agrees to participate in Top Floor Baddies and understands the program may include competitions, physical activities, interviews, eliminations, and group living arrangements.

2. FILMING CONSENT

Contestant grants Producer the unrestricted right to photograph, record, film, livestream, edit, distribute, and otherwise use Contestant's name, image, voice, likeness, social media handles, and biographical information in connection with the program.

3. OWNERSHIP

All footage, photographs, recordings, interviews, and related materials shall remain the sole property of Producer.

4. COMPENSATION

Contestant understands participation does not guarantee compensation, prizes, sponsorships, future opportunities, or television placement unless specifically stated in writing.

5. ELIMINATION

Contestant acknowledges that eliminations are part of the competition and agrees to abide by all decisions made by Producer.

6. CONDUCT

Contestant agrees to follow all house rules, refrain from damaging property, avoid illegal drug use, and respect production staff. Producer reserves the right to remove Contestants for violations.

7. CONFIDENTIALITY

Contestant agrees not to disclose production information, results, eliminations, filming details, or unreleased footage without written permission.

8. RELEASE OF LIABILITY

Contestant releases Producer, staff, sponsors, venue owners, and affiliates from claims arising from participation except in cases of gross negligence or intentional misconduct.

9. MEDICAL EMERGENCIES

Contestant authorizes Producer to obtain emergency medical treatment if necessary.

10. GOVERNING LAW

This Agreement shall be governed by the laws of the State of Georgia.

8. Contestants may not post spoilers, elimination results, behind-the-scenes footage, production details, or confidential information until authorized by production.
9. Contestants agree that all recordings made during production belong exclusively to Top Floor Baddies Productions.
10. Contestants may be removed immediately for violations of these rules.
11. Contestants understand that removal from the show may result in forfeiture of eligibility for prizes.
