
The Tutoring School First Aid Policy



The Tutoring School LTD provides both online and in-person private tuition across primary, secondary and GCSE and A- Level subjects. All sessions are delivered by fully qualified, DBS-checked tutors with extensive experience. This policy is only applicable to in-person lessons.

1. Introduction

The safety, health, and wellbeing of all students attending lessons at 14 Levett Road, Polegate, BN26 6NE are of the highest importance. This policy outlines the first aid arrangements, emergency procedures, and safety expectations during tutoring sessions delivered in the home/office.

2. First Aid Provision

- A fully stocked and regularly checked First Aid Kit is stored in the office drawer.
- A qualified First Aider (Amy Sams) will administer immediate first aid when required.
- For any incident that is beyond basic first aid or appears serious, emergency services will be contacted immediately (999).

3. Emergency Procedures

If a student feels unwell, has an accident, or notices a hazard, they must inform the tutor immediately.

Minor Injuries

- Small cuts, grazes, or minor bumps will be treated using appropriate first aid supplies.
- The incident will be recorded in the First Aid Record Book.

Serious Injuries or Illness

 Examples include severe bleeding, suspected fractures, head injuries, seizures, or an allergic reaction.

In these cases, the tutor will: o Call 999 if required. o Contact the student's parent/guardian immediately. Follow advice from emergency services. 4. 5. Safety Expectations in the Home/Office

To maintain a safe learning environment, students are asked to:

- Follow all instructions designed to keep them safe.
- Walk, not run, inside the property.
- Store coats, school bags, and personal items in the designated area to avoid tripping hazards.
- Keep drinks and food away from electrical equipment (laptops, chargers, plugs).

• Use equipment appropriately and report any issues.

6. Fire Safety

- The property is equipped with working fire alarms, including in the tutoring room.
- In the event of a fire:
 - o Leave belongings behind.
 - o Exit calmly and immediately using the nearest safe exit.
 - Proceed to the meeting point: the front of the property (14 Levett Road, Polegate, BN26 6NE).
- Fire exits and procedures will be explained at the student's first lesson.

7. Recording & Reporting Incidents

- All accidents, injuries, or significant health-related incidents will be recorded in the First Aid Record Book.
- Parents/guardians will be informed of:
 - Any injury that occurs
 - Any first aid administered
 - Any incident requiring monitoring or follow-up
