

**Fat Tomato Inc. Event Bookings  
Terms & Conditions**



**Public Truck Events -**

All public truck events will be held to a \$1,000.00 minimum sales requirement. In the event that the public event does not reach the \$1,000.00 minimum sales requirement, the remainder of the sales requirement will be owed to Fat Tomato Inc. by the public event requestor at the conclusion of the event. If you are a non-profit organization or are looking to raise money for a cause, please reach out to Fat Tomato Inc. privately so we can consider contributing a portion of our sales to your cause. If you are a brewery looking to have our truck serve at your location, we require a \$1,000.00 sales minimum for locations that are more than 50 miles roundtrip traveling distance. We are rain or shine; however in the event that severe weather (lightning, hail, high winds, tornados, etc.) is active in the area, we will reschedule for a future available date of your choosing. We always strive to maintain a set schedule, but in the event a mechanical issue presents itself within 48 hours of a scheduled public event and a repair is not complete in time, we will do our best to accommodate a future available date of your choosing.

**Private Truck Events-**

All private event bookings are reserved on a first come, first serve basis and are held to a \$1,000.00 minimum sales requirement for 2 hours of service. Each additional hour will be held to a \$500.00 sales minimum sales requirement. A 25% non-refundable deposit is required at the time of booking and secures the date of your event. The final guest count and remaining balance is due no later than 7 days prior to the event date. Cancellations will be accepted penalty-free up to 15 days prior to the event date. In the event that the cancellation falls within the 15 day window, you may be subjected to a cancellation fee of up to 15% of the remaining balance owed. In any scenario that involves a cancellation, please reach out to us directly, as we are always willing to work on rescheduling and using your non-refundable deposit toward a new date. If your cancellation is due to a government mandated closure, we will be happy to apply your non-refundable deposit to a future available date of your choosing.

**Neighborhood Truck Events-**

All neighborhood event bookings are reserved on a first come, first serve basis. As courtesy to the hosting neighborhood booking the event, we have waived our minimum sales requirement and deposit

but ask that the host of the event heavily promotes the event on social media and throughout the neighborhood. We encourage a minimum of fifty families to participate. All marketing materials and menus will be provided by Fat Tomato Inc. on the day of booking your neighborhood event. We are rain or shine; however in the event that severe weather (lightning, hail, high winds, tornado, etc.) is active in the area, we will reschedule for a future available date of your choosing.

### **Wedding Trucks Events-**

All wedding bookings are reserved on a first come, first serve basis and are held to a \$1,500.00 minimum food sales requirement. A 25% non-refundable deposit is required at the time of booking and secures the date of your event. The final guest count and remaining balance is due no later than 14 days prior to the event date. Cancellations will be accepted penalty-free up to 30 days prior to the event date. In the event that the cancellation falls within the 30 day window, you may be subjected to a cancellation fee of up to 15% of the remaining balance owed. In any scenario that involves a cancellation, please reach out to us directly, as we are always willing to work on rescheduling and using your non-refundable deposit toward a new date. If your cancellation is due to a government mandated closure, we will be happy to apply your non-refundable deposit to a future available date of your choosing.
