

Do Not Move Or Damaged Dumpster

Placement: A1A Dumpster Rental will place the dumpster in a location desired by the customer, if possible, as long as it's deemed safe by a A1A Dumpster Rental representative. The dumpster must not be moved from where it was placed for any reason by anyone other than A1A Dumpster Rental. If dumpster is moved, the customer or contractor will be held responsible for all damage to our property and any costs incurred.

It is also agreed and understood that if payment is not made, A1A Dumpster Rental, files notice to owner (NTO) a charge of one hundred dollars (\$100.00) will accrue. If a claim needs to be filed in court or on a bond, another two hundred-fifty dollars (\$250.00) will accrue. A1A Dumpster Rental is not responsible for fluids dripping out of containers and "customer" will insure any charges or fines related to fluids dripping from the container provided by A1A Dumpster Rental

DUMPSTER RENTAL SERVICE AGREEMENT

1. Agreement: This agreement legally binds ("Customer") and A1A Dumpster Rental to the terms and conditions listed below and in accordance with the laws of the State of Florida in effect at the time of ordering a dumpster. A1A Dumpster Rental agrees to provide the "Customer" with non-hazardous waste collection, transportation, disposal and recycling services.
2. Service: "Customer" agrees to give A1A Dumpster Rental at least one to two (1) business days notice for service of dumpster delivery, exchange, termination or relocation). If a call for service is received after 12p.m. (noon), A1A Dumpster Rental cannot guarantee service for the next business day. There may be times when a delay could be incurred in servicing your needs due to inclement weather, traffic conditions, equipment failure etc.
3. Inability to Deliver or Pick Up: If A1A Dumpster Rental attempts to deliver or pick up material or a dumpster and either is blocked or prevented in any way from being delivered or picked up, including being declined and turned away, the customer will be subject to a fee \$150.00 up to \$300.00.
4. Prohibited Waste: "Customer" agrees not to place any hazardous or toxic waste in the dumpster as it is against the law. All hazardous or toxic waste found in the dumpster will become the responsibility of the "Customer". At A1A Dumpster Rental discretion may return the hazardous or toxic waste found in the dumpster and charge the "Customer" a \$150 to \$175 Return Charge. At A1A Dumpster Rental discretion may charge the "Customer" a disposal fee for the hazardous or toxic waste found in the dumpster as detailed below in the section called Disposal Fees. Hazardous or toxic waste includes industrial waste, waste containing asbestos, septic tanks and waste, paint, cleaning solutions, biomedical waste, pesticides, solvents, tires, oil, oil filters, oil containers, gas cans, propane tanks, batteries of any kind, appliances with Freon (air conditioners, refrigerators, etc.), Freon aerosol cans, hazardous waste, etc.
5. Equipment: All equipment furnished by A1A Dumpster Rental shall remain property of the Company, however, "Customer" shall have care, custody and control of the equipment and shall bear responsibility and liability for all loss and damage to the equipment and for its contents while at the "Customer's" location. "Customer" shall not move or alter the equipment and shall use the equipment only for its intended purpose. "Customer" shall provide unobstructed access to the equipment on scheduled pick-up day or be subject to a dry run fee of \$150-\$300.00. A1A Junk Removal is NOT responsible for any damage to "Customer's" property including walkways, curbing, pavement, driveways, pavers, irrigation, wells, septic or underground utilities resulting from the company's provision of services. "Customer" warrants that the right of way is sufficient to bear the weight and physical dimensions of the Central Florida Dumpsters equipment and vehicles.
6. Overfilled Dumpsters: "Customer" agrees not to overfill the dumpster above the top rail of the dumpster. An over-filled dumpster may allow debris to fall out and damage other cars and trucks and it is against the law to transport an over-filled dumpster. A1A Junk Removal reserves the right to refuse to pick up an over-filled dumpster. If over-filled, the "Customer" will be responsible for over-filled debris down to the top rail of the dumpster AND CHARGED AN ADDITIONAL FEE.
7. Overweight Debris Dumpsters: A1A Dumpsters includes a certain amount of dump fee's with each construction debris dumpster depending on the size, which is listed on our web-site www.a1ajunkremoval.com. If tonnage exceeds allowed weight limit there will be an additional charge of \$125.00 each ton over with a minimum of a 1 ton charge.
8. Daily Rental: Each dumpster includes a number of days in the rental, which is 4 days unless other arrangements are made. A daily rental fee of \$125.00 per day will apply after the included number of days if the dumpster is not emptied and returned or removed at the "Customer's" request. If the dumpster is emptied and returned, the next dumpster is considered a new rental and includes the same number of days as the first dumpster starting the day of the swap or new empty container is delivered.
9. Indemnity: The "Customer" agrees to indemnify, defend, and save A1A Dumpster Rental harmless from and against any and all liability which A1A Dumpster Rental may be responsible for or pay out as a result of bodily injury (including death), property damage or any violation or alleged violation of the law to the extent caused by "Customer's" breach of this Agreement or by any negligent omission or willful misconduct of the "Customer" or its agents, employees, contractors in the performance of this agreement. Neither party shall be liable to the other for incidental, consequential, or punitive damages arising out of or in connection with the performance or non-performance of this agreement.
10. Stand by time: A maximum 15 minutes per load is allowed for delivery of each dumpster and/or load of material. If trucks are held beyond this period, the excess will be charged to the customer at the seller's current rate; \$3.50 per minute.
11. Method of Payment: "Customer" agrees to provide a credit card on file and pay for services they have ordered. If Credit Card is declined, "Customer" is subject to a finance charge of 1.5% per month (18% per annum). Should the servicing of any Agency or Attorney become necessary to collect any amount outstanding, I/we agree to pay of such collection including a reasonable attorneys fee. I/we further agree that any lawsuit against A1A Dumpster Rental to collect such obligations shall be filed in court having proper jurisdiction of such claims in Flagler County, Florida. Whereas, it is hereby stipulated that proper venue shall be any such lawsuit.

By signing these Standard Terms and Conditions ("Standard Terms"), together with the applicable Work Order, constitute the SERVICE AGREEMENT ("Agreement") by A1A Dumpster Rental, Florida Locally owned company and "Customer", whose name, and address(es) are set forth in the signed Work Order for DUMPSTER RENTAL SERVICES I understand that payment is due upon rendered services and have agreed to the above conditions. By signing this agreement you agree that all items are now property of A1A Dumpster Rental.
