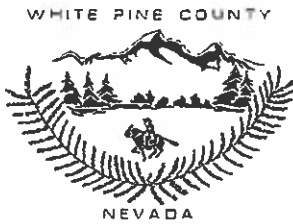

NOTICE: Soas to honor the privacy of the applicants, we made sure to conceal certain pieces of data.

There were TWO applicants to fill the vacant RPC seat. Clearly the notice pursuant to NRS 241.031 and 241.033 was completely neglected in Wheable and Beecher's collaborated improper appointment of Mr. George Chachas upon which his selection was done behind closed doors and with a complete disregard of the proper appointment due process (by not involving members of the County Commission in the selection process the proper way). Mr. Chachas has known ethical breeches in the offices he's held in the past (see public item EXHIBIT 1.R, The Nevada State Commission on Ethics regarding Mr. George Chachas), whom is such a known disturbance in these public meetings that he's even had to be removed from their very own meetings by the County Sheriff himself.

Mr. Edwin Szewczyk would have made a most excellent choice. However both Wheable and Beecher denied him of that opportunity to play politics instead. This ill-willed decision by both public official attorneys has had a devastating impact on the RPC board and the members of the public to whom they serve, ever since.

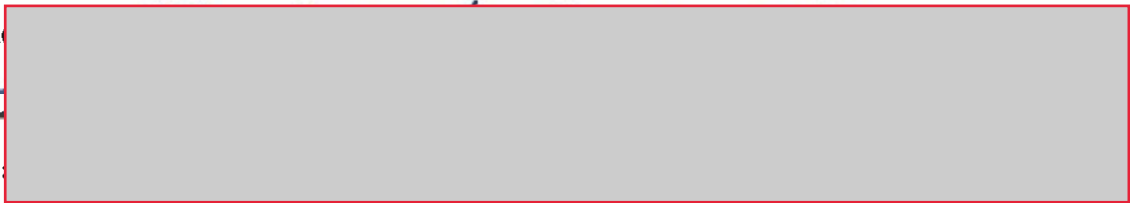
