Mr. Michael A. Wheable, District Attorney re-branded as County Manager in February of 2022

This is just a 1-year comparison among several different sources, just to illustrate the massive discrepancies in job title reporting and the problems in our accounting systems, with respect to Wheable's actual salary & benefits earnings. We show discrepancies over the last 5 years total for Mr. Wheable alone, which will require a full investigation. Mind you, this is also the same man that has served on the County Audit Committee all of these years.

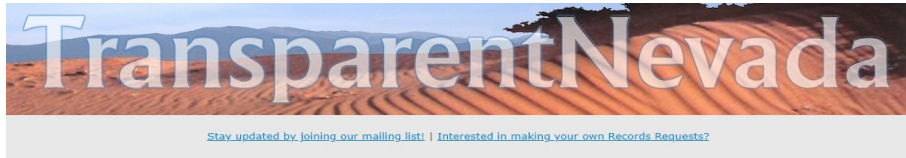

Why does our internal system for year 2019 show that Mr. Michael A. Wheable's received only a base salary of \$56,054.35 with no "Benefit Pay" and no "Other Pay",

while Both OpenPayrolls.com and TransparentNevada.com show the following: "Base Pay" of \$122,677.88 / "Other Pay" of \$4,718.38 / "Benefit Pay" of \$45,458.60, for a "Total Pay" of \$172,854.86? This is a MASSIVE discrepancy.

In addition, WHY is Wheable listed as County Manager in our internal record keeping system for 2019 when he wasn't re-branded as such until February of 2022?
