Feb 17 2021 Regional Planning Commission Meeting

This video recording is regarding the deliberate attempt to eliminate the Regional Planning Commission ("RPC") from the decision-making process regarding a pending business bargaining agreement with a company outside of Utah, regarding a hydro-pump storage project in White Pine County. This particular discussion was had between the following time into this video: from 27:25 minutes into video (5:56pm) – 35:00 minutes into video (6:05pm).

Mrs. Mckinzie Hilton (NV State Bar # 14447) was sent by DA Wheable (NV Sate Bar # 12518) to attend this particular February 17, 2021 RPC meeting as a means to completely exclude the RPC from their input into this large scale planning project. She recommended that the discussion item be tabled to a later date and offered up a highly suspicious and vague explanation as to the reasoning to halt the discussion item: because the county is lacking a "BLM signature". The RPC was shunned out of the process entirely, even with all the questions and concerns that were raised. This discussion item was never brought forth again for discussion as it most certainly should have been. Mrs. Mckinzie Hilton incorrectly stated that this board is nothing more than an "advisory board" (to justify such abhorrent action to exclude all criticism of the project). This county has since lost some of our finest members from the RPC and this happens to be the very same commission that both Wheable and Beecher (NV State Bar # 12555) later improperly appoints, out of proper procedure and against Open Meeting Law [NRS 241], a known highly disturbed individual to a vacant seat of that RPC, as a stepping stone tactic to ridding the commission that'd hold them accountable.
