Narrative:

On October 23, 2022, I got dispatched to Mona Pole canyon for reports of four stranded individuals in a cabin. After contacting the property owner, David Levitt, it was discovered that he had taken in a family from Venezuela and taken them there to stay for a few days.

Due to the initial report of them walking in the snow and stranded with no warm clothing, I had Search and Rescue respond to the scene. After being there for a while, it was discovered that the initial report of them walking in the snow with very little clothing was incorrect due to a language barrier. All stranded parties were in good health and had food, heat, and shelter but; very scared because this was the first time they had ever witnessed snow, causing them to panic and call 911.

Search and Rescue made it to the cabin, located all parties, and escorted them off the mountain without incident. After that, David Levitt arrived and took custody of all parties.
