Report Narrative

SUMMARY

I responded on the complaint of an aggravated assault where a Redacted-year-old female was attempting to run her mother over with the car. I arrived and found these people in the home, separated, and found no physical injury. Details are as follows.

I was dispatched to 3820 Little Rock Ln at 1539 hrs. I was advised that Redacted was attempting to take the car and run her mother over. Being familiar with this family and Redacted, I hurried to the area. When I arrived I found Redacted in the living room and her mother on the front porch. I noticed a red BMW with Utah license plate 194WLS in the driveway and a maroon Ford Taurus blocking it in, front bumper to rear bumper.

### M1/ROSELLE HAMBLIN CONTACT

I made contact with M1/Roselle and she advised me that her daughter, Redacted, had attempted to run her over with the car. I further interviewed her and found that M1/Roselle had attempted to discuss the use of the car with Redacted and did not give her permission to take the car tonight. Redacted, feeling that she had to use the car, attempted to take the car with out her mother's permission. It should be known that I also was looking for Redacted and this car on yesterday's date. It appears that Redacted has done this several times. While Redacted was attempting to leave the house, M1/Roselle followed her and stood behind the car so she could not leave the driveway. Redacted started the car, put it into reverse and slowly backed into M1/Roselle who would not move. Redacted continued to back out. At this time, the grandfather of Redacted, W1/Richard Anderson, the father of M1/Roselle, drove by, saw what was going on, and drove his car, a Ford Taurus, maroon in color, into the driveway, blocking the BMW in.

At this time, M1/Roselle dialed 9-1-1 and gave Dispatch the information. While she was on the line with Dispatch she attempted to get the keys by asking Redacted to hand them through the window, but Redacted refused. Redacted began to get out of the car. M1/Roselle felt like she was going to run away from the area, which is also another frequent incident with this young lady, and as a result, M1/Roselle kept this door closed with her body, attempting to detain Redacted until officers arrived. As a result of this, the door was opened slightly a few times and at one time Redacted's fingers got shut in the door. Redacted was able to escape the car in spite of the efforts of M1/Roselle. As she passed M1/Roselle, M1/Roselle grabbed hold of Redacted's belt to try to restrain her until she gave M1/Roselle the keys to the vehicle that she did not have permission to use. A grappling match ensued. Hair was pulled, all in an attempt to restrain Redacted who was definitely ungovernable. M1/Roselle was in fear that she would run away again.

### CONVERSATION

I had a conversation with M1/Roselle regarding the possible charges. It appeared to me that Redacted was attempting to take the car unlawfully without her mother's permission. This would be Joyriding. This attempt was foiled only by M1/Roselle standing behind the vehicle and then W1/Anderson blocking the vehicle in with his vehicle. I did not feel that the act of assault had occurred by backing the vehicle into M1/Roselle because there were no injuries.
