I, Sgt. Dove, with the Provo Police Special Victim's Unit received a request from the Utah County Attorney's office regarding a referral that had come to their office. The request was that I contact V1/ [REDACTED] and conduct and interview regarding reported sexual abuse from [REDACTED] S1/David Hamblin. I initiated an investigation and I filed this police report accordingly.

INITIAL REFERRAL

I was forwarded an email through Dave Sturgill's office at the Utah County Attorney's; in that email was included a forwarded initial report from Anthony Howell. The report was from [REDACTED], wherein she had recorded numerous accounts of sexual assault and rape from the time she could remember as a small infant until the time that she was approximately 13 or 14 years old. The suspect of these numerous assaults was [REDACTED] S1/David Hamblin. Contact information for V1/[REDACTED] was included in the report. I made contact with V1/[REDACTED] and scheduled an appointment for her to come in for an interview.

VICTIM INTERVIEW

I met with V1/[REDACTED] and her husband O1/[REDACTED] on January 20, 2012. Our interview was conducted in the soft interview room at the Provo Police Department. That interview was both audio and video record and is attached to this report in its entirety on a recorded DVD. I am going to summarize some of the events that were reported to me in this initial police report. I will be attaching more specific information as I receive it and as supplemental reports are warranted.

V1/[REDACTED] explained to me that she was one of four female [REDACTED] David and [REDACTED]. She stated that she was born in [REDACTED] and within the first year of her life she has begun to recall and have flashbacks of very severe sexual assault and rapes at the hand of [REDACTED] up to and including her 13th year when she was attending [REDACTED] Middle School in Provo. She stated that David Hamblin has joined a Native American religious church or sect wherein it is an accepted practice to utilize peyote. She indicated that David Hamblin is a physiologist and therapist by trade and by education and that from a very early age he has used that psychological influence on her and all of [REDACTED] and they have all be victims of severe sexual abuse and rape from the time she can remember. She has provided a pretty specific timeline that corresponds with the memories and experiences that she can recall. She cited hundreds and hundreds of times that she has been the victim of sexual abuse at the hands of David Hamblin over the 13 years prior to [REDACTED] 1999. During that year also David was arrested for poaching, reported by [REDACTED] as having killed animals to use in his ritualistic ceremonies. [REDACTED] stated that from 1999 until the present day she has managed to make it through high school. She attended [REDACTED] High School her freshman, sophomore, junior and senior year. She graduated from [REDACTED] High School and she accepted a job in [REDACTED] and in [REDACTED] working for [REDACTED]. In [REDACTED] she fulfilled and LDS mission to [REDACTED] and returned from that mission in [REDACTED]. She began classes at BYU in [REDACTED] and is currently attending BYU in an undergraduate program. In [REDACTED] [REDACTED] and the couple has been together ever since. [REDACTED] indicates that she obvious issues with intimacy with her husband and she understands that these issues are stemming back from years and years of severe violent sexual

abuse from David Hamblin.

EXAMPLES OF SEXUAL ABUSE CITED

I have met with [REDACTED] a total of about 3 times now since our initial meeting on January 20, 2012. My objective was to allow her time to collect and organize her experiences and put them on paper with coordinating dates, times and locations as best she could remember, as there has been some pass since the incidences took place. My objective today is to give a brief summary of the abuse that she has cited, that took place during those 13 years and that she has produced in a written format. I will continue to add more specific details as we build this case and as more evidence continues to be produced.

[REDACTED] cites vividly remembering her first experience within the first year of her life, when she lived in New York City between [REDACTED]. She stated that this experience was on his bed. Understanding that this incident took place out of the state of Utah she felt that it was important to help develop history and consistency in his character. [REDACTED] said, regarding experience 1 that she can recall of the attached writings, "I remember looking out of my crib and seeing David's body standing in front of it. He wasn't wearing any pants, just the top of his LDS garment. David lowered the side of my crib and took me on his bed. It was daytime because the room was filled with natural light. The next thing David did was put his penis in my mouth. It was a horrible taste and he kept putting it in my mouth and made me choke and cough. Later I learned the horrible smell and taste was semen because as David continued to abuse me he would often verbalize what he was doing and would often tell me to suck out the semen or lick up the semen." She then lists experience 2 in her kindergarten years between [REDACTED] and [REDACTED]. The location for this incident is the Provo house located at 280 E 2200 N. She refers to the Provo house also as the Centennial house as it was very close to Centennial Middle School.

In experience 2 [REDACTED] records the following, "I was often scared to go to the bathroom in the night. I knew if David heard me get up he would come hurt me. I usually tried to hold it until the morning if I could and if I couldn't I would be sure to not even flush or turn on the sink to wash my hands, just to be safe. This was hard for me because I have always like being clean and I've been somewhat germaphobic, but obviously the alternative was much worse so I did it anyway. During a school night while I was in Kindergarten I woke up needing to go to the bathroom really badly and after holding it for about a half an hour I finally got up and tip toed to the bathroom. The basement was very cold because it was winter outside and so it made me shiver. After I wiped I realized that I got some pee on my hand and I wanted to wash my hand really badly. I went to the sink and kept looking behind me. I turned the knob for cold water, just a tiny bit, to get some water dripping out. I commenced washing my hands when I heard someone walking up behind me. David grabbed me and I shook I was so scared and cold and he grabbed my wet hands with one of his and pulled down his bottom garments revealing himself. He forced my hands on top of his penis and violently rubbed back and forth in my hands with his hands clenching the outside of mine. I was quietly crying and tense all over as he shook me back and forth because he was making me rub him so fast and hard. He hurt my hands and he continued to squeeze them tighter and tighter. I was so grossed out I wanted to throw up. He continued until he started breathing more and more heavily and then he ejaculated in my face and tried to force open my mouth with his hand. I kept clenching my lips and turning my head away and it got on the floor. He kept saying open your mouth [REDACTED], I wouldn't. He had finished ejaculating and it had gotten all over my Care Bear nightgown and my face as well as the ground. He commanded me to lick his semen off the floor. I shook my head, too afraid to look at him. He said it one more time. I responded in the same way, I was angry. He clenched my arms and made fists, hurting me and said if you don't do it I will go beat up [REDACTED] right now. He started walking to [REDACTED] room, the west bedroom in the basement and I said okay. I got on the floor and started licking up the semen. I was crying very hard and started to dry heave. He watched as I did it and when I finished he picked me up off the floor and put me on my feet. He pulled my nightgown over my head and wiped off my face and the floor with the night gown. Then he put the night gown in the sink, flushed the toilet and turned on the hot water. He told me to go to bed. I ran away into the bedroom and cried for what it seemed to be a long time. I was disgusted with the taste in my mouth. I kept spitting into a tissue I had gotten from the side of my bed. The taste of semen and smell of semen was so thick I couldn't sleep. As soon as it got light outside, about three hours later, I ran to the shower and showered off."

Experience 3: During the school year at the Provo house, "wherever we lived [REDACTED] and I would try to find hiding places and safe places to escape David at night or when [REDACTED] was away. When we moved to Provo we would often hide in the northeast corner of the basement, the storage room which was a scary place because of spiders, boxes and a single light which hung from an electrical cord. David would hate it when we would hide and in some of our hiding places he would find us. When he did he would usually take us to the back hallway where the bedroom on the southeastern corner; the one with the maroon carpet. He would throw one of us against the wall or onto the floor and would abuse one of us while the other two were forced to watch. David would abuse whoever was home and his mood would control his level of violence in the abuse. When my [REDACTED] would come home he would often tell her that we had been fighting with each other and that he had to stop us from hitting each other. The next day we would have big bruises, but they were from him. During my kindergarten year when I was 5 years old [REDACTED] and I were home from school and [REDACTED] was gone. David stayed at home with us. He was supposed to be doing work in his office. I remember because he was wearing his work clothes; his khaki pant and brown belt and shoes with the tassels on them and a collared shirt. About a half hour after [REDACTED] left home David came downstairs where we were playing in the main basement area where most of our toys were. He violently grabbed [REDACTED] by the arm and yelled at [REDACTED] and I to follow him. [REDACTED] started crying and we quickly started following. He shook her and told her to be silent and told [REDACTED] and I that we should be silent as well. [REDACTED] was crying so hard and started

hyperventilating so David threw her aside, hitting her against the wall. After he threw her against the wall David said that if we didn't remain quiet he would cut up and kill [REDACTED] and our orange Tabby cat named Angus. [REDACTED] kept crying quietly but it wasn't quiet enough because he threatened to hit [REDACTED] again. I moved toward him which was not uncommon of [REDACTED] to take turns being abused. I did it because I didn't want him to keep hurting [REDACTED]. [REDACTED] had both done the same thing for me before. David got a really crazy look on his face and violently took off my pants and yelled at me to kneel on the floor. I did and then he put his penis into my anus and picked up my back legs as he kept pushing me forward and backward. I started to scream because it hurt so badly and he covered my face over my mouth, but covered my nose too so I had a hard time breathing. Then he started breathing really heavily, he dropped my legs and was shaking as he started ejaculating. We all started crying hard. He pulled his penis out and the rest of the semen got on my naked bottom and my shirt, as well as the maroon carpet. He got angry and grabbed my underwear. He used my underwear to wipe up the spot of semen and then he got up and yelled 'Put your shirt in the sink [REDACTED] and then get dressed.' As he passed the bathroom I heard him turn on the sink and then he turned it off again and left. When he was gone we cried together. He had put my panties in the bathroom sink to soak. David's abuse was so painful that I couldn't even sit down for a little while because it hurt so badly. It was the most difficult when I was supposed to be at school again. I told [REDACTED] that I had a hard time sitting and [REDACTED] asked me if I was thoroughly wiping my bottom after I went to the bathroom. I was so scared to tell her anything because of David's threats so I told her that I was not wiping as well as I should. [REDACTED] put me in warm bath with Epsom salt when this happened."

[REDACTED] goes on to relate experiences four through fourteen of very similar, violent rapes and sexual abuse endured by all of [REDACTED] at the hands of David Hamblin. I will include written statements and timelines submitted by [REDACTED] as well as other information that may come from her siblings. So far I have only spoken with [REDACTED] who goes by the name of [REDACTED]. She came to the police department with her mother [REDACTED] whose nickname is [REDACTED]. She is [REDACTED]. [REDACTED] has remarried and during my conversation with [REDACTED] she did not have any independent recollection of sexual abuse at the hands of David Hamblin. [REDACTED] did however receive a hand written letter from David Hamblin recently at school where she attends at [REDACTED] High School. It was delivered to her at the hands of teenage boy whose mother is either connected through her ward or some other means to David Hamblin for current or past counseling. David Hamblin maintains a website called "the red path." He describes having therapeutic sessions and promotes the use of peyote and other methods of therapy. Regarding [REDACTED] and [REDACTED] I will be submitting a separate report with the information that [REDACTED] gave me and why she is so frightened to have any correspondence with David Hamblin.

DISPOSITION

As for this case regarding [REDACTED] and her accounts of sexual abuse, I will continue to add information and build this case as evidence is presented. It appears that there has been some history with the family and previous investigations regarding [REDACTED] referred to and a previous declination from the Utah County Attorney's office to file charges on investigations from approximately 10 to 12 years ago. I will continue to research those report and include them with this initial report as I develop this investigation.

I conclude this report disposition 4 pending future investigation. Dispo 4/kc

The basement was very cold because it was winter outside and so it made me shiver. After I wiped I realized that I got some pee on my hand and I wanted to wash my hand really badly. I went to the sink and kept looking behind me. I turned the knob for cold water, just a tiny bit, to get some water dripping out. I commenced washing my hands when I heard someone walking up behind me. David grabbed me and I shook I was so scared and cold and he grabbed my wet hands with one of his and pulled down his bottom garments revealing himself. He forced my hands on top of his penis and violently rubbed back and forth in my hands with his hands clenching the outside of mine. I was quietly crying and tense all over as he shook me back and forth because he was making me rub him so fast and hard. He hurt my hands and he continued to squeeze them tighter and tighter. I was so grossed out I wanted to throw up. He continued until he started breathing more and more heavily and then he ejaculated in my face and tried to force open my mouth with his hand. I kept clenching my lips and turning my head away and it got on the floor. He kept saying open your mouth [REDACTED] I wouldn't. He had finished ejaculating and it had gotten all over my Care Bear nightgown and my face as well as the ground. He commanded me to lick his semen off the floor. I shook my head, too afraid to look at him. He said it one more time. I responded in the same way, I was angry. He clenched my arms and made fists, hurting me and said if you don't do it I will go beat up [REDACTED] right now. He started walking to [REDACTED]'s room, the west bedroom in the basement and I said okay. I got on the floor and started licking up the semen. I was crying very hard and started to dry heave. He watched as I did it and when I finished he picked me up off the floor and put me on my feet. He pulled my nightgown over my head and wiped off my face and the floor with the night gown. Then he put the night gown in the sink, flushed the toilet and turned on the hot water. He told me to go to bed. I ran away into the bedroom and cried for what it seemed to be a long time. I was disgusted with the taste in my mouth. I kept spitting into a tissue I had gotten from the side of my bed. The taste of semen and smell of semen was so thick I couldn't sleep. As soon as it got light outside, about three hours later, I ran to the shower and showered off."

Experience 3: During the school year at the Provo house;

"...wherever we lived [REDACTED] and I would try to find hiding places and safe places to escape David at night or when [REDACTED] was away. When we moved to Provo we would often hide in the northeast corner of the basement, the storage room which was a scary place because of spiders, boxes and a single light which hung from an electrical cord. David would hate it when we would hide and in some of our hiding places he would find us. When he did he would usually take us to the back hallway where the bedroom on the southeastern corner, the one with the maroon carpet. He would throw one of us against the wall

or onto the floor and would abuse one of us while the other two were forced to watch. David would abuse whoever was home and his mood would control his level of violence in the abuse. When [REDACTED] would come home he would often tell her that we had been fighting with each other and that he had to stop us from hitting each other. The next day we would have big bruises, but they were from him.

During my kindergarten year when I was 5 years old [REDACTED] and I were home from school and [REDACTED] was gone. David stayed at home with us. He was supposed to be doing work in his office. I remember because he was wearing his work clothes; his khaki pant and brown belt and shoes with the tassels on them and a collared shirt. About a half hour after Mom left home David came downstairs where we were playing in the main basement area where most of our toys were. He violently grabbed [REDACTED] by the arm and yelled at [REDACTED] and I to follow him. [REDACTED] started crying and we quickly started following. He shook her and told her to be silent and told Rachel and I that we should be silent as well. [REDACTED] was crying so hard and started hyperventilating so David threw her aside, hitting her against the wall. After he threw her against the wall David said that if we didn't remain quiet he would cut up and kill [REDACTED] and [REDACTED] orange Tabby cat named Angus. [REDACTED] kept crying quietly but it wasn't quiet enough because he threatened to hit [REDACTED] again. I moved toward him which was not uncommon of [REDACTED] to take turns being abused. I did it because I didn't want him to keep hurting [REDACTED]. [REDACTED] had both done the same thing for me before.

David got a really crazy look on his face and violently took off my pants and yelled at me to kneel on the floor. I did and then he put his penis into my anus and picked up my back legs as he kept pushing me forward and backward. I started to scream because it hurt so badly and he covered my face over my mouth, but covered my nose too so I had a hard time breathing. Then he started breathing really heavily, he dropped my legs and was shaking as he started ejaculating. We all started crying hard. He pulled his penis out and the rest of the semen got on my naked bottom and my shirt, as well as the maroon carpet. He got angry and grabbed my underwear. He used my underwear to wipe up the spot of semen and then he got up and yelled 'Put your shirt in the sink [REDACTED] and then get dressed.'

As he passed the bathroom I heard him turn on the sink and then he turned it off again and left. When he was gone we cried together. He had put my panties in the bathroom sink to soak. David's abuse was so painful that I couldn't even sit down for a little while because it hurt so badly. It was the most difficult when I was supposed to be at school again. I told [REDACTED] that I had a hard time sitting and [REDACTED] asked me if I was thoroughly wiping my bottom after I went to the bathroom. I was so scared to tell her anything because of David's threats so I told her that I was not wiping as well as I should. [REDACTED] put me in warm bath with Epsom salt when this happened."

[REDACTED] goes on to relate experiences four through fourteen of very similar, violent rapes and sexual abuse endured by all of her siblings at the hands of David Hamblin. I will include written statements and timelines submitted by [REDACTED] as well as other information that may come from her siblings.

So far I have only spoken with [REDACTED], who goes by the name of [REDACTED]. She came to the police department with [REDACTED], whose nickname is [REDACTED]. She is [REDACTED] and [REDACTED] has remarried. During my conversation with [REDACTED], she stated she did not have any independent recollection of sexual abuse at the hands of David Hamblin. [REDACTED] did however receive a hand written letter from David Hamblin, recently at school, where she attends at [REDACTED] High School. It was delivered to her at the hands of teenage boy whose mother is either connected through her ward or some other means to David Hamblin for current or past counseling.

David Hamblin maintains a website called "the red path." He describes having therapeutic sessions and promotes the use of peyote and other methods of therapy. Regarding [REDACTED] and [REDACTED], I will be submitting a separate report with the information that [REDACTED] gave me and why she is so frightened to have any correspondence with David Hamblin.

DISPOSITION

As for this case regarding [REDACTED] and her accounts of sexual abuse, I will continue to add information and build this case as evidence is presented. It appears that there has been some history with the family and previous investigations regarding the [REDACTED]. I am working with the Utah County Attorney's office to verify time frames and dispositions of those investigations. I will continue to research those reports and include them with this initial report, as I develop this investigation.

I conclude this report disposition 4, pending future investigation. Dispo 4/kc

CASE STATUS AND UPDATE:

Since my last entry on this case I have met several times with [REDACTED] including times with her husband [REDACTED] and with [REDACTED].

I have met them at the County Attorney's office and have had conferences with them and the county attorney's victim advocates as well as with our victim advocates here at the Provo Police Department.

I have collected additional evidence i.e.; photographs, statements, etc. and conducted additional interviews.

I have prepared an affidavit for an arrest warrant for the suspect in this case, David Hamblin, and I am preparing this police report to be submitted to the County Attorney's office for review and reference to the affidavit for issuance of an arrest warrant.

MEETING DATES:

On March 9, 2012 I met with [REDACTED] at the Utah County Attorney's office for review of her case.

On March 15, 2012 I met with [REDACTED] and Victim's advocate Traci Anderson at the Provo Police Department for an additional interview. She also presented some additional evidence, i.e.: photos, etc. at that time and information regarding her sisters and phone numbers for those sisters that I might contact them to coordinate information regarding a particular trips to Jacob Hamblin's Arch in Southern Utah.

On March 16, 2012 I made a phone call to [REDACTED]'s sisters [REDACTED] and [REDACTED]. Those phone calls were audio recorded and copies of those phone calls are attached to this report recorded on a CD.

[REDACTED] OUT OF THE COUNTRY:

[REDACTED] and her husband [REDACTED] for the next several months. They returned to the US in approximately August or September of this year. I did maintain contact with her through Skype and email during her tour in [REDACTED]. While she was gone I continued to try and organize the large amounts of evidence and photographs and prior reports that were associated with this case.

CONTACT REESTABLISHED:

On 9/12/2012 I met with [REDACTED] and the Provo Police Department to give her an update on the case and to make a plan to move forward. I also coordinated efforts with her and confirmed information to initialize preparation of an affidavit for an arrest warrant for suspect David Hamblin. I have continued to review reports, organize photographs and work on the compilation of this case, including making copies of the audio and video files to be attached and forwarded to the County Attorney's office.

CONTACT, [REDACTED] SISTERS:

I now want to make reference to the phone calls that I made to [REDACTED] sisters, [REDACTED] and [REDACTED]. This contact is relevant to the case because we discussed a particular trip that David Hamblin took with [REDACTED] to Jacob Hamblin's Arch in Coyote Gulch, Escalante Utah in Garfield County Utah. The zip code for Escalante Utah is 84726.

In [REDACTED]'s interview she references this trip and she remembers that it was significant to her because she stated that David Hamblin raped her several times on this trip. She also stated that her [REDACTED] and [REDACTED] could give independent recollections of this trip that would lend to the fact that David Hamblin was abusive to all of the [REDACTED] and to different levels of physical and sexual abuse.

CONTACT, [REDACTED]:

I contacted [REDACTED] at approximately 1640 hours Utah time on Friday, March 16, 2012. I was provided her phone number by [REDACTED] and I asked her if she would be willing to talk to me and give me an accounting of a trip that all the girls took with [REDACTED] David Hamblin to Jacob Hamblin's Arch in Coyote Gulch, Escalante, Utah. [REDACTED] agreed that she would talk to me. I asked her if she could remember how old she was; she stated that she was about [REDACTED] or [REDACTED] years old. She says that [REDACTED] would have been approximately [REDACTED] or [REDACTED] years old. [REDACTED] said that David was insistent on only the girls going on this trip with him this time. She said that he would not allow anyone else to go. Often times their mother would go or a cousin or a friend, but this time she stated that David was insistent that only he and the three girls go.

She remembers that they had to hike in for a long time to get to where they were going. She said that David knew the way to get into the Gulch and that they had to cross dunes and that they also had to climb hand holds that were pretty dangerous. She called them Indian hand holds. She said that David's statement to the girls was "If Indian kids can do it so can you." She stated that the first night they camped under the arch called "Jacob Hamblin's Arch." She said that the next day they climbed up the arch. She said that it was a pretty dangerous climb and she remembers thinking that it was probably not real safe, especially for girls as young as they were.

[REDACTED] went on to say that she knew that stuff had happened on that trip. She said I know he told me I couldn't wear my swimming suit. I asked her what he said specifically and she said that he something to the effect of "you can pack that in the bottom of your backpack, you won't need it." She said that she tried to put on her swimming suit and that David told her to take it off. She also said that one thing that she always remembers or that will always stay with her from that trip was how isolated they were. She said that there was no one around, they were out in the middle of nowhere and she followed that up specifically with the statement that probably there was no way anyone could have heard us if we screamed. I asked her to expand on what she meant by "stuff happened." She said "I know when something bad happens because I don't even want to remember it. When I think of that trip it's not with any fond recollection at all. It's like I don't even want to remember that. I know that bad stuff happened because of the few things I do remember like him telling me to not wear my swimming suit and the guilty feeling I had when he was taking pictures of us."

[REDACTED] went on to say that approximately 8 months after that trip she remembers David telling her in passing that not all pictures that are taken get developed and that people won't develop pictures if they are lewd. She also has a distinct recollection of that trip because she remembers David making fun of her the whole trip. I asked her to tell me about that. [REDACTED] said, "I was a very late developer. [REDACTED] was not so he made fun of me the whole time because I was so flat chested." I asked her what he would say and she said the word "pancakes" and she another phrase he used was "little nipper" referring to her flat chest. She also says that she does remember that [REDACTED] was on her period on that trip and that David was really angry about that.

[REDACTED] says that she wet the bed until she was quite old because of all the different issues of her childhood. She stated that due to that fact she would pack and take with her pull-ups. She remembers that [REDACTED] distinctly had to borrow some of her pull-ups for this trip because she started her menstrual cycle when they were on that trip. I asked her if she could tell me how David did not allow her to wear her swimming suit, was it just a verbal order or did he physically take it away. She said it was more of a verbal order. She said that he treated all of the girls differently. He was very emotionally abuse towards [REDACTED] but he was much more physically abusive towards [REDACTED] because they didn't bruise as easily and they were a little stronger. She said [REDACTED] was kind of a fragile person.

[REDACTED] went on to say that she very rarely stood up for herself and if she was going to exert herself it would be in behalf [REDACTED]. So when her father would tell her not to do something she just wouldn't do it to avoid the conflict. Then she followed that up with, "There's only so much you can do when you're [REDACTED]."

I asked [REDACTED] if they went swimming a lot on that trip and she said "Yeah, they went swimming a lot because there really wasn't anything else to do." The location is basically a sand hole in the middle of nowhere. I asked her if [REDACTED] was naked during this trip as well and she verified that "yes he was." She remembers him getting into the water naked.

She also remembers little things about the trip like they ran out of drinking water and she thought it was kind of gross that they had to actually filter or purify the water they had been swimming in so that they could drink it. She said that she was not allowed to wear her swimming suit at all during the trip, even though she wanted to. She remembers that the photograph she had made reference to was a photograph of her jumping off the side of the rocks into the water. She distinctly remembers her [REDACTED] taking pictures of the girls. As our conversation was drawing to a close [REDACTED] made the following comments. "It would be such a relief for us to be able to get him in prison finally. We know he's victimizing other people and he is a danger out that. I'm very willing to testify if I need to in court." Our conversation ended shortly thereafter.

I have included with this report a CD recording of my exact and entire conversation with Eliza Bradford on that date.

CONTACT [REDACTED]

I introduced myself to [REDACTED] over the phone and also asked her if she could give me an accounting of a trip to Jacob Hamblin's Arch that all three girls took with [REDACTED].

[REDACTED] stated that they would go often. Sometimes [REDACTED] would go and they would come across rivers, pools, springs, etc. and that they would swim and play in the stream and also swim in the pools that were deeper. She does remember one trip clearly however where everyone was nude including [REDACTED]. She also stated that she remembers another trip however where [REDACTED] took on the [REDACTED] and they went to what she called "Nirvana." She remembers climbing to the top of the canyon. She also remembers this trip specifically because she said her menstrual cycle started for the first time on this trip. She said it was very painful, that she was not prepared for that and that there was no mother or any other woman there to help her and she remembers that being very traumatic to her. She stated that her menstrual flow was heavy and that it was very embarrassing and she remembers hiding often behind bushes or wherever because she was trying to control her menstrual cycle while on this camping trip with [REDACTED].

She says that normally everybody would have been completely naked and swimming in the pools, even at her age and her [REDACTED] ages, but on this particular trip she didn't feel comfortable getting completely naked because her period had started and so she was allowed to wear a t-shirt and try to cover herself. She remembers that [REDACTED] didn't have anything on and neither did [REDACTED]. She remembers there was a lot of playing tag and what she called "wrestling" in the water with grabbing and touching things going on during that trip. She said that they all went swimming many times, it was very hot and there was nothing else basically to do there. She stated that there were no other hikers around, there were no other people around and they did sleep out in the desert. She remembers that she was about [REDACTED] years old and that [REDACTED] are about [REDACTED] apart respectively with her being the oldest. She said it was not uncommon for them [REDACTED] to get naked and she even remembers a trip before when [REDACTED], even though she was embarrassed, agreed to get naked and basically everybody go skinny dipping together. I asked her whose idea it was that everybody get naked and go skinny dipping and she said it was [REDACTED] idea.

[REDACTED] told me that she remembers feeling guilty and bad because her period had started. She felt like it was her fault and she knew that there was a shift in the way that [REDACTED] was treating her and not associating with her because that happened on the trip. She remembers that they walked a long time to get to the part where they were going. I asked if she could remember what vehicle they were in and she said it was Toyota. She described it as beat up, junky, white, hatch back type. It was cheap and it was little and really beat up and small.

She also remembers another facet of the trip as they were travelling back to the main road. She said that they had to travel for a long time on a dirt road and that the road was really bumpy and described it as having washboard ruts from the rain. She said that [REDACTED] us all, "help him drive" and take turns sitting on his lap for about 10-15 minutes each. We lost contact on the phone conversation for a few moments and then reestablished contact and [REDACTED] went on to tell me what she remembers about the trip.

She stated that they stopped at a little general store which she described as a mom and pop type store and she specifically remembers that because she was finally able to buy some maxi pads and take of her menstruation issue. She said they then went home.

She said that during that trip there were probably 3 or 4 separate swimming episodes where [REDACTED] all got naked and were swimming together in a pool. We lost contact again for a short time and then reestablished our connection and then I asked her if she could remember whether or not there was a camera or photographs taken on this trip. She said "Yeah," [REDACTED] had a camera, but she doesn't remember what kind. She thinks that probably everybody took turns taking pictures, but she knows [REDACTED] was taking pictures of the girls. I asked her if she had seen the pictures and she said she knows they exist, but she doesn't know if they ever got developed. She went on to explain that [REDACTED] liked to shop at REI that he was an outdoorsman and a hiker. She remembers that they ate a lot of MRE type meals or freeze dried meals while they were on the trip. She remembers also that they had to do some purification to water that they got out of the springs while they were there.

As she was recalling other specifics she remembers that there were little frogs everywhere and that they were not always all together all the time. She remembers in the mornings bathing by herself in a stream and she was not in the immediate vicinity or had eye contact with [REDACTED].

She also stated that once [REDACTED] got older they found out that [REDACTED] had told each one of them privately that they were his favorite [REDACTED] and that they needed to keep that a secret so that they individually thought that they were his favorite. I asked her if she could remember anything else that she thought might be significant.

[REDACTED] went back to the swimming issues and indicated that there was a lot of touching going on while they were swimming. She said that she remembers that David would "catch" them as they would jump in from the sides of the pools. As our conversation was drawing to a close, again my objective was simply to get her perspective of the trip to Jacob Hamblin's Arch, I asked [REDACTED] specifically if she could give me a statement or a sentence regarding what she would like to see happen with David. I asked her if she could do that what would that sentence or statement be. She made the following statements,

"He needs to be jailed for sure because he is so highly intelligent and highly trained." She said "he has a natural manipulative personality and it is such that he is a menace to society." She said "he's capable of doing so much damage to people, especially focusing on people who are already victims of other problems." She said "he preys upon the weaknesses and disabilities of people." She followed that statement up with "I wish we could get life imprisonment. Whatever we can do to have the most severe punishment of length of time in jail is the wisest thing to do."

Soon after these statements my conversation with [REDACTED] was terminated. An exact recording of my conversation with [REDACTED] in its entirety is attached to this report recorded to a CD.

SUMMARY: REASONING FOR [REDACTED] CONTACT:

I have included a summary of my conversations with [REDACTED] for the following reasons: this particular trip was traumatic to [REDACTED] because she said that David raped her several times on the trip. I wanted to get an independent recollection of this trip because the sisters were witnesses at least to this trip and can attest to the nature of [REDACTED], David Hamblin, and the way that he treated [REDACTED] as far as physical, sexual and emotional abuse is concerned. I wanted to include independent recollections to be considered for review and credibility concerning [REDACTED]'s report. Both girls were supportive of [REDACTED] and her efforts to bring this abuse to light. [REDACTED] actually initiated the conversation regarding this particular trip because she did locate photographs that were taken during that trip to Jacob Hamblin's Arch. Those photographs were submitted and are part of this case and available upon request. [REDACTED] also submitted many, many photographs indicating histories and locations between their home in Southern Utah and the Provo residence where much of the abuse also took place.

CHRONOLOGICAL TIMELINE PROVIDED

[REDACTED] provided a chronological timeline listing experiences one through fourteen and dating from 1986 to 1999. [REDACTED] references the Provo house which is located at 280 E 2200 N. Experience number two, five, six, seven, nine, ten, eleven, twelve, thirteen and fourteen all took place at the Provo residence. All of those experiences are detailed and included with this report and correspond with the attachment labeled Kate Baxter's timeline.

DISPOSITION

I will include one more supplemental report that describes in detail each incident that has been submitted by [REDACTED] with its corresponding time and location. The initial part of this police report indicates some of the worst experience that [REDACTED] initially reported when she and her husband came to the Provo Police Department. I will give further detail on those incidences and how they correlate with the timeline that she submitted and also how the correlate with the affidavit that I am submitting to the Utah County Attorney's office. This case remains open pending that final report.

ADDITIONAL INFORMATION SUBMITTED BY [REDACTED]

(Photographs)

Through the course of several interviews with [REDACTED] she produced several dozen photographs from her past. Most of the photographs were submitted to assist in creating a reference to the timeframe in her life when the sexual abuse was occurring.

She wanted to submit photographs that contained pictures of [REDACTED] home in Mt. Pleasant as well as the Provo home which brings these offenses into our jurisdiction. She also wanted to include photographs of the pets that she had while she was growing up. She had several dogs and cats as pets and claims that through eh hardest times when she was being sexually abused by [REDACTED] often she would rely on her pets for solace and consolations. She stated that almost every time [REDACTED], David Hamblin, would threaten to hurt or kill a family member if she ever disclosed what was going on he also included the family pets. She indicated that David Hamblin was an avid hunter and outdoorsman. When he killed large game he would often bring that game into the kitchen table and butcher the game in the home. She stated that he would make reference to butchering the family members and the family pets in the same manner and fashion that he butchered the large game usually Elk or Deer. [REDACTED] remembers this because it let a distinct impression on her because of all the raw meat and blood associated with butchering a large game animal. She asked that I include several pictures of her pets to show how close she was to those pets. She also included a photograph of David butchering an Elk on the kitchen table for reference. That photograph is attached to this report.

I have also made copies of several of the photographs that [REDACTED] requested be submitted for reference in this case. [REDACTED] requested that I submit photographs of the bathroom from the Provo home where much of the sexual abuse took place. She asked that I include photographs of [REDACTED], when they were at a much younger age, versus being grown adult women, married and with their own families, today.

She advised that as she was reviewing many of the [REDACTED] photographs, she noticed several bruises on their legs and remembers that their upper arms were often covered to hide bruises that she claims were sustained during the very intense physical and sexual abuse at the hands of David Hamblin. She also asked that I include photographs of David with the girls when they were at that younger age, so that we could reference what he looked like as well, versus the current, long grey hair, resembling the Native American heritage that he has since adopted.

[REDACTED] also asked that I include a photograph of her and [REDACTED] once David was no longer [REDACTED] as young women and including [REDACTED]. That photograph is also included with this report, showing all three [REDACTED] as [REDACTED] stated that in this photograph you can see that they finally have relief and that David is not constantly a threat in their lives; however she stated all three girls were always nervous because he was still accessible to them. I have original photographs of all of the copies that have been submitted with this report for reference or should they be requested.

TIMELINE/AFFIDAVIT/REFERRAL FOR CHARGES:

I have included a timeline developed by [REDACTED] regarding where she lived and where the sexual abuse took place during her lifetime. Included in that timeline is the following accounts in chronological order. I have also referenced these accounts back against an affidavit in support of an arrest warrant which is attached to this report.

[REDACTED] stated that when she was in Kindergarten in the years of [REDACTED] and [REDACTED] lived in the house that she referred to as the Centennial house because it was very close to Centennial Middle School in Provo, Utah. The actual address of that home is 280 E. 2200 N., Provo, Utah. The following is an account of what happened, verbatim in [REDACTED]'s own words due to the powerful nature of her recollection.

"During a school night while I was in Kindergarten I woke up needing to go to the bathroom really badly and after holding it for about a half hour I finally got up and tip toes to the bathroom. The basement was very cold because it was winter outside and so it made me shiver. After I wiped I realized that I got some pee on my hand and I wanted to wash my hand really badly. I went to the sink and kept looking behind me. I turned the knob for cold water just a tiny bit to get some water dripping out. I commenced washing my hands when I heard someone walking up behind me. David grabs me and I shook as I was I scared and cold and he grabbed my wet hands with one of his and pulled down his bottom garments revealing himself. He forced my hands on top of his penis and violently rubbed back and forth in my hand with his hand clenching the outside of mine. I was quietly crying and tense all over as he shook me back and forth because he was making me rub him so fast and so hard. He hurt my hands and he continued to squeeze them tighter and tighter. I was so grossed out I wanted to throw up. He continued until he started breathing more and more heavily and then he ejaculated in my face and tried to force open my mouth with his hand. I kept clenching my lips and turning my head away and it got on the floor. He kept saying "open your mouth [REDACTED]" I wouldn't. He had finished ejaculating and it had gotten all over my Care Bear nightgown and my face as well as the ground. He commanded me to lick his semen off the floor. I shook my head too afraid to look at him. He said it one more time. I responded in the same way, I was angry. He clenched my arms and made fists, hurting me, and said if you don't do it I will go beat up [REDACTED] right now. He started walking to [REDACTED]'s room, the west bedroom in the basement, and I said okay. I got on the floor and started licking up the semen. I was crying very hard and started to dry heave. He watched as I did it and when I finished he picked me up off the floor and put me on my feet. He pulled my nightgown over my head and wiped off my face and floor with the nightgown. Then he put the night gown in the sink, flushed the toilet and turned on the hot water. He told me to go to bed. I ran away into the bedroom and cried for what it seemed to be a long time. I was disgusted with the taste in my mouth. I kept spitting into a tissue I had gotten from the side of my bed. The taste of semen and smell of semen was so thick I couldn't sleep. As soon as it got light outside, about three hours later, I ran to the shower and showered off."

The next incident that [REDACTED] cited was also during her Kindergarten year in school. It occurred in Provo, Utah when she was approximately 5 years old. Her exact words are as follows:

"About a half hour after [REDACTED] left home David came downstairs where we were playing in the main basement area where most of our toys were. He violently grabbed [REDACTED] by the arm and yelled at [REDACTED] and I to follow him. [REDACTED] started crying and we quickly started following. He shook her and told her to be silent and told [REDACTED] and I that we should be silent as well. [REDACTED] was crying so hard and started hyperventilating so David threw her aside, hitting her against the wall. After he threw her against the wall David said that if we didn't remain quiet he would cut up and kill [REDACTED] and [REDACTED] orange Tabby cat named Angus. [REDACTED] kept crying quietly but it wasn't quiet enough because he threatened to hit [REDACTED] again. I moved toward him which was not uncommon of [REDACTED] to take turns being abused. I did it because I didn't want him to keep hurting [REDACTED]. [REDACTED] had both done the same thing for me before. David got a really crazy look on his face and violently took off my pants and yelled at me to kneel on the floor. I did and then he put his penis into my anus and picked up my back legs as he kept pushing me forward and backward. I started to scream because it hurt so badly and he covered my face over my mouth, but covered my nose too so I had a hard time breathing. Then he started breathing really heavily, he dropped my legs and was shaking as he started ejaculating. We all started crying hard. He pulled his penis out and the rest of the semen got on my naked bottom and my shirt, as well as the maroon carpet. He got angry and grabbed my underwear. He used my underwear to wipe up the spot of semen and then he got up and yelled 'Put your shirt in the sink [REDACTED] and then get dressed.' As he passed the bathroom I heard him turn on the sink and then he turned it off again and left. When he was gone we cried together. He had put my panties in the bathroom sink to soak. David's abuse was so painful that I couldn't even sit down for a little while because it hurt so badly."

[REDACTED] indicated that the abuse continued and was equally brutal whenever [REDACTED] would go to [REDACTED] home in Spring city, Utah as well. The next incident that [REDACTED]'s cites that occurred in Provo at that residence is the following.

"I loved to be at school. When I was home from school I wanted to go back because I felt safe there. Before dinner one night I was playing outside. It was around Halloween because there were pumpkins in front of the house across the street west from us. [REDACTED] called me to come inside for dinner. After dinner I went to take a warm bath in the bathroom upstairs next to [REDACTED] bedroom. It wasn't [REDACTED] bedroom bathroom, but one down the hall from them. When I went into the bathroom David came in after me. [REDACTED] was cleaning up after dinner in the kitchen which was a hallway away from the

bathroom. I'm not sure where [REDACTED] was and [REDACTED] were watching TV in the family room next to the kitchen. David came in as I was getting undressed and grabbed my shoulder and my neck with one hand and my vagina with his other. He told me not to lock the door and to stay in the tub until he said I could go back. He threatened that if I didn't he would cut up [REDACTED] and put them in my bed. I sat in the bath with the light on and stayed up as long as I could. [REDACTED] knocked on the door and asked if I needed anything before she went to bed and I said I was okay, that I wasn't feeling good and that the warm water was helping my tummy. She asked about it and I said I was okay. She went to bed. I laid there in fear as I heard [REDACTED] playing and laughing out the door. I wanted to get out and be with them and be safe. It was around midnight when I refilled the bath for the third time. I knew the time because the plastic cream colored clock that was hanging on right side of the toilet on the wall and I kept track of the time because it was so scary to sit there watching the clock. I knew David was going to come and molest me; I just wanted to get it over with. After refilling the bath it was warm and enveloped me, I fell asleep. When I woke up David was putting my on my stomach, leaning over the edge of the tub with my legs out and my head in the water. It was up to me to keep my head up to stop myself from drowning as he kneeled, dropped his pants, put Vaseline on his penis and pushed me back and forth putting his penis in and out of my vagina. We always had a big tub of Vaseline in the bathroom and every bedroom for that matter. He used that on his penis and raped me. I gasped for air over and over as my head came out of the cold water and my ribs hit the cold porcelain rim of the tub. I cried silently trying to be a quiet as I could. When I got loud he would stick my head under the water and hold it there for a few seconds. I would come up and be as quiet as I could. Not long after he ejaculated in me, breathing very heavily he pushed me back in the tub and drained the water. He leaned down right into my face and spitting on me commanded me to go back to sleep. I did, but not for long. I woke up around 4 am, which I think was about an hour or so after he came in and was freezing, not to mention I had sperm coming down my legs. I turned on the warm water and felt better. I went to the bedroom, put on my pajamas and went to bed. I ran to school the next morning happy to be there."

The next statement and incident that [REDACTED] remembers happened in the winter to spring of [REDACTED] to [REDACTED]. This incident also included strangulation. Again in her exact words:

"The first time I remember be strangled was when I was in 4th grade. I remember this because it was not long after the experience in the bathtub. I was sleeping in my bedroom when I suddenly awoke to David taking off my pajama bottoms and my underwear. I began to scream and he covered my mouth. I started struggling against him physically because I was afraid. He climbed on top of me and his weight took me over. He held down my kicking legs and started to put his penis into my vagina, but because I was struggling he got some sort of lubricant like Vaseline all over me and my sheets. He got so angry and told me that it would only hurt more if I struggled. I didn't stop, but he laid right on me and then put his penis into my vagina. It hurt so much I began crying quietly and tensing up. Then he started sweating as he moved back and forth. He was breathing more and more heavily and suddenly grabbed by neck as he ejaculated he squeezed my neck sporadically, not consistently, strangling me. Then he collapsed and let go. I was choking; I thought I was going to die. He got up and left."

The next incident [REDACTED] cites is a particular road trip that she was forced to take when she was in 5th or 6th grade. She cites details of how David Hamblin brutally sodomized her at least twice on that trip. She believes it was Southern Utah and into Arizona as they often went to those parts of country. The next incident that [REDACTED] remembers in Provo happened in the fall of [REDACTED]. She stated that she was in 7th grade at [REDACTED] Middle School when this incident occurred. Her exact words are:

"In my 7th grade I went to [REDACTED] Junior High in Provo; however the majority of my family remained in Spring City, Utah where my two older sisters attending [REDACTED] High. David, having an office in his home in Provo, spent the weekdays in Provo. [REDACTED] David would come into my room sometimes even three times, but at least once every night and rape me. I had a gauze canopy over my bed and because I would tie the knot so tight to try and keep him out he even ripped my canopy. I bought the canopy in the first place because I thought it would be protection as I slept. I saved up all my money as a 5th and 6th grader to purchase it. It cost around \$80 to \$100 at the company store. That is a lot of money for an 11 year old. He would tell me that he was an angel. He would also tell me that this was what God wanted me to do. He told me that if I remembered that he had come into my room and the things he did to me in the morning or if I told anyone that I would be killed along with all my family members, my pets, by best friends [REDACTED] and [REDACTED]. He also described in explicit detail how he would kill me. For example I remember this threat that he told me in the experience stated below. He told me that he would take a bid sharp knife into my vagina and cut me all the way up my front and through my face and head. Other times he would tell me to be happy and that I had to tell people how wonderful he was and what a perfect [REDACTED] he was. I did, I was afraid. I remember one particular night when I was praying because I was so afraid every night. He came in and saw me kneeling, praying, and said he was an answer to my pray and he torn off my pants, pushed me onto the floor and inserted his penis into my butthole. I fought against it as much as I could, throwing my arms behind myself. He pushed against me, moving toward and against me, breathing really heavily. He ejaculated on my back and in my hair. Before he left he pushed my head very hard into the carpet, almost suffocating me and then gave me the threat as stated above. Which was forget what happened or else I will take a big sharp knife into your vagina and cut all the way up your front, even through your face and head. The next day I got to school late. I was tired and very sore, not just in my butthole, but my on my arms and legs from the struggle. If I didn't obey him he would hit me and hold me down, sit on me and crush me. He would cover my mouth until I couldn't breathe and force me down. It hurt so much."

The next incident that [REDACTED] cites that happened in Provo, she states happened in about August [REDACTED]. She remembers it was her 7th grade year. She stated they came from the Spring City house to stay in the Provo house. Again in her exact words:

"When we drove up to Provo that night I sat in the back of the car and tried to sleep. I knew I wouldn't be able to sleep once we got to Provo. It was often clear to me that David was in the mood to abuse me or [REDACTED]. I was right. Later that night after we got to Provo he raped me two times. The first time was when we first got home. He had been listening to some bad music on the way up. I still don't know who it was, but they swore and had more of the 70's or 80's feel. It seemed like his music got him really sexually excited because when he got home he ordered me to run in the house as fast as I could and then he started chasing me, growling. I was terrified and started hyperventilating and crying as I ran. He began to laugh like an 'I'm going to get you' kind of laugh and then I slammed the door. The door to his office on the southwest end of his house, but not the laundry room door behind him and tried to lock it, but he opened the door and was laughing and growling at the same time and still chased me until I fell on the floor between his office and the hallway. I had tripped on the line between the lighter carpet and the brown tile. My head hit the tile floor in the hallway and I had a lot of pain. He dragged me to my feet, back into his office and flipped me over, undid my pants and pulled them off. I was crying and saying 'don't, don't'. Then he got up to close the blinds. It was dark outside and so if he turned on a light someone might have been able to see in. When he got up to close the blinds I flipped back over to my front side and grabbed my pants, pulling them up as I ran from the room to my bedroom next to his office. I locked the door to my bedroom and sat by it so if he tried to unlock it he could not. He yelled and yelled and yelled and even hit the door over and over. I was crying quietly and praying. I don't know what time I fell asleep because I didn't have a clock, but I woke up to the door smashing me against the east wall of the room. I had fallen asleep behind the door. He came in pulled me by my legs to the middle of my bedroom floor. He then already had his pants off and had stuff, lubricant, on his penis. He immediately forced his penis into my vagina, but it wouldn't go very far so he kept pushing and pushing. He started shaking and ejaculated in and one the outside of my vagina. He left me there and went to his room, one room away, and slammed the door. I went to the bathroom and locked the door behind me. I tried to clean up all the gross stuff he put on me. I cried and cried, afraid that I would wake him up in the process and he would come get me again. He didn't wake up just then, but he did come back later that night while I was asleep in bed. He pulled off my pajama pants and underwear and again inserted his penis into my vagina. It was so sore. He smelled horribly and drooled on me as he pushed himself back and forth. I fought against him and pushed him, but he just clamped his hands on my arms and held them up above my head. He started breathing heavily and then he ejaculated. He ejaculated in my vagina and as he was ejaculating he pulled out his penis and pushed my body down, putting his penis in my mouth while he said 'eat it' over and over. I cried and choked and turned my head away. He whacked my head and left the room. Again I went to the bathroom, locking the door behind me and showering. I had the worst headache the next morning and I missed my first period French class.

The next account that [REDACTED] gives at the Provo happened at approximately [REDACTED] to [REDACTED]. Her exact words:

"Prior to abusing me one night David came into my room while I was sleeping and woke me up saying my name loudly as he stood in his LDS garments. He then told me that he was a very powerful angel and that having sex with him was commanded by God. I became tense and afraid just like I always did, even fighting at times and he held me down and again as I continued to fight he started to hit me on my chest. He then grabbed my breasts which were just beginning to grow and squeezed them so hard I stopped fighting and cried. Then he forced his penis into my vagina and thrust in and out while he was on top of me. Then as he kept pushing down on top of me his smelly chest in my face I couldn't breathe. He ejaculated inside my vagina while collapsing on top of me. I cried and he left. I went to the bathroom and kept crying and showered off. At this age I still had not begun my period so he was not afraid to have intercourse. He was often lubricated before I would even wake up. I'm pretty positive that he just used the Vaseline by the side of our beds because I would sometimes find a black pubic hair in those tubs, which could only be his."

[REDACTED] cites another timeframe when she was raped multiple times by David Hamblin at the Provo residence. The timeframe is January [REDACTED]. She remembers the date because it was immediately following when David Hamblin was arrested for unrelated charges. I've included her exact words:

"After he was bailed out of jail by a friend or a client, not long after I spent another week or so at the Provo house with David. I was abused almost every night that week. I tried to get to school and stay there as long as I could. I had bruises the shape of fingerprints all over my bottom, hips and thighs. I remember him coming into my room almost every night and each time he would put his penis into my vagina and ejaculate. He was especially violent and angry this week. For example one night I particularly remember him putting his penis in me and sitting me up pushing me back and forth so he didn't move, just me. He did this until he ejaculated. He even gave me whiplash from it. That week I was in a lot of physical pain."

Then next incident [REDACTED] cites she refers to as "The worst time I remember." This one took place at the Provo residence in approximately January [REDACTED]. Her exact words are as follows:

"The last time I remember being abused was the last night I spent at the Provo house. I was sitting in my room while David was having a meeting with several men. I heard them all talking, laughing and yelling, but couldn't understand everything they were saying through the walls, nor did I want to. All of the sudden I heard David's office door upon, his footsteps down the tile hall and then to my bedroom. He opened the door and said 'Follow me [REDACTED]'. I just looked at him and shook my head. I was really afraid. He got angry and grabbed my arm and scolded me as he brought me to his office. I was in his office and all I remember was being so cold and smelling gross smells and four different men forced sex onto me, vaginal

intercourse. I don't remember who they were or know who some of them were. I did know that David was one of them. The next thing I remember is waking up in my bathtub with semen all over me. I showered off and went to bed."

LASTING EFFECTS:

████ listed several consistent problems she has had since her family has been separated from David Hamblin. These problems include fear and an absolute terror that David Hamblin will find her and possibly her husband and follow through with the death threats that she has endured for as long as she can remember. I have included her exact words explaining some of the residual fears she still harbors:

"Today, irrational or not, I am still dealing with many of these effects. The examples below have all been consistent problems since my family was separated from David Hamblin. 1- I still have to check my house, under my bed, in my closet, shower, everywhere when I come home. 2 - I can't sleep very well. I have night terrors of him hurting me. 3- I have a hard time with physicality, even with friends; hugging, sitting next to someone, being in a room alone with someone, especially a male. 4- I can't be at home alone, sometimes during the day, but especially at night. If I am I freeze and can't move or rather too terrified to move. 5- If someone walks into a room when I'm not expecting them to, sisters, mom, husband, I jump and often scream and cry uncontrollably for a while. Crying can last for a long time depending on how I was feeling already or how much I was scared. This is especially dramatic if I am getting into the shower or changing. 6- I can't be in a bathroom without the door locked. I get so scared that someone or David is going to hurt, rape or kill me. All the fears of his threats and abuse are flooding back into my muscles, mind and body. I'm terrified, but to protect others as well as my own family this document has to be recorded."

AFFIDAVIT:

According to the accounts that I have been able to obtain from █████ that occurred in Provo City, Utah County jurisdiction I have prepared/attached an affidavit to support an arrest warrant for David Hamblin. The affidavit I have submitted is requesting;

15 counts of rape of a child

4 counts of sodomy on a child

2 counts of aggravated sexual abuse of a child, as per the events relayed by Kate Baxter.

DAVID, LOCAL RESIDENT:

David Hamblin supposedly still lives in Provo at the listed address. He has been known to frequent the Deseret Industries at Provo, the Provo City library, the Wynnsong theatres in Provo and the Orem City Library. █████ says she does not feel safe as long as he is on the loose. She has encountered him on occasion, unintentionally, out in the public and she indicated that any time she has seen him she immediately leaves the area and has anxiety attacks for the rest of the day and possibly the week. David Hamblin's current driver's license photograph shows him to have long grey hair in a ponytail type style.

████ states that David Hamblin still conducts therapy even though his state license has been revoked for improprieties. I have included a copy of a records check indicating the date that his state license to practice was revoked.

████ indicated that David currently operates on a Webpage called the Red Path and I have included photographs from that webpage which appear to be David Hamblin.

David's ex-wife, █████, Roselle Stevenson, also has met with me and indicated that David has strong violent tendencies. She states that he has ties to the Native American Church called the Oklevueha Native American Church. She believes that with these ties which extend into Mexico that David will flee and disappear into Mexico if he is simply summoned to come to court and answer to these charges.

I have attached copies of photographs provided by █████. Copies of all of the interviews conducted with █████. A statement from Roselle Stevenson, █████. Photographs of David Hamblin as a young man and up to an including his current driver's license photographs as well as his driver's license records check for ID validation. There are also photographs from the trip to Jacob Hamblin's arch. The photos show the girls swimming, nude, as indicated in their statements. These photos are also available, upon request.

AFFIDAVIT INFORMATION AND WARRANT

During the week of December 10, 2012 I submitted an affidavit in support of arrest warrant to the Utah County Attorney's office. Pursuant to reviewing that affidavit and the rest of the police report, County Attorney Dave Sturgill then filed an information against suspect A1/David Lee Hamblin to include 18 felony counts of sexual offenses against a child. Those accounts are as follows:

- 2 - Attempted Sodomy upon a child
- 3 - Sexual abuse of a child
- 4 - Aggravated Sexual abuse of a child
- 5 - Rape of a Child

The probable cause statement for that information read as follows:

"Dan Dove, Provo Police Department, having probably cause to believe a crime was committed submitted evidence in support of the filing of this information: On or between August 1, 1991 and June 1, 1992, the defendant forced the victim (the defendant's daughter who was 5-6 years old at the time) to manual masturbate him until he ejaculated. As the defendant ejaculated he attempted to force his penis into the victim's mouth and eventually made her lick his semen off the floor.

On or between August 1, 1991 and June 1, 1992 the defendant anally sodomized the victim in front of [REDACTED]

On or about October 1995 the defendant fondled the victim's vagina and engaged in sexual intercourse with the victim who was [REDACTED] years old at the time.

On or between October 1, 1995 and June 1, 1996 the defendant engaged in sexual intercourse with the victim who was [REDACTED] to [REDACTED] years old at the time.

On or between August 1, 1998 and June 1, 1999 on at least 10 occasions the defendant engaged in sexual intercourse with the victim who was [REDACTED] to [REDACTED] years old at the time.

On or between August 1, 1998 and June 1, 1999 on at least 2 occasions the defendant anally sodomized the victim and forced her to perform oral sex on him. All of the sexual abuse occurred at the [REDACTED] Provo residence."

I produced the affidavit information and subsequent arrest warrant for A1/David Lee Hamblin to Judge Lynn Davis at the Utah County Courthouse on December 13, 2012. Judge Davis assessed a bail of \$750,000 cash only. The warrant indicated that it could be served day or night and from any state within the United States. The warrant number through the Utah County Attorney's office is #121403389.

JCAT COORDINATION

I contacted Ofc. Joshua Jennings with our joint criminal apprehension team (JCAT) taskforce. I advised him that we were going to arrest A1/David Lee Hamblin on today's date 12/13/2012 and requested that he and his taskforce try and locate him and maintain surveillance on him while we conducted a pretext phone call with the victim V1/[REDACTED]. Ofc. Jennings advised that he and his taskforce were able to locate A1/David Lee Hamblin or at least his vehicle at the listed address 541 E 500 N, an apartment complex in Provo, UT. They maintained surveillance on that residence and his vehicle while a pretext phone call was conducted between V1/[REDACTED] and A1/David Lee Hamblin at the Provo Police Department.

PRETEXT PHONE CALL

V1/[REDACTED] and her husband came to the Provo Police Department and we met with Victim's Advocate Traci Anderson in the soft interview room. V1/[REDACTED] called A1/David Lee Hamblin on a recorded line and conducted a pretext phone call. That phone call lasted approximately 41 minutes. During the course of the phone call V1/[REDACTED] confronted A1/David Hamblin regarding the multiple times that he had raped her as a child. A1/David Lee Hamblin distinctly states in that phone call, "I am sorry for raping you." As she continues to confront him and request explanation for his actions he also made the following the statements when she asked why he had sexually abused her. A1/David Hamblin said, "I'm not saying it isn't true." Later he said, "I wish I could apologize better." Later he said, "I believe you and I'm willing to own it and I'm gonna work hard on it." Later in the conversation he said, "I'm not saying someone in my body didn't do it, I'm saying I didn't do it." Later he said, "That's not saying it couldn't have happened or didn't happen to you and I'm not saying what you're saying isn't true." Later he said, "I believe it's quite possible, I don't doubt it." Later he said, "I've lived with this for a long time now. Sorry, Love. You sure are brave and well spoken."

A copy of A1/David Lee Hamblin's conversation with V1/[REDACTED] during the pretext phone call is attached to this report, recorded onto a CD. An electronic copy and a hard copy of that conversation was also provided to the Utah County Attorney's office.

ARREST INTERVIEW AND BOOKING

Once the pretext phone call had concluded I advised the JCAT taskforce to go ahead and arrest A1/David Hamblin and bring him to the Police Department for an interview. Ofc. Joshua Jennings and the taskforce were able to locate A1/David Hamblin at his address. They arrested him on the warrant and brought him to the Provo Police Department. I attempted to interview A1/David Hamblin in our interview room. I confirmed his personal information in writing, I.E. name, birthdate, address, etc. I then advised him that I wanted to have a conversation with him regarding his daughter and I advised him of his rights per Miranda. A1/David Hamblin invoked his rights to speak with an Attorney before talking to me and our conversation was terminated. Ofc. Orgill with our patrol division transported A1/David Hamblin to the Utah County jail and booked him in on the 18 felony counts listed on the arrest warrant.
