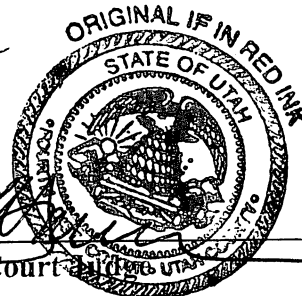

_____ Under Utah Code 77-32-202, the Utah County Public Defender's Office is appointed to represent the defendant in this matter.


