Initial Call

On 12/13/2012, I was contacted by Officer Jennings about an arrest warrant in the area of 541 E. 500 N. #11. He informed me that there was a warrant for the arrest of S/David Lee Hamblin with 18 counts relating to rape of a child. Bail was set at \$750,000.00 dollars cash only. There is a copy of the warrant attached.

Arrest

When we went to the apartment, the suspect, S/David Hamblin, opened the door. He was cooperative as Officer Jennings placed him in handcuffs. A security sweep was conducted of the residence, but no one else was present in the apartment. There was a burning candle inside that S/Hamblin requested be left burning, as it was a religious candle of some sort.

Transportation and Booking

I transported S/Hamblin to the Provo Police Department where he spoke briefly with Sgt. Dove. I was then asked to transport S/Hamblin to the Utah County Jail and book him on his warrant. I provided the jail with a copy of his arrest warrant and booked him under booking number 285698.

Disposition

S/Hamblin is currently in the Utah County Jail. There is nothing further at this time. End of report. Clear this case as inactive.
