On the date of 08-24-02, I contacted V-1 Roselle Anderson Hamblin at the address of 3820 N. Little Rock Dr. in Provo, Utah. Upon arriving, I met with V-1 Roselle Hamblin, the parent of S-1 Redacted. V-1 Roselle Hamblin stated that S-1 Redacted had run away. In doing so, S-1 Redacted Hamblin had taken her mother's vehicle. The vehicle is described as a 1994 GMC Suburban, two-tone blue-on-silver. The Utah license plate is #687JYP. V-1 Roselle Hamblin stated that she informed S-1 Redacted not to take the vehicle that evening. S-1 Redacted disobeyed and took the vehicle.

I asked V-1 Roselle Hamblin if she wanted to pursue any charges concerning Utah Code 41-1a-1314, which is Operating a Motor Vehicle for an Extended Time. V-1 Roselle Hamblin stated she did not want any charges at this time that might scar S-1 Redacted's records and cause her any problems with employment or school, later on in life.
