# Flush faucets and check for chlorine when reopening a business

When not in use for extended periods of time, water sitting in the lines can stagnate. As businesses begin to reopen in Templeton, owners are encouraged to flush inside lines and test for chlorine.

The town of Templeton doesn't have large business parks that have been closed for any length of time and water mains have been circulating well. But Templeton Community Services District (TCSD) General Manager Jeff Briltz does suggest the following for those opening up for business.

"Businesses should flush their faucets for several minutes," said Briltz. "If you have access to chlorine test kits or strips, like a pool test kit, flush until the test registers a chlorine residual."

# It's budget development time for local government and the outlook is bleak

By state law, local government agencies must adopt a budget for the upcoming year – or in the case of the school district, the upcoming three years – by the end of June. With the economy in very poor shape, state and local revenues are heavily impacted and budgets will take heavy hits.

Templeton Community Services District (TCSD) and Templeton Unified School District (TUSD) along with San Luis Obispo County are all working on their 2020-21 fiscal budgets under very challenging circumstances.

Tonight, we'll take a look at how the budget deficits may affect Templeton Schools, then look at TCSD and SLO County in upcoming editions. ### "Here's how a \$54 billion deficit will hurt Californians"

Cal Matters – May 7, 2020 By Judy Lin

California faces an unprecedented \$54 billion deficit. Finance officials announce the unemployment rate could reach 18 percent, worse than the Great Recession. Schools, health care and safety-net programs face devastating cuts as state and local officials seek additional federal stimulus.

The deficit is three and a half times the state's \$16B rainy day fund, and nearly 37 percent of the state's general fund.

#### Editor's Note! Note the section on K-12 schools in the above article.

Currently, it is estimated that there will be an \$18 billion decrease in minimum funding guaranteed for K-12 schools and community colleges. This is in addition to the estimated \$400 per pupil average or \$2.4 billion that CA schools have spent responding the coronavirus pandemic – over and above what was in their budgets.

Keep in mind that, by law, CA schools must adopt a balanced budget for the next school year and two more years out by the end of June. In addition to being in the black, the three-year budget projections must include a minimum 3 percent reserve.

Adding to the potential difficulties is something the Governor said a few weeks ago regarding limiting class sizes in order to practice social distancing and increasing the regular sanitizing and cleaning of school facilities once they reopen. If required, this directive would necessitate an increase in facilities, teachers, and MOT staff, literally bankrupting most school districts.

Keep in mind that schools operating in the red can be taken over by the state – eliminating any voice in local control. With huge budget cuts on the horizon and very costly, potential directives from the state, in addition to the current budgetary challenges Templeton schools have been dealing with, our school district and Board of Trustees have a daunting task ahead of them.

If the quality of your children's education, how and where they are educated, and by whom, is important to you, now is the time to get up to speed and participate in this process.
