Participants must comply with our house rules, use our proprietary technologies, have a ReentryPay bank account, use ReentryApp to stay on-track with release terms, and keep their mobile phone GPS on. No exceptions.
3. Zoning for our homes forbids acceptance of sex offenders and certain violent offenders. We are good neighbors.
4. ReentryCenters.com is not a drug treatment program or dispensary and not a mental health facility.
