Motion for Order of Diversion
(Into the Re-Entry Solution Program)

Comes now, _____, the defendant in the above-styled cause, and hereby moves this Honorable Court to order him/her placed into the Re-Entry Solution Rehabilitation Program (RSRP), submitting the following in support thereof:

- (1) The defendant has committed a crime against society by breaking one or more of the laws against the State of Alabama;
- (2) The defendant acknowledges the error of his/her ways and desires a chance to redeem himself before this Court and to society;
- (3) The defendant is prepared to plead guilty to his offense(s) and place himself/herself at the mercy of the Court, but desires an opportunity to participate in an alternative sentencing and rehabilitation program, instead of a state prison;
- (4) The defendant believes it to be in the best interests of society to allow him/her to serve his/her sentence in a community-based corrections program, in lieu of incarceration.
- (5) The defendant believes that he/she falls into a category of eligible offenders that pose low, or moderately low, risk to society and could safely be monitored and managed in an alternative sentencing setting.

As such, the defendant requests the Court to order him/her to participate and complete the RSRP residential treatment program at one of the Alliance Reentry Centers (ARC) facilities.

The ARC program helps rehabilitate and transform former offenders into law-abiding, employed, working, contributing members of society who are taxpaying and more resistant to the criminal influences experienced prior to their arrest.

The ARC has been proven to be effective at reducing recidivism rates among program completers greater than non-participants.

The ARC uses evidence-based practices that are proven effective at reducing criminal behavior and has been shown to improve outcomes for probationers and parolees. Some of the essential services the ARC program provides are:

- Housing
- Employment
- Transportation
- Mentorship and life skills coaching
- Financial education and training
- Family support services
- Drug prevention and recovery education
- Rehabilitative and reentry assistance

The ARC serves as an alternative path to incarceration that can help criminal offenders build skills necessary to reenter the community successfully, live productively, with a positive more well-rounded outlook on life.

The ARC's benefits include preventing future criminal behavior through surveillance, rehabilitation, and community reintegration; protecting the public and fostering public safety; easing institutional crowding and generating cost savings to taxpayers; addressing victims' needs through restorative justice; keeping offenders in the community under supervision; and reducing offender recidivism.

Wherefore, based upon the foregoing facts and premises, the defendant prays the Court will order him into the Re-Entry Solution Rehabilitation Program and permit him/her an opportunity to turn their life around and repay their debt to society in a positive more productive manner. The interests of justice would be so served.
