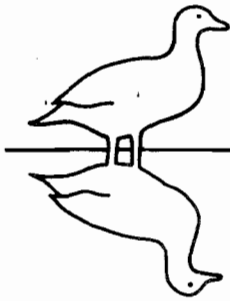

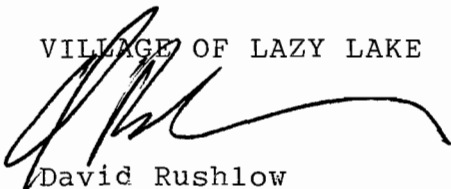

Re: Broward County Chapter 163 Review Comments - Town of Hillsboro Beach, Town of Lauderdale-by-the-Sea, Village of Lazy Lake and City of Lighthouse Point

Pursuant to Chapter 163.3184, attached are the Broward County review comments for the above-referenced comprehensive plans. Because of the nature of the Broward County Charter and its unique planning requirements, there are two sets of comments for each plan. One set of comments has been prepared by the Broward County Planning Council staff and the other by the Broward County Office of Planning.

The Broward County Planning Council, as the County Land Planning Agency for the county-wide land use element (Volumes I and III of the Broward County Comprehensive Plan), has prepared comments addressing the consistency of the local land use element with the County Land Use Plan. The Planning Council is scheduled to take formal action on the comments December 1, 1988. We will notify the Department of Community Affairs of the formal action.

The Broward County Planning Council, as the County Land Planning Agency for the Broward County Land Use Plan, is responsible for reviewing the local land use elements of all local governments in Broward County and providing comments to the Florida Department of Community Affairs. Pursuant to Chapter 163.3184, Florida Statutes, the Council's responsibility is to review each local land use element in the context of the relationship and effect of the element on the Broward County Land Use Plan. The Lazy Lake Land Use Element has been reviewed for consistency with the proposed 1989 Broward County Land Use Plan and Planning Council policies for certification of local plans. The following comments address those revisions to the Lazy Lake Land Use Element which are necessary to bring the element into conformity with the proposed 1989 Broward County Land Use Plan and the Planning Council policies for certification.

A. FUTURE LAND USE MAP

1. The land uses shown on the Village of Lazy Lake Future Land Use Map are consistent with the proposed 1989 Broward County Land Use Plan Map.
2. The Planning Council's certification policies require that all applicable Broward County trafficways be shown on the local land use plan map. Alternately, trafficways may be depicted on a separate map with a note on the Land Use Plan map indicating conformity with the Broward County Trafficways Plan. North Andrews Avenue, a 106' minor arterial, must be shown on the Village's Future Land Use Map.

B. FLEXIBILITY ZONE TABLES

1. The Village must submit a table for Flexibility Zone Number 45 indicating planned acreage by land use category and number of permitted dwelling units. This table may be part of the supporting documentation for the plan.
2. The second paragraph on page 6 of the Village's Plan indicates that the overall density in the Village is 65 dwelling units per acre. This appears to be an error. The number of permitted units is 50 (10 acres x 5 du's per acre).

C. PERMITTED LAND USES AND DENSITIES

1. The Village's Land Use Element should include a definition or explanation of how residential densities are calculated. The proposed 1989 Broward County Land Use Plan explains gross density on page IV-24. The Village may adopt this definition or a more restrictive definition of density.
2. The permitted uses within the Village's Parks and Recreation land use category are not consistent with the new Open Space and Recreation Category included in the proposed 1989 Broward County Land Use Plan. It is recommended the Village adopt the language of the proposed County Plan.

D. COUNTY PARK REQUIREMENTS

1. The Village must demonstrate compliance with the Community Parks and Recreation Standard of 3 acres per thousand population consistent with Section IV.C. of the proposed 1989 Broward County Land Use Plan. To meet this requirement, the Village must show that the commonly owned recreation area is zoned and deed restricted for open space use.

E. IMPLEMENTATION REGULATIONS AND PROCEDURES

1. The Development Review Requirements section of the Village's Plan should be revised to include the requirement that community parks be adequate to serve the proposed development consistent with the 3 acres per thousand population standard.
2. Section 4.1 (a) of the Village's Plan which addresses platting requirements must be revised to make the effective date the date of adoption of the 1989 Broward County Land Use Plan.
3. New procedures for amending the Broward County Land Use Plan will be included in the Planning Council's Administrative Rules Document which is currently being prepared. Changes to the existing procedures are under consideration and may necessitate revisions to Section 5.0 of the Implementation Section of the Village's.

F. GOALS, OBJECTIVES AND POLICIES

The Village of Lazy Lake is encouraged to review and address within their land use element plan all goals, objectives and policies contained within the 1989 Broward County Land Use Plan. The plan's goals, objectives and policies will be a primary consideration in the Council's review of the Village's certification and recertification requests and future County Land Use Plan amendment requests.

The Village is required to address those objectives and policies contained within the 1989 Broward County Land Use Plan which establish specific requirements for local plans. Local objectives and policies do not have to contain the exact language of the Broward County Land Use Plan, but must provide the same general direction. Local objectives and policies may be more restrictive than the Broward County Land Use Plan. Attached is a list of the objectives and policies (listed by the goal heading and reference number) from Section II. of the proposed 1989 Broward County Land Use Plan which local governments are required to address. If a specific objective and/or policy is not addressed within the Village's plan, the justification or rationale for such an omission must be provided with the certification request.

1. Sanitary Sewer: The Element indicates the BCSSE, as adopted, will be the effective element; however, the BCSSE service area does not include Lazy Lake.
2. Solid Waste: The Element does not indicate the effective element. Since Lazy Lake has entered into an interlocal agreement with the County, it is suggested the County's Element be incorporated as the effective element.
3. Potable Water: The Element indicates the BCPWE, as adopted, will be the effective element, yet the water is supplied via Wilton Manors from the City of Fort Lauderdale. It is suggested Lazy Lake consider making the City of Wilton Manors P.W.E. as the effective element.
4. Drainage: The Element references the Broward County Health Department which should be referenced as the Florida H.R.S., Broward County Public Health Unit.

Introduction

Staff has completed its review of the Comprehensive Plan for the Village of Lazy Lake for consistency with the *Regional Plan for South Florida*. This review is undertaken pursuant to the Local Government Comprehensive Planning and Land Development Regulation Act, Chapter 163, Part II, Florida Statutes and Chapters 9J-5, 9J-11, and 9J-12, Florida Administrative Code.

Summary of Staff Analysis

The Comprehensive Plan for the Village of Lazy Lake is incomplete. The Plan does not set levels of service as required by Chapter 9J-5, F.A.C. As a result, the Council is unable to determine consistency with the *Regional Plan for South Florida*. Staff objections, recommendations, and comments were made to strengthen the data and analysis and the future land use; traffic circulation; sanitary sewer, solid waste, drainage, potable water, and natural ground water aquifer recharge; conservation; recreation and open space; intergovernmental coordination; and capital improvements elements.

Recommendation:

Object to the Comprehensive Plan for the Village of Lazy Lake based on it being incomplete and therefore insufficient for review, and approve the staff report for transmission to the Department of Community Affairs (DCA).

THE VILLAGE OF LAZY LAKE COMPREHENSIVE PLAN REVIEW

Statutory Authority

The review of the Village of Lazy Lake Comprehensive Plan for consistency with the *Regional Plan for South Florida* has been undertaken pursuant to the Local Government Comprehensive Planning and Land Development Regulation Act, Chapter 163, Part II, Florida Statutes, and Chapters 9J-5, 9J-11, and 9J-12, Florida Administrative Code.

Community Description

The Village of Lazy Lake encompasses 13 acres located in east central Broward County. The Village is surrounded by the City of Wilton Manors. A location map is attached. The Village has a current population of 32, and projects no significant change in population by the year 2000.

The current land use in the Village is 77% residential and 23% recreation and open space. The Village is a largely built-out residential community centered around a small body of water known as Lazy Lake. The primary focus for planning is maintenance of the community's single family character.

Community Planning Initiatives

The primary new initiatives for Lazy Lake during the planning horizon include:

- Maintaining the single family residential character of the Village and upgrading the quality of the existing housing stock; and
- Maintaining the viability of the lake for drainage and recreation.

Objections, Recommendations, and Comments

The Comprehensive Plan for the Village of Lazy Lake is incomplete. It does not set levels of service for traffic circulation, solid waste, drainage, potable water, and recreation and open space, as required by Chapter 9J-5, F.A.C. As a result, the Council is unable to determine consistency with the *Regional Plan for South Florida*. Staff objections and recommendations are made concerning the traffic circulation; sanitary sewer, solid waste, drainage, potable water, and natural ground water aquifer recharge; and recreation and open space elements. Staff comments concerning the data and analysis, and the future land use; sanitary sewer, solid waste, drainage, potable water, and natural ground water aquifer recharge; conservation; intergovernmental coordination; and capital improvements elements are provided with the intent to further the goals of the *Regional Plan for South Florida* pertaining to these elements.

Objections and Recommendations

1. Traffic Circulation Element

- (a) The Village does not set a level of service for traffic circulation as required by Rule 9J-5.007(3)(c)1., F.A.C. It is not possible to determine consistency with the *Regional Plan for South Florida* due to this deficiency.

Recommendation:

Comply with Rule 9J-5.007(3)(c)1., F.A.C., by setting an acceptable level of service for traffic circulation in order to ensure consistency with Regional Goal 63.1, which calls for a ten percent reduction by 1995 in the portion of the regional roadway network operating below level of service D in 1987.

2. Sanitary Sewer, Solid Waste, Drainage, Potable Water, and Natural Ground Water Aquifer Recharge Element

- (a) The Village does not set levels of service for solid waste, drainage, and potable water as required by Rule 9J-5.011(2)(c)2., F.A.C. It is not possible to determine consistency with the *Regional Plan for South Florida* due to this deficiency.

Recommendation:

Comply with Rule 9J-5.011(2)(c)2., F.A.C., by setting an acceptable level of service for solid waste, drainage, and potable water in order to ensure consistency with Regional Goal 51.1, which provides for a reduction by 1995 of thirty percent in the amount of solid waste being placed in landfills in 1986, with Regional Goal 38.1, which requires a reduction in ground and surface water contamination, and with Regional Goal 37.1, which provides for a year round potable water supply and maintenance of adequate volumes for natural ecosystems, respectively.

3. Recreation and Open Space Element

- (a) The Village does not set a level of service for recreation as required by Rule 9J-5.014(3)(c)3., F.A.C. It is not possible to determine consistency with the *Regional Plan for South Florida* due to this deficiency.

Recommendation:

Comply with Rule 9J-5.014(3)(c)3., F.A.C., by setting an acceptable level of service in order to ensure consistency with Regional Goal 46.1, which provides for accessibility of the parks and recreational facilities in the Region.

Comments

1. General Requirements for Data and Analysis

- (a) Chapter 9J-5, F.A.C., establishes general requirements for the data and analysis which support comprehensive plans. The Village of Lazy Lake Comprehensive Plan does not include certain required information, such as information related to population projections, soils, historic properties, wellfield cones of influence, traffic circulation, and interlocal agreements. This information is necessary to determine consistency with the *Regional Plan for South Florida*. The Village should provide the required data and analysis or explain clearly why it is inapplicable in order to ensure that the Comprehensive Plan is consistent with the *Regional Plan for South Florida*.

2. Future Land Use Element

- (a) The Village and Broward County have different land use designations for the lake and adjacent land. Under its charter, Broward County is responsible for designating land uses within the County. The Village should conform to the County's land use designation or include a policy in its intergovernmental coordination element to resolve this issue.

3. Sanitary Sewer, Solid Waste, Drainage, Potable Water, and Natural Ground Water Aquifer Recharge Element

- (a) The Village has no plans to convert from septic tanks to sanitary sewer and states that the cost of such a conversion would be prohibitive. There is no data and analysis provided in support of this statement. Regional Goal 66.2 encourages the replacement of septic systems with sanitary sewer. To further this intent and strengthen the sanitary sewer subelement, the Village should include an objective or policy to pursue financial assistance for a conversion.
- (b) The *Regional Plan for South Florida*, specifically Goal 51.1 and Policies 51.1.2 and 51.1.3, encourages the reduction of solid waste through the use of recycling products and programs. To further this intent and strengthen the solid waste subelement, an objective or policy should be incorporated to promote the use of recyclable products and programs through public information, or other appropriate means.
- (c) At a minimum, the existing stormwater management systems and current levels of service should be maintained. A monitoring and maintenance program should be established for existing and future systems.

4. Conservation Element

- (a) South Florida is dependent on the Biscayne Aquifer for its potable water, the sole source of drinking water in the region. Regional Goal 37.1 encourages the protection of the region's potable water supply. It is suggested that Lazy Lake develop and implement water conservation goals, objectives and policies for year round and emergency water conservation.
- (b) Two of the major pollutants of the water supply are fertilizers and pesticides. The *Regional Plan for South Florida*, specifically Regional Goal 45.1, encourages the reduction in use of these chemicals through xeriscape landscaping which requires minimal water, fertilizers and pesticides. Policies encouraging the use of xeriscape will reduce the need for these chemicals and will protect the water supply.
- (c) *The Regional Plan for South Florida*, specifically Goal 47.1 and Policies 47.1.4, 47.1.7, and 47.1.8, encourage the improvement of air quality in the Region. To further this intent, an objective to meet current and future air quality standards set by EPA should be adopted. The following policies are suggested to further the *Regional Plan for South Florida*:
 - (1) During land development, air pollution should be minimized through the use of environmentally approved mulching, spraying, or grassing of exposed land surfaces.
 - (2) Demolition/renovation projects shall comply with all asbestos regulations.
 - (3) The Village shall cooperate with Broward County and the Florida Department of Environmental Regulation to maintain acceptable air quality standards.

5. Intergovernmental Coordination Element

- (a) For those facilities or services provided by other local governments, the Regional Planning Council encourages the adoption of the level of service standards set by the facility provider when consistent with applicable regional policies. An additional policy in the intergovernmental coordination element to ensure cooperation for level of service maintenance is encouraged.

6. Capital Improvements Element

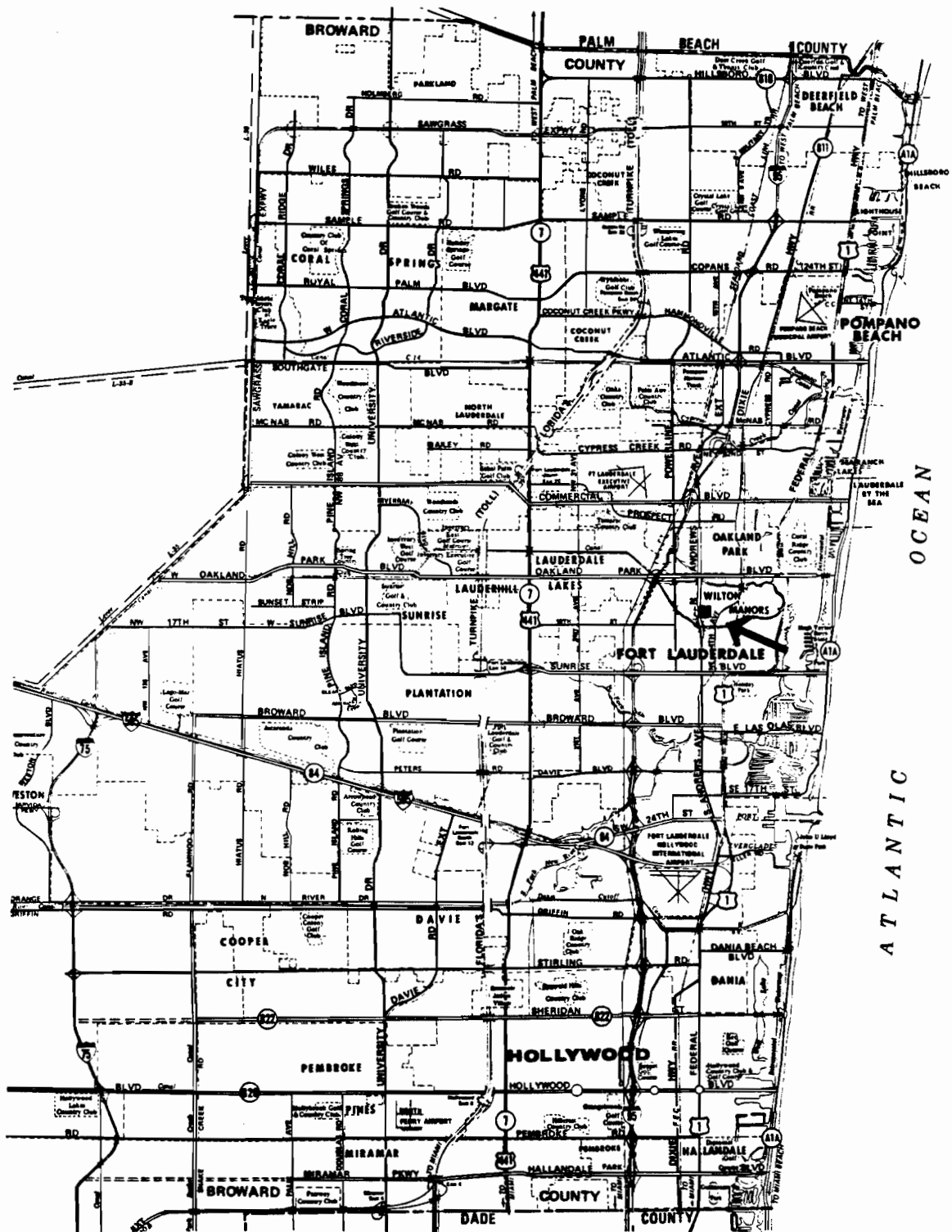
- (a) The capital improvements element discusses the need for street resurfacing, tree trimming, and lake cleaning, but does not schedule these items or provide project cost data, as required by Rule 9J-5.016(4), F.A.C. The Village should include a schedule and cost data for its capital improvements projects.

Conclusion

The Comprehensive Plan for the Village of Lazy Lake could not be reviewed for consistency with the *Regional Plan for South Florida* without adopted levels of service. Staff objections, recommendations, and comments are intended to strengthen the data and analysis and the future land use; traffic circulation; sanitary sewer, solid waste, drainage, potable water, and natural ground water aquifer recharge; conservation; recreation and open space; intergovernmental coordination; and capital improvements elements and to further support the Regional Goals corresponding to those elements.

Conditions of Review Findings

The results of this review by the South Florida Regional Planning Council (SFRPC) are based on the Comprehensive Plan for the Village of Lazy Lake, Broward County as approved for review by the Department of Community Affairs on October 7, 1988. The SFRPC reserves the right to review any amendments to the present submission for consistency with the *Regional Plan for South Florida*. The SFRPC will continue to work with the local government, the Department of Community Affairs, and the other reviewing agencies during the remainder of the review and adoption process.

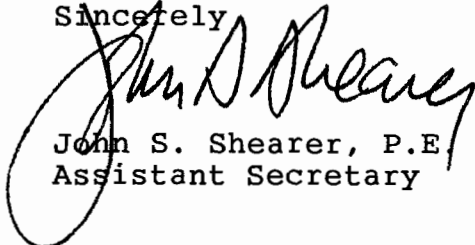

FUTURE LAND USE ELEMENT

Recommended Objections

1. An objective is not provided in this element which addresses the protection of the Village's natural resources, e.g. Lazy Lake and its tree cover. 9J-5.006(3)(b)4.
2. Policies are not provided in this element that provide for drainage, stormwater management and protection of environmentally sensitive lands. 9J-5.006(3)(c)4 and 6.

DRAINAGE SUBELEMENT

Recommended Objection

1. The statement on page 15 of the Drainage subelement, that "all drainage within the village is accommodated by the lake", does not indicate whether structural stormwater management facilities within the basin direct runoff to the lake or whether drainage is accomplished entirely by overland flow. 9J-5.011(1)(e) and (f).

Recommendation/Comment

Clarify how the drainage of the Village of Lazy Lake is accommodated by the lake.

Lazy Lake is fortunate in that it is spring fed, has a minimal drainage area and relatively natural abutting land uses. Maintaining the water quality of this lake is obviously important to the Village's residents. The following recommendations are provided to assist them in this effort.

If structural drainage facilities are in place, then those facilities should be fitted with devices to reduce the pollutants in the runoff. Pollution control devices include debris screens on stormwater drains, detention/retention ponds, oil and grease skimmers, and vegetated swales to name a few. Positive drainage systems can be modified to include these devices if they are not already in place.

If drainage to the lake is accomplished entirely by overland flow, then controlling nonpoint pollution at the source is essential. Refraining from dumping toxic or harmful material into the lake or

storing it in yards where it may seep into the lake are good management practices. Fertilizer and pesticide use should also be closely monitored to prevent pollution of the lake by these activities. Unstabilized soil and yard debris can contribute organic matter to the lake resulting in sediment accumulation and turbidity problems. Vehicles should be washed where the wash water can be absorbed into the ground rather than runoff into the lake. Any runoff from the roads surrounding the lake should be directed to vegetated retention areas to prevent contaminating the lake with metals and hydrocarbons.

NATURAL GROUNDWATER AQUIFER RECHARGE SUBELEMENT

Recommendation

1. The use of septic tanks in this area (surficial Biscayne Aquifer - sole source of potable water) has great potential to adversely affect groundwater quality. The village of Lazy Lake should consider replacing existing individual septic systems with sewer connections. Although expensive, this alternative may become more financially attractive as older septic systems reach the end of their service life. Switching to a sewer system could thus be phased in over time. Due to the small size of this village (13 dwellings, 32 residents), connections could probably be made to an existing system in one of the surrounding municipalities. 9J-5.011(1)(f)2 and 4; 9J-5.013(2)(c)1.

CONSERVATION ELEMENT

Recommended Objections

1. This element does not provide an analysis of known pollution problems impacting Lazy Lake. 9J-5.013(1)(b). If grass carp are being used to control an aquatic weed problem there must be an oversupply of nutrients to the lake from septic tanks or lawn fertilizer. Problems should be identified and steps taken to reduce nutrient loads to the lake.
2. A policy is needed in this element which addresses implementation activities for the protection of water quality by restriction of activities known to adversely affect water quality. 9J-5.013(2)(c)1

Recommendation

The use of grass carp to control aquatic weeds is palliative in nature and does not address the cause of the aquatic weed problem. A water quality assessment of the lake and its watershed should be conducted to determine pollutant loads and their sources. With this information, cost effective and environmentally sound methods can be implemented to control pollutant input.

Funds should be identified in the Capital Improvement Element to accomplish the lake water quality study.

General and Specific Comments and Recommendations on Lazy Lake's Local Government Comprehensive Plan:

Future Land Use Element:

According to our review of the Florida Master Site File and the National Register of Historic Places, no sites currently are listed for the Village of Lazy Lake. On the other hand, our files also indicate that the area has never been evaluated to determine if any potentially significant historical resources may be present. For this reason, the Village of Lazy Lake needs to develop goals, policies and objectives for identifying, designating and protecting historically significant properties as directed by section 9J-5.007, Florida Administrative Code, and paragraph 163.3177(6) (a), Florida Statutes.

Traffic Circulation , Capital Improvements and Infrastructure Elements:

Activities associated with these elements may have an impact on significant or potentially significant historical resources. It should also be mentioned that both federal and state laws require Federal and State Departments of Transportation to evaluate project effects on National Register eligible properties, and that agencies must demonstrate that there are no feasible or prudent alternatives to adverse project impacts for any activities which they assist or undertake.

Housing Element:

Historical resources are not addressed either in the support documents or in the goals, policies and objectives of the Housing Element. Furthermore, the Village of Lazy Lake has developed no goals, policies and objectives for identifying, designating and protecting historically significant properties in accordance with section 9J-5.011, Florida Administrative Code. The rule states that this element shall contain one or more policies and objectives for the identification of conservation, rehabilitation or demolition activities that may affect historically significant housing or neighborhoods. As a consequence, the village needs to develop goals, policies and objectives which address the issue of historically significant housing. In light of the limited number of buildings there, if the village would provide photographs and the dates of construction of the houses, the Bureau of Historic Preservation would be pleased to provide assistance in determining if they are historically significant.

Infrastructure Elements: (See Traffic Circulation)

Conservation Element:

Should the local government designate a conservation area for natural resources, this might also serve to protect historical resources, especially prehistoric archaeological sites.

Recreation and Open Space Element:

Historical resources can be protected if they are included within passive recreation areas or green space preservation tracts.

We primarily assist local communities with their historic preservation efforts by helping them identify, evaluate and maintain or mitigate damage to significant historical resources in their areas of jurisdiction. Furthermore, projects with any state or federal involvement (e.g., Community Development Block Grants, 201 Wastewater Treatment Plants, airports, Land and Water Conservation Fund Grants, transportation projects, Developments of Regional Impact, U.S. Army Corps and DER permits, etc.) must be submitted to this office for review to determine the impacts they may have on significant historical resources. We urge, therefore, that the Village of Lazy Lake contact the Bureau of Historic Preservation regarding any technical assistance needed in the identification, evaluation, preservation and mitigation of damage to historical resources. A listing of findings by the local governing body, if any, which were not included in the ordinance; and

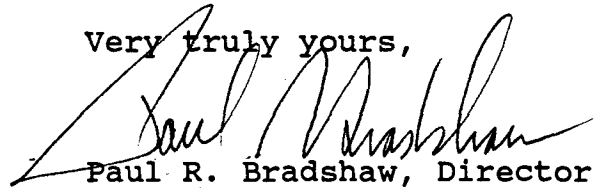
A statement indicating the relationship of the additional changes to the Department's Objections, Recommendations and Comment Report.

INTRODUCTION

The following objections, recommendations and comments are based upon the Department's review of the comprehensive plan pursuant to s.163.3184, F.S.

Because of the extremely small size and completely developed nature of this Village, the Department agrees with the Village that many of the requirements of 9J-5, F.A.C., are inapplicable. Therefore, this Objections, Recommendations and Comments Report addresses only those requirements the Department believes are applicable, and that the proposed plan does not sufficiently address.

Objections (A. in the attached report) relate to specific requirements of relevant portions of Ch. 9J-5, F.A.C., and Ch. 163, F.S. Each objection includes a recommendation of one approach that might be taken to address the cited objection. Other approaches may be more suitable in specific situations. Some of these objections may have initially been raised by one of the other state agencies. If there is a difference between the Department's objection and the state agency advisory objection or comment, the Department's objection would take precedence.

Each of these objections must be addressed by the local government and corrected when the plan is resubmitted for our compliance review. Objections which are not addressed may result in a determination that the plan is not in compliance. The Department may have raised an objection regarding missing data and analysis items which the local government considers not applicable to its plan. If that is the case, a statement justifying its non-applicability pursuant to Rule 9J-11.004(2)(f), F.A.C., must be submitted. The Department will make a determination on the non-applicability of the requirement, and if the justification is sufficient, the objection will be considered addressed.

The comments (B. in the attached report) which follow the objections and recommendations section are advisory in nature. Comments do not represent objections and will not form bases of a determination of non-compliance. They are included to call attention to items raised by our reviewers. The comments can be substantive, concerning planning principles, methodology or logic, as well as editorial in nature dealing with grammar, organization, mapping, and reader comprehension.

Appended to the back of the Department's report are the comment letters from the other state review agencies and other agencies, organizations and individuals. These comments are advisory to the Department and may not form bases of Departmental objections unless they appear under the "Objections" heading in this report.

- (c) Policies which are tentative or conditional, or do not describe the activities, programs and land development regulations which will implement the plan, are unacceptable.
- (d) Requirements identified in Chapter 9J-5, F.A.C., which are required to be addressed by objectives and policies must be based upon relevant and appropriate data.

If desired, local governments may choose to assign the measurability to a policy, however, it must be clearly linked to the pertinent

objective and the final combination must provide a clear basis for assessing the effectiveness of the plan. It is also incumbent upon the local government to establish that it has met the intent of the Rule when it deviates from the requirement related to measurable objectives. The Department is primarily concerned that local governments provide the basis for assessing the effectiveness of their plan.

Comprehensive plan objectives and policies must be written for each of the requirements identified in Chapter 9J-5, F.A.C., unless there is a valid explanation why the requirement does not apply. These requirements, by themselves, are not objectives or policies and cannot be used as such in the elements. All goals, objectives and policies within the plan shall be based upon relevant and appropriate data. Objectives and policies need to be supported by the data and analysis in order to have validity within the plan.

Objectives and policies related to land development regulations must be adopted pursuant to s. 163.3202, F.S.

A policy addressing the protection of environmentally sensitive land is not included.

Recommendation

Include a policy addressing this requirement, considering any needed protection of the lake and the area designated as open space within the Village.

6. 9J-5.006(3)(c)7.

A policy addressing the establishment of standards for

densities or intensities of use for each future land use category is not included.

Recommendation

Include a policy addressing this requirement.

1. The Village must submit a table for Flexibility Zone Number 45 indicating planned acreage by land use category and the number of permitted dwelling units. This table may be part of the supporting documentation for the plan (Broward County Planning Council).
2. The second paragraph on page 6 of the Village's Plan indicates that the overall density in the Village is 65 dwelling units per acre. This is an error, as the number of permitted units is only 50 (10 acres x 5 du's per acre) (Broward County Planning Council).
3. The permitted uses within the Village's Recreation and Open Space land use category are not consistent with the new Open Space and Recreation Category included in the proposed 1989 Broward County Land Use Plan. It is recommended the Village adopt the language of the proposed County Plan (Broward County Planning Council).

An analysis of the problems and opportunities for sanitary sewer has not been included.

Recommendation

Include in this subelement an analysis of potential problems and/or opportunities that the Village will face through the continuing utilization of septic tanks. Opportunities to connect to a central sewer system at some point in the future should also be analyzed.

3. 9J-5.011(1)(f)3.

This subelement states that there are no plans to convert the Village to sanitary sewer because the cost to the residents would be prohibitive, but there are no cost figures or other analysis to support this statement.

Recommendation

Include in the analysis of problems and opportunities cost figures to support this statement, or demonstrate the steps the Village could take to assuage some of the costs, such as the pursuit of any available State or Federal matching funds.

4. 9J-5.011(1)(f)4.

An analysis of soil surveys for areas served by septic tanks and an explanation of suitability of those soils for such facilities is not included.

Recommendation

Include an analysis of the suitability of the existing soils for septic tank use, basing this analysis upon the best available data from the United States Department of Agriculture, Soil Conservation Service.

Goals, Objectives and Policies

5. 9J-5.011(2)(c)1.

A policy establishing priorities for replacement, correcting existing facility deficiencies and providing for future facility needs is not included. Include a policy that addresses the Village's position and needs concerning the replacement of septic tanks with connection to a central system.

The portion of this requirement to identify and analyze known pollution problems has not been included.

The statement that grass carp are being used to control an aquatic weed problem implies an oversupply of nutrients are reaching Lazy Lake. Include identification and analysis of this problem (examining as appropriate septic tank effluent and fertilizers and pesticides) in this subelement.

2. 9J-5.013(2)(c)7.

Objective 3.2 and its associated policies (to maintain the ecological balance of the lake by continuing to stock the lake with adequate weed feeding fish and establishing a program to periodically clean the lake of debris) does not address removing the cause of the present ecological imbalance, and thus do not adequately provide for the protection of existing natural reservations, as required.

Recommendation

Expand this objective and its associated policies to include measures the Village can take to address the source of the oversupply of nutrients reaching Lazy Lake, (which could include control of fertilizers and pesticides and/or septic tank effluent).

3. 9J-5.015(2)(a)

An analysis that evaluates the effectiveness of the existing coordination mechanisms described in Paragraph (1)(b), such as intergovernmental agreements, joint planning and service agreements, special legislation and joint meetings or work groups which are used to further intergovernmental coordination is not included.

Recommendation

Include this analysis, assessing the effectiveness of the current contracts with the Village's service providers as well as all of the other existing formal and informal coordination mechanisms.

4. 9J-5.015(2)(b)

An analysis of the specific problems and needs within each of the comprehensive plan elements which would benefit from improved or additional intergovernmental coordination and means for resolving those problems and needs is not included.

Recommendation

Include an assessment of these special problems and needs, including such issues as the measures needed to solve the aquatic weed problem in Lazy Lake and the current inconsistency between the Village and the Broward County Planning Council regarding the allowable land uses in the Recreation and Open Space land use category.

Goals, Objectives and Policies

5. 9J-5.015(3)(b)1.

Objective 4.1 contains the phrase "continue to coordinate to the maximum extent possible". Use of this conditional language renders the objective neither specific nor measurable.

Recommendation

Expand this objective to provide specific and measurable direction for intergovernmental coordination between the Village and Broward County and the City of Wilton Manors.

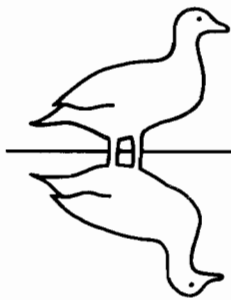

AN ORDINANCE OF THE VILLAGE OF LAZY LAKE, FLORIDA. ADOPTING THE VILLAGE OF LAZY LAKE COMPREHENSIVE PLAN 1989 TO INCLUDE GOALS, OBJECTIVES AND POLICIES FOR LAND USE, HOUSING, CONSERVATION/UTILITIES/RECREATION AND OPEN SPACE, AND UTILITIES/INTERGOVERNMENTAL COORDINATION/CAPITAL IMPROVEMENT/TRANSPORTATION; PROVIDING FOR THE ADOPTION OF THE FUTURE LAND USE ELEMENT, THE TRAFFIC CIRCULATION ELEMENT, HOUSING ELEMENT, SANITARY SEWER, SOLID WASTE, DRAINAGE, POTABLE WATER, AND GROUNDWATER AQUIFER RECHARGE ELEMENT, CONSERVATION ELEMENT, RECREATION AND OPEN SPACE ELEMENT, INTERGOVERNMENTAL COORDINATION ELEMENT AND CAPITAL IMPROVEMENTS ELEMENT; PROVIDING FOR THE ADOPTION OF THE FUTURE LAND USE PLAN MAP; PROVIDING FOR THE ADOPTION OF SUCH OTHER MAPS, TEXTS AND EXPLANATION AS THE COUNCIL DEEMS NECESSARY FOR CLARIFICATION; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Lazy Lake has caused to be prepared the Village of Lazy Lake Comprehensive Plan 1989 in accordance with the Local Government Comprehensive Planning and Land Development Regulation Act (Section 163.3161 et. sec. Florida Statutes); and

WHEREAS, the Village has reviewed, considered and addressed the comments submitted by the Department of Community Affairs pursuant to Rule 9J-11.010 Florida Administrative Code; and

WHEREAS, the Village has held public hearings on the adoption of the Comprehensive Plan in accordance with all applicable governmental regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF LAZY LAKE, FLORIDA:

Section 1: That the above recitals are true and correct and incorporated herein.

Section 2: That the Village of Lazy Lake Comprehensive Plan 1989 which includes the following elements and sections is hereby adopted pursuant to Section 163.3184 Florida Statutes:

- A. Goals, objectives and policies for land use, housing, conservation/utilities/recreation and open space, utilities/intergovernmental coordination/capital improvement/transportation.
- B. Monitoring and evaluation procedures.
- C. Future land use element.

- D. Traffic circulation element.
- E. Housing element.
- F. Sanitary sewer/solid waste/drainage/and nature groundwater aquifer recharge element.
- G. Conservation element.
- H. Recreation and open space element.
- I. Intergovernmental coordination element.
- J. Capital improvement element.
- K. Future land use plan map.
- L. Other maps, text and explanation contained in the Village of Lazy Lake Comprehensive Plan 1989.

Section 3: The Village of Lazy Lake Comprehensive Plan 1989 document is hereby adopted and incorporated by reference.

Section 4: If any word, phrase, clause, subsection or section of this Ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not effect the validity of the remaining portions of this Ordinance.

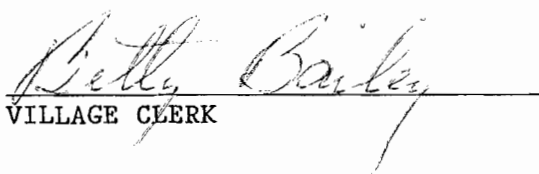

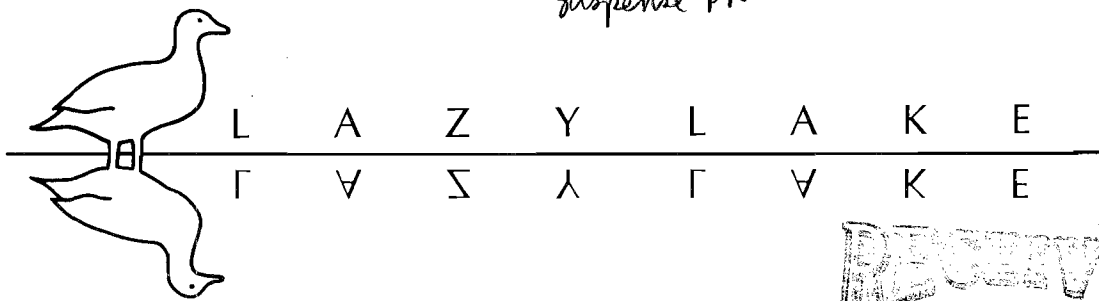

Introduction

On November 21, 1988, the Council voted to find the Comprehensive Plan for the Village of Lazy Lake inconsistent with the *Regional Plan for South Florida*, due to the lack of adopted levels of service. Council also voted to approve the staff report for transmittal to the Department of Community Affairs (DCA). On January 10, 1989, DCA issued an Objections, Recommendations, and Comments (ORC) Report. The Village of Lazy Lake adopted its Comprehensive Plan with revisions on March 14, 1989 and transmitted it to DCA for determination of compliance.

Summary of Staff Analysis

The adopted Comprehensive Plan for the Village of Lazy Lake now includes adopted levels of service and is found to be generally consistent with the *Regional Plan for South Florida*. Staff will continue to work with the local government, the Department of Community Affairs, and other review agencies during the remainder of the compliance review process. A copy of the original staff report will be provided to the Department of Community Affairs for their consideration.

Recommendation

Find the adopted Comprehensive Plan for the Village of Lazy Lake consistent with the *Regional Plan for South Florida*.

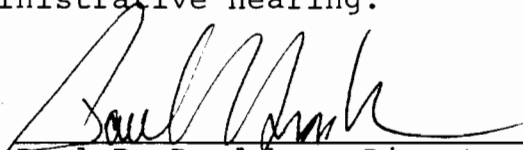

Community Profile

The Town of Lazy Lake is the size of a city block. It contains a total of 13 acres, and is entirely surrounded by the City of Wilton Manors. There are 19 platted single-family lots, some of which have been combined to make up the present 13 single family dwellings. The Town is built-out and the population is stable at 32 persons.

Eleven of the houses use septic tanks; two are connected to an adjacent Wilton Manors sewer line. Wilton Manors serves the community with water and Broward County handles the solid waste. There is only one road, a two lane cul-de-sac that essentially functions as a driveway for seven of the houses. There are no other roads within the City's jurisdiction.

Summary of Preliminary FindingsConcurrency Management (9J-5.006(3)(c)3.; .016(3)(c)6.)

The plan adequately addresses concurrency management with the inclusion of Objective 1.2.1 on p. 3 that states that facilities must be available concurrent with the impacts of development. Level of service standards to be maintained are established in Objective 4.5 (pg.5).

Levels of Service (9J-5.007(3)(c)1.; .011(2)(c)2. a.-d.; 9J-5.016(3)(c)4.)

The plan adopts adequate levels of service standards for public facilities in policies a) - e) under Objective 4.5 on pg. 5. They adopted a "qualitative" standard for Lazy Lane (which is a local street), and adopted the service provider's standard for the other public facilities. The data and analysis in the individual elements were also strengthened to provide support for the adopted objective and policies.

Capital Improvements/Financial Feasibility (9J-5.016(4)(a))

The plan demonstrates no need for capital improvements within the first five year timeframe. Estimated revenues and expenditures total \$14,484 for FY 88-89; the next five years show similar expected expenditures. These can be met out of existing revenues. The plan is financially feasible.

Protection of Natural Resources (9J-5.013(2), (3))

The Town's only natural resource is Lazy Lake, which is an old rock pit and not connected to any outside water sources. The lake is currently considered of good quality, but there has been a recent weed problem within the lake. Objective 3.1 and 3.2, pg. 4, outline how the lake will be protected from degradation. Objective 4.4, p. 5 states that by 1991, the Town will prepare a feasibility study regarding conversion of septic tanks to sewer. The following policy indicates that if found necessary and feasible, the housing units will be connected to a gravity sewer system by 1995. The Town is in a zone of saltwater intrusion and there are no wellfields nearby. Therefore, continuing the use of septic tanks does not have an effect on potable water quality. Since they address protection of the lake through their lake maintenance policies and the future study of the effect of septic tanks, protection of natural resources are adequately addressed.

Affordable Housing (9J-5.010(3)(b)1.)

Given that the Town is built-out, no objections to affordable housing were raised in the ORC Report. This is not an issue in this plan.

Coastal Management/Hurricane Evacuation (9J-5.012(3))

Since the Town is not coastal, this is not an issue.

Urban Sprawl (9J-5.011(2)(b)3.)

Given the built-out nature and size of the community, this is not an issue.

Intergovernmental Coordination (9J-5.015(2), (3))

The ORC contained several objections to the lack of data and analysis within this element. The adopted plan does outline what governmental entities they coordinate with and through what means (contracts, service agreements, etc). Their analysis states that everything works well currently and no problems have been derived from other comprehensive plan elements that would benefit from additional coordination. They have policies under Objective 4.1, pg. 4, to maintain the existing contracts with the service providers. Given the nature of the community, this requirement

is sufficiently addressed.

Consistency with the State Comprehensive Plan/Regional Policy Plan

The ORC contained two objections to State Comp Plan policies. The additional data and analysis submitted in the adopted plan addresses these objections.

The ORC contained objections to four RPC goals, mainly addressing the need to adopt LOS standards and protect the lake. The additional data, analysis, and goals, objectives and policies included in the adopted plan address the objections. The SFRPC had objected to the proposed plan due to the lack of adopted LOS standards, but since this issue was addressed, the Council did find the adopted plan consistent with the Regional Plan for South Florida in their March 20, 1989 meeting.
