# Official Nomination Call for CWA Local 6001 Executive Board Elections

***This is your official notice that nominations for Executive Board Elections are being accepted by CWA Local 6001 Election Committee for positions on the Executive Board of Local 6001.***

1. Members will be electing the following officers:
  - A. President
  - B. Executive Vice President
  - C. Vice-President
  - D. Secretary
  - E. Treasurer
  - F. Area Reps
    - i. Area 1: All members at DFW Airport (There will be 2 elected to this position)
    - ii. Area 2: All members at DFWRES - SRO (There will be 2 elected to this position).
    - iii. Area 3: All members in Premium Services for TX, MO and OK areas.
    - iv. Area 4: All members in Texas outside of DFW. (AUS, IAH, ELP, SAT).
    - v. Area 5: All members in Missouri and Oklahoma.
2. Only the names of properly nominated candidates will be printed on official ballots and mailed to members. **ONLY MEMBERS CAN NOMINATE OTHER MEMBERS AND VOTE.** All nominations forms must be received through **U.S. Mail at the Election Committee's P.O. Box by September 22, 2023.** No electronic nomination forms will be accepted. All nominations forms received will be reviewed by the Election Committee on **September 22, 2023.**
3. Nomination Procedure
  - a. Anyone wishing to be nominated for a CWA Local 6001 Executive Board seat must have attended at **least two (2) Informational Membership Meetings** in the twelve (12) months immediately preceding the nomination deadline **AND** be nominated by at least **five members** in good standing who are **eligible** to vote. **NO electronic signatures will be accepted.**
  - b. Nominees, or those nominating them, must complete the CWA Local 6001 Nomination Form. (Included).
  - c. Please mail the completed nomination form in a self-stamped envelope to the CWA Local 6001 Election Committee post office box by the nomination deadline of (September 22, 2023). **Mail to: CWA Local 6001 Election Committee, PO Box 1247, Euless, TX 76039-9907**
4. Tentative Time Line for Voting:
  - a. Deadline for Nominations: **September 22, 2023.**
  - b. Ballots mailed to members: **October 3, 2023.**
  - c. Deadline for Ballots to be received: **October 30, 2023.**
  - d. Runoff Ballots (if one) to be mailed: **November 3, 2023.**
  - e. Runoff Ballot Deadline to be received: **December 1, 2023.**
5. Campaigning
  - a. Campaigning must not interfere in any way with work. No campaigning in work areas. No campaigning during work hours except breaks in non-work areas.
  - b. No campaigning can be done at official union meetings, functions, or activities.
  - c. Candidates may produce and distribute campaign literature and materials. Such materials must be produced at the candidate's expense. No CWA or American Airlines symbols, logos or similar devices may be used on campaign literature. Uses of any CWA Union Boards are prohibited.
