

## BSA Troop 52, Emmaus Catholic Parish, Lakeway, Texas 2021-2022 Camp/Event Agreement

I/We, the parent(s)/guardian(s) of Scout, \_\_\_\_\_ do hereby give my/ our permission and approval for me/my/our son to participate in Troop 52 Emmaus Catholic Parish activities until the close of the LTISD 2021-2022 School Year (May 2022). I/ We do hereby, for myself, my heirs, executors, and administrators, waive, release, absolve, indemnify and agree to hold harmless any and all adults who chaperone this event, other participants, the Catholic Diocese of Austin, Emmaus Catholic Church, BSA Troop 52 and any of the above named parties' representatives, successors, supervisors, sponsors, and/or organizers, for any injuries in connection with the outing / event(s) conducted by Troop 52, provided that said injuries are not the result of gross, willful negligence.

I/We likewise release from liability any person(s), airline, bus company, or other transportation service, transporting myself/my child, in a privately owned and/or leased vehicle, to and from any activities connected Troop 52 activities, with the exception of gross negligence due either fully, or in part, to mechanical failure and/or operator error.

I/We also give permission to seek any emergency care should I/my child be involved in any accident or be injured in any way during such events and acknowledge I/we have submitted to the Troop Medical Officer a current and complete BSA Health and Medical Record and will keep the Medical Officer apprised of changes in my/our Scout's medical condition including medications and instruction on their use.

I/We understand that in any such instance, all attempts will be made to contact the parent/guardian. In the event that I/we cannot be contacted, I/we hereby give permission to the attending physician to hospitalize, secure treatment for, and to order injection, anesthesia, and/or surgery for myself/my child, as named herein. I also agree that I am legally responsible for all/any personal actions taken by me/my child/guardianship during these events, and agree to be financially responsible for any/all damages, legal fees, and other costs incurred as a result of the actions/behavior of myself/my child/guardianship. Furthermore, I/we agree that if the behavior of the above-named is inappropriate, unsafe and/or detrimental to the group, I will be contacted immediately to secure means of removing myself/my child/guardianship from the event premises. I understand that any financial costs incurred as a result of myself/my child/guardianship being sent home are my responsibility.

### SCOUT CODE OF CONDUCT:

1. I will behave in accordance with the Scout Law and Oath at all times in my actions and words. Vulgar language, profanity, and inappropriate topics are strictly prohibited.
2. When instructed/directed by an adult or junior leader to do or not do something that is in accordance with this code of conduct, I will follow the instructions/directive given to me. I will not be disruptive and will show the attention and respect that is expected.
3. I will consider the feelings of other scouts and adults and not do anything, either physically or verbally, that will make them feel uncomfortable or put them in a situation in which they feel threatened, including bullying.
4. I will bring to the attention of an adult leader or Senior Patrol Leader any situation that I am not comfortable with, and not take matters into my own hands.
5. I will not do anything that causes danger or harm to myself or others.
6. I will respect the property of others and not steal or damage property that does not belong to me.
7. I will leave my electronics at home. If I am caught using electronic games, phones, or audio/visual devices without adult leadership permission or to look at inappropriate material (pornography, adult content, etc.), I understand those devices will be confiscated and held by an adult leader until the end of the event.
8. I will not bring or receive unapproved food items and drinks (candy, sodas, junk food).

I understand that if I do not follow the rules outlined above that a call will be placed to my parents and that my parents will have to immediately remove me from the event. A meeting will then take place with my parents in attendance in order to discuss my future behavior and participation in events, including my status as a member of Troop 52.
