FOR THE OPTICS MENTIONED YOU WILL ALSO BE REQUIRED TO SEND THE SLIDE INTERNALS (MINUS BARREL AND RECOIL SPRING)FOR FIT AND FUNCTION CHECKS. FAILURE TO DO SO MAY RESULT IN ADDITIONAL FITTING NEEDED BY A QUALIFIED GUNSMITH.
