CCR&R continues to have conversations around ways we can help and encourage more participants to enroll in our trainings and make it a priority to attend. The barrier with participants not attending sometimes is out of our control when family emergencies, illness, or other things arise, but we truly appreciate the ones that call and/or email to let us know they are no longer able to attend in hopes we can provide an opportunity for another participant to attend. Our room capacity continues to be at 25 in hopes to keep the spread of illness at a minimum. We are grateful to continue to receive CVP funds to offer a mixture of face to face and virtual trainings to meet the needs of our child care providers.							
Success	Quarter three we offered three trainings that were made possible by CVP funds. We were excited to offer these 3 trainings as providers have been wanting trainings around literature and music. Each of these trainings had the perfect blend of presentation and collaboration. Participants were able to work in small groups where they practice implementing new skills into their child care program and ways to implement more music and dialogue reading throughout their day. We used CVP funds to not only pay for the trainer fees and mileage, but also to purchase musical instruments and books that participants got to use during the training.
