**JUDGMENT**

On December 21, 2020, Plaintiff Reneau C. Kennedy, Ed.D brought this action for injunctive and monetary relief against Defendant Vee Lee who is representing herself *pro se*, for violations of:

1. Count I - Cyberpiracy Protections for Individuals, 15 § U.S.C. 8131
2. Count II - Anticybersquatting Consumer Protection Act, 15 U.S.C. § 1125
3. Count III - Federal Trademark Infringement
4. Count IV - Federal Unfair Competition
5. Count V - State Unfair and Deceptive Trade Practices
6. Count VI - Common Law Trademark Infringement and Unfair Competition
7. Count VII - False Light
8. Count VIII - Defamation
9. Count IX - Punitive Damages

Ms. Lee agreed to the terms articulated in this Judgment and entry thereof without trial on all issues and facts herein as noted on the record at the Final Pre-Trial Conference of this matter held on March 10, 2023 before the undersigned.

Dr. Kennedy filed her Motion for Partial Summary Judgment on March 23, 2022 (Dkt. No. 56). On May 10, 2022, the Court partially granted Dr. Kennedy's Motion for Partial Summary Judgment, finding in Dr. Kennedy's favor on Counts II (15 U.S.C. §1125 Anticybersquatting) and Count VI (Common Law Trademark Infringement and Unfair Competition) and granting injunctive relief. *See* Dkt. No. 68.

Now, therefore, before the taking of any testimony and without trial, and upon the March 10, 2023 stipulation of Dr. Kennedy and Ms. Lee, **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:**

**I.**

**JURISDICTION**

The Court has jurisdiction over the subject matter of this action, which includes claims based on 15 U.S.C. §§ 1125, 8131, pursuant to 28 U.S.C. § 1331. The Court also has personal jurisdiction over Dr. Kennedy and Ms. Lee.

## II.

### DISPOSITION OF DR. KENNEDY'S CLAIMS

1. Count I - Cyberpiracy Protections for Individuals, 15 U.S.C. § 8131 is **GRANTED** in Dr. Kennedy's favor.

2. Count II - Anticybersquatting Consumer Protection Act, 15 U.S.C. § 1125, is **GRANTED** in Dr. Kennedy's favor pursuant to the Court Order Adjudicating her Motion for Partial Summary Judgment. *See* Dkt. No. 68. All unresolved issues of fact or law are **GRANTED** in Dr. Kennedy's favor by stipulation between Dr. Kennedy and Ms. Lee.

3. Count III - Federal Trademark Infringement is **DISMISSED** with Prejudice.

4. Count IV - Federal Unfair Competition is **DISMISSED** with Prejudice.

5. Count V - State Unfair and Deceptive Trade Practices is **DISMISSED** with Prejudice.

6. Count VI - Common Law Trademark Infringement and Unfair Competition is **GRANTED** in Dr. Kennedy's favor pursuant to the Court Order Adjudicating her Motion for Partial Summary Judgment. *See* Dkt. No. 68. All unresolved issues of fact or law are **GRANTED** in Dr. Kennedy's favor by stipulation between Dr. Kennedy and Ms. Lee.

7. Count VII - False Light is **GRANTED** in Dr. Kennedy's favor.

8. Count VIII - Defamation is **GRANTED** in Dr. Kennedy's favor as to the following statements:

9. Count IX – Punitive Damages is **DISMISSED** with prejudice.

### **III.**

#### **DISPOSITION OF MS. LEE'S COUNTER-CLAIMS**

1. Counter-Claim I – Declaration Judgment of Non-Infringement is **DISMISSED** with prejudice.
2. Counter-Claim II – Abuse of Process is **DISMISSED** with prejudice.

### **IV.**

#### **MONETARY JUDGMENT**

Judgment is hereby entered in favor of Dr. Kennedy and against Ms. Lee for violation of the claims granted herein in Dr. Kennedy's favor in the amount of ONE HUNDRED THOUSAND AND XX/100 DOLLARS (\$100,000.00).

### **V.**

#### **DECLARATORY JUDGEMENT**

Judgment is hereby entered in favor of Dr. Kennedy and against Ms. Lee for violation of the claims granted herein in Dr. Kennedy's favor and injunctive relief is ordered as provided for in the Order (1) **PARTIALLY GRANTING SUMMARY JUDGMENT IN PLAINTIFF'S FAVOR ON COUNTS II AND VI,** (2) **DENYING SUMMARY JUDGMENT ON COUNT V,** AND (3) **GRANTING INJUNCTIVE RELIEF (Dkt. No. 68) which is expressly incorporated herein.**

It is further ordered Ms. Lee must transfer the portlockpredator Instagram account and the domain "portlockpredator.com" to Dr. Kennedy and remove all

references Ms. Lee has posted on the internet regarding Dr. Kennedy within five days after entry of this Judgment.

**VI.**

**COSTS AND FEES**

Dr. Kennedy and Ms. Lee shall each bear their own fees and costs of this action.

**VII.**

**RETENTION OF JURISDICTION**

**IT IS FURTHER ORDERED** that this Court retains jurisdiction of this matter for purposes of construction, modification, and enforcement of this Judgment for one (1) year from entry.

**FINAL JUDGMENT**

This Judgment is final pursuant to Rule 54(c) of the Federal Rules of Civil Procedure.

IT IS SO ORDERED.
