Explanation for Additional Income:

The additional income generated through the sale of artwork created by the founder serves not only as a source of funding for the foundation but also as a unique way to offer our donors something of meaningful value in return for their contributions. By purchasing these original pieces of art, donors receive tangible, one-of-a-kind works inspired by the core mission of the True Top 1% Foundation—using art as a healing tool for veterans and servicemembers.

This gives our donors a deeper connection to the cause, as they are not only contributing financially but also supporting veterans' mental health in a more personal way. For donors, the artwork acts as a special and meaningful reminder of their contribution, making their support feel more impactful and tangible.

What's more, the sale of these artworks effectively increases the overall value of the donation. For example, a donation of \$5 to \$20 could transform into a donation of \$50 or \$100 when the donor receives an original artwork in return. This added value incentivizes donors to contribute at higher levels, knowing they will receive a meaningful piece of art that is both a representation of the healing process and a lasting symbol of their support for our veterans.

Through the sale of these artworks, the foundation not only generates essential revenue but also enhances the donor experience, helping to create stronger connections with our mission and inspiring greater generosity from those who wish to support our cause. By offering something of value in exchange for their donations, we are able to encourage more sustained and meaningful involvement, ultimately enabling us to reach and support more veterans through our programs.

Lines 28–31 – Program Services and How We Support Veterans and Military Personnel

The True Top 1 Percent Foundation exists to serve and support the men and women who selflessly chose to serve our nation. We recognize that military service does not end when the uniform comes off—many veterans face lasting effects from trauma, loss of identity, or difficulty transitioning to civilian life. Our programs are designed not just to help veterans survive, but to help them heal, reconnect, and thrive.

We focus on creative therapy as a non-clinical, accessible, and stigma-free path to healing. Our programs meet veterans and military families where they are—emotionally, physically, and mentally—and offer both structured and self-guided opportunities to process trauma, build community, and rediscover purpose.

Line 28 – Arts4Vets Art Therapy Classes

We provided 288 veterans with hands-on, instructor-led classes in painting, drawing, and sculpture, all within supportive environments where they could freely express their emotions and explore personal healing through creativity. These sessions are structured to help manage post-traumatic stress, improve emotional regulation, and foster a sense of belonging through shared artistic experiences. Art classes also empower veterans to reclaim identity and purpose beyond their service.

Line 29 – Mental Health Expressive Art Toolkits

This self-paced program distributed 278 personalized art therapy kits to veterans and active-duty personnel. Each kit includes high-quality materials, instructional guides, and therapeutic activities designed to support emotional expression, mindfulness, and healing. These toolkits are essential for veterans who may be isolated, homebound, or in early stages of recovery, and they offer a dignified and private way to explore mental wellness.

Line 30 – Capt. S. Claus Program

We reached over 240 military families through the Capt. S. Claus Program, an uplifting initiative combining holiday cheer with mental health outreach. Veteran Santas visited bases, hospitals, and community events offering free toys, meals, art kits, and meaningful conversations. More than just a festive experience, the program helps break the stigma around mental health by making support approachable and joyful. This initiative strengthens community ties and reminds servicemembers and their families that they are seen, valued, and supported—especially during emotionally complex seasons.

Line 31 – Other Program Services

An additional \$13,303 in program expenses supported multiple outreach and therapeutic initiatives, including:

450 bulk art kit distributions to veterans and their families

225 CAV Books (art-based mental health workbooks created in collaboration with IU Bloomington)

The #Painting4PTS initiative, which provides therapeutic painting sessions for those experiencing PTSD

The Angry Letter Therapy program, allowing participants to process and release anger through symbolic letter-burning and visual art
