Batoon-Garcia worked in different bilateral, regional and multilateral policy offices in the DFA as: Assistant Director, Office of ASEAN Affairs; Assistant Director Asian and Pacific Affairs; and Director, later Executive Director, Office of United Nations and International Organizations.

On foreign assignment, Batoon-Garcia served in various capacities as Consul in the Philippine Embassies in Tokyo and as Minister and Consul General in Washington, D.C. Later, Batoon-Garcia was appointed Ambassador to Venezuela and Trinidad and Tobago with jurisdiction over 20 other countries and territories. Subsequently she became the Ambassador to Thailand and Permanent Representative to UN ESCAP. Before retirement she was assigned as Ambassador to Norway, Iceland, Denmark, Sweden and Finland.

During Batoon-Garcia's various assignments in the Home Office and abroad, she formulated policy recommendations promoting Philippine interests involving political, economic, cultural, labor and assistance to national matters, among others. Aside from attending conferences, she represented the Philippines in the various countries and territories where she was assigned.

After retirement from the DFA, Batoon-Garcia joined MEPI, as Corporate Secretary, (2023-February 2025); Learn JP Corp., as Director, (2023 to the present); and AFDR Insurance Brokers, Inc. as Independent Director (2024 to the present).
