What's the diagnosis?

- we have a plan led system and so the failure to produce up to date plans inevitably causes major problems
- that failure, is in part, due to unreasonable or undeliverable expectations and requirements
- a lack of resources including skills as well as numbers

BUT at least partly responsible for all of that:

 a lack of clarity and consensus about what it is expected to deliver

do you really mean we have choice and can reflect our local priorities?



if you do, why do we keep losing all these appeals?



how do we maintain quality, quantity and morale?





Over the next 18 months....maybe



reform of local plan making (but slow and lots of friction)



useful changes relating to Neighbourhood Plans



possible change in the calculation of housing numbers



new legislation on biodiversity and nature recovery



unresolved issues relating to environmental impacts



changes in green belt policy (?)



recruitment and morale issues for local authorities in particular



community dissatisfaction and distrust



But all this change and 'about to change' is causing problems

- when will we know if this is going to happen?
- when will the detailed guidance and regulation be issued?
- how does it make sense to progress work which may turn out to be wasted effort?
- how do we know what's going to be best for our residents?
- and let's be honest: where is the local political advantage?





At community level

- 'planning by appeal' may continue to be an issue
- when and how to progress new or revised Neighbourhood Plans?
- other options for planning at neighbourhood level
- dialogue and relationship with the local planning authority
- infrastructure challenges
- delivery a key issue often overlooked and not managed well
