Clerks/Chairmen Forums

We have reintroduced Clerks and Chairmen's Forums. These are one of the best ways of ensuring that we are communicating with you and a great opportunity to receive updates and to ask questions of/give feedback to me and the Surrey Board Chairman. Over 30 clerks attended their first forum in early June and the Chair's Forum is on the 29th June at 10.30.

Initially we are keeping the forums fairly straightforward, however we will look at inviting representatives from other organisations -Surrey Police and SCC - to join us for an update on key issues that affect you all. Any other suggestions for 'visitors' that you would find useful would be very welcome.

Survey

As we are settling down into our new way of working it is now time to find out if there is a need to refocus some of our services. Next month the Surrey Board will be asked to agree a survey intended to understand your council and requirements. We really would appreciate it if you could respond to the survey. I promise it will not be too onerous.

SLCC

We recognise the importance of Surrey ALC and the local branch of SLCC working much more closely together for you benefit. The Chair (Iain Lynch) and myself will be meeting up soon to talk about how we can achieve this.

Surrey ALC Board

The Board is due to meet on the 12th July. There is a need to strengthen the Board and recruit new Directors who have skills and experience that will enhance SALC's services. We have information on our website asking for expressions of interest. We are very pleased to have had responses from interested members (from Surrey Heath, Guildford and Waverley area). Ideally, ultimately we would like to see a Surrey Board that has representation from across the whole County. This would be effective from mid October (after the AGM). Training Programme

It has been great to see many of you at training events. It is effectively the same team of trainers that ran the SSALC training. The training is currently modular and being delivered by Zoom with each module lasting on average around 90 minutes. This has proved to be very successful as not only are members happier with shorter time but it has allowed us to have much more focus on particular areas that affect the way a council, and its members, undertake its business. Feedback has suggested that the more established/experienced members have also found it useful as a refresher. More topics are regularly being added to the programme and it is worth checking the website regularly – see further details below.


Queen's Platinum Jubilee
