# Surrey CC Highways Parish and Town Council Engagement Project

Surrey CC Highways have set up a project to investigate what is important for Parish and Town Councils and how the Surrey CC Highways team

communicate. 15 Parish Councils and SALC are now involved in a focus group as part of this project. We look forward to updating you on the outcome.

## Subscriptions 2024/24

Surrey ALC have completed their own budget calculations and looking forward to the 2024/25 council year and indeed 2025/26, can confirm that subscription rates will be fixed at a 2% increase year on year and for those councils who have their fees capped at the large council rate will see a nominal £25 increase in the annual rate. Surrey ALC has worked hard to maintain a low cost base and as such is able to pass on these cost benefits to its members through below inflation price increases.



#### Pay Award 2023-24 Update

The pay increase has been significantly delayed over the last couple of years – last year's agreement for 22-23 was finalised in April 2023. The delays are due to negotiations between the National Joint Council (NJC) and the unions.

- Review of council business plan/vision document
- End of quarter review of financial position

# October:

• Start of budget setting process

- Interim internal audit
- Agree staffing budget for next financial year

#### December:

- Final budget approved by council
- End of quarter review of financial position

# **D-DAY 80**

D-DAY 80 6 June 2024 marks the 80th Anniversary of the D-Day landings and parish and town councils are encouraged to take part by lighting a Beacon on that day representing the 'light of peace' that emerged from the darkness of war. The King's Pageantmaster, Bruno Peek, has produced a Guide to Taking Part and this, along with the official logo for the event, and the Certificate of Grateful Recognition, can now be downloaded from D-DAY 80 BEACONS. Page 3 of the guide includes a message from the Prime Minister encouraging communities to take part, with the Introduction

to D-Day 80 on pages 5 - 6, along with the International Tribute on page 18, to be read out as Beacons are being lit that evening. A "beacon" can be anything from a small bonfire to a gas or even laser display.

We suggest all parish and town councils have an item on their next available agenda "To consider taking part in the D-Day 80 commemorations".



# Free first aid training for Surrey residents

# NALC launches consultation to update the Model Financial Regulations

NALC are working with The Parkinson Partnership LLP to update the 2019 Model Financial Regulations for England and Wales. The model financial regulations are part of a support package that local (parish and town) councils receive through their NALC and county association membership. They are an essential tool for councils of all sizes, setting out the framework within which the council ensures responsible, sustainable and compliant management of its finances. NALC are seeking views on the technical aspects of the regulations, and the responses will inform the revision and content of these regulations.
