## **Members Code of Conduct**

We have had a few enquiries regarding the recently published Local Government Association's Model Members Code of Conduct.

The LGA, following consultation, has produced a Model which aims to both (i) deliver consistency in the

implementation of the Code throughout the three tiers of Local Government and (ii) enables members to have a better understanding of the requirements of the Code of Conduct introduced under the Localism Act 2011 and subsequent Regulations.

Currently NALC is pressing the Government to respond to recommendations from the Committee on Standards in public Life published in January 2019 which made 26 recommendations to change the current standards regime governing conduct in local government, including the introduction of sanctions. We have not published the LGA Code on our website. However, aware that some Boroughs/Districts are adopting the LGA Code members may wish to discuss this further with their Monitoring Officer.

#### **Remote Meetings**

We were very disappointed on your behalf with the High Court Decision to dismiss the Application to allow remote meetings to continue post 7<sup>th</sup> May. We do not underestimate the difficulty that this places on you all. However, the simple fact is that any Meetings held remotely post 6<sup>th</sup> May will be unlawful. We will keep you updated.

#### **Welcome Back Fund**

The Government has established a £56m Welcome Back Fund. The Government is strongly encouraging Principal Authorities to pass on the funding to Town and Parish Councils and to work with them to boost shopping areas, high streets, provide/ improve green spaces, outdoor seating areas, markets and pop up food stalls. #### **Borrowing Approval Application Process**

We mentioned in the last bulletin that there was a significant backlog in processing applications. Officers from the County Associations have met with MHCLG (Parish Borrowing Team) and have received assurances that the backlog will be cleared by the end of June and current applications will take 3-4 months to turn around.

The whole process is to be modernised with the aim of streamlining it and making it easier for Councils and County Officers to manage.

#### **Key Changes to AGAR**

To remind councils <£25k that Internal Auditors must now monitor Transparency Code compliance to achieve an appropriate level of scrutiny.

### Furlough Scheme

This must be shown as income and not reduction in staff costs.
