SPONSORSHIP:

Applicants must be sponsored by a member of the NYC Verrazano 10-13 Association in good standing for the past three (3) consecutive years.

ELIGIBILITY:

Son, daughter or a grandchild of a member is eligible for a scholarship and must be attending or enrolled in a College or University on a full-time basis (at least 12 credits) for the 2009-2010 school year.

ONE ENTRY PER APPLICANT:

Only one application per applicant is permitted. If more than one application is received for the same applicant, all applications for that applicant may be discarded.

SAME FAMILY APPLICANTS:

Each eligible member of a family may participate. However, only one scholarship will be awarded per family each year.

VERIFICATION OF ATTENDANCE:

Winners will be required to verify school enrollment.

NUMBER OF SCHOLARSHIPS:

For the 2009-2010 school year, four (4) scholarships each in the amount of \$500.00 will be awarded.

SCHOLARSHIP DRAWINGS:

Drawings will be on a lottery basis in order to give each applicant an equal chance of selection. Scholarship awards will be drawn at the NYC Verrazano 10-13 Association General Meeting on October 21, 2009, by the Scholarship Committee and viewed by the membership in attendance. All applications must be received prior to the drawing date. **NO APPLICATIONS** will be accepted at the meeting.
