The May meeting date has been changed from May 16 to May 23. This was made so that members could attend the Albany Lobby Day trip.


Elections will be held at our November meeting. Members who are in good standing and wish to run must submit a written letter addressed to the Nominating Chairperson prior to the election.

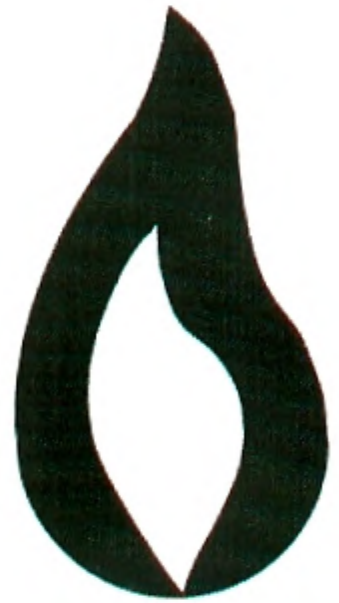
