Happy New Year from Governor Andrew Cuomo and Mayor Bill DeBlasio.

Beginning January 1, 2020 things will get even tougher for New Yorkers and its law enforcement community.

The below is from a November 2019 article in the NY Post by its Editorial Board.

Why new ‘bail reform’ law has New York law enforcement worried

As dumb as the moves sound, the state’s drive to spring some 900 city jailbirds early and the city’s plans to bribe them to show up for court are fully in the spirit of the “reform” law that kicks in Jan. 1. That’s the real problem.

Gov. Andrew Cuomo says he was unaware of state plans for early release of hundreds of accused. Maybe so — but he can’t be ignorant of the law itself, since he signed it.

The state Office of Court Administration is just figuring out how to apply the law, which outlaws bail for many offenses, when the ball drops in Times Square. Releasing all eligible jailbirds on New Year’s Day is impractical; hence the talk of springing them in batches through year’s end.

And never mind that those sprung include the likes of Jose “Catano” Jorge, charged with first-degree criminal sale of a controlled substance after a customer OD’d on fentanyl-laced heroin. Or Jacob Morales, who has two prior assault convictions and allegedly pulled a razor on a No. 4 straphanger. Or Anthony Matarazzo, who did hard time for robbery in Jersey and stands accused of holding up two Manhattan banks.

Outraged that these guys will get out early? Come Jan. 1, all such accused criminals will automatically walk pending trial.

They’re more likely to walk after trial, too: The “reform” law also gives defense lawyers the right to see all the prosecution evidence, including witness names, within two weeks of arraignment. If prosecutors fail to deliver, the case may collapse. Same if witnesses decide they’re too scared to testify after getting “mysterious” threats.

Now you see why departing Police Commissioner James O’Neill, incoming PC Dermot Shea and law-enforcement pros across New York are worried.

Mayor Bill de Blasio’s plans to offer the accused free baseball tickets, movie passes and gift cards to get them to return for court may look naïve — as one Manhattan Criminal Court senior staffer aptly put it: “You’re literally rewarding them for committing a crime.” But rewarding criminals fits perfectly with the new law.

Which, again, Cuomo signed. So, he gets no points for being less doofy than Blas here.

A memo circulated by prosecutors across the state lists some of the no-bail crimes come Jan. 1: criminally negligent homicide, aggravated assault on a child under 11, selling drugs on or near school grounds.

That’s some reform.

As part of this year's budget bill, the Legislature has passed a measure that will greatly reduce the number of arrested persons for whom judges may require bail. Taking effect in January 2020, the new legislation, as currently enacted, will have a significant negative impact on public safety.

The New York City Police Department favors responsible bail reform. There is no reason to hold non-violent minor offenders who pose no danger to public safety on cash bail of any amount. But any reform package should allow judges to remand arrested persons who represent a danger to others, as measured by the gravity of the offense for which they have been arrested and also by the gravity of offenses they have committed in the past.

New York State is one of only three states that do not allow judges to weigh the dangerousness of a subject in determining whether to remand the subject or set bail. Under the new law, judges will be expressly forbidden from remanding or setting bail even for flight risks in the cases of lower level robberies and burglaries and virtually all drug trafficking cases, no matter how many prior offenses the accused robbers, burglars, and drug dealers may have.

Beginning next year, police will be forced to release habitual criminals to return to their chronic offenses, whether violent crimes, burglaries, drug trafficking, or grand larcenies. For instance, an offender held on bail for a serious narcotics charge in 2018—and who had four prior arrests for robbery in a single year—would not be subject to bail under the new law.

The more strident bail reform advocates bolster their case by claiming that arrests for minor crimes are swelling the jail population with people held on bail. The opposite is true. The NYPD has systematically reduced the number of misdemeanor arrests, which are down 38% in the past five years. About 89% of arrested people are already released at arraignment, or before, without bail or incarceration. New York City's jail population has been declining for years, down 35% since 2013 and 63% since 1993.

In addition to restricting judges on setting bail or remanding dangerous criminals, the new law requires that many arrested persons be released with desk appearance tickets or DATs, without being held even for arraignment. Typically, arrestees who are issued DATs are released from precinct station houses within a short time of their arrests. Approximately one quarter of people released with DATs never appear for their scheduled court dates, and DATs have a negligible deterrent effect on chronic offenders.

Barring some specific disqualifying factor, had the new law been in effect in 2018, about 16,000 arrestees with prior arrests involving force, weapons, or sex offenses would have been released with DATs. This includes approximately 1,000 people with records of five or more arrests for violent crime in the prior three years.

With New York City crime down steeply since 1993, some Albany legislators seem to have lost sight of what it takes to keep crime down. Our current low crime levels aren't a permanent achievement. They are a continuing challenge.

At the NYPD, we work at that challenge every day. We target crime-prone locations, control conditions on the street, and focus on the criminal actors who cause much of city's crime. Disrupting the activities of the criminal population and reducing their opportunities for further crime are among our principal goals and our daily responsibilities.

The new law on bail and desk appearance tickets will make the work of disrupting criminals and deterring crime much more difficult. If the worst short-term outcome for chronic offenders is a DAT—which they perceive to be the equivalent of a traffic ticket—the police's ability to deter crime will be greatly diminished. State legislators should reconsider and revise this ill-advised legislation before it begins to eat away at the fabric of society.

Let me begin by wishing you and your families a Blessed and Very Happy New Year.

With the new year comes tax time where Uncle Sam wants his piece of the action.

Please be aware of the many scams that lurk about. The following article was excerpted from an AARP website.

IRS Impostor Scam

Some brazen scammers rip off unwary taxpayers by impersonating agents of the Internal Revenue Service. They'll call and insist that a potential victim has an unpaid tax bill and faces arrest unless they pay up, immediately. Con artists have numerous ways to make the hoax seem convincing. They can trick a caller ID to make it appear that the call is coming from an actual IRS office, and they may even know part of the mark's Social Security number.

In a recent three-year period, the Treasury Department's inspector general for tax administration received reports of more than 1.6 million calls from IRS impersonators, with more than 8,600 victims collectively losing almost \$47 million. One massive, long-running fraud scheme, eventually busted by federal authorities, saw call centers in India use information from data brokers to find potential victims, whom they contacted and scared into making payments via reloadable gift cards or wire transfers to co-conspirators in the United States. Older Americans were among the prime targets.

The IRS says scammers are increasingly turning to robocalls to reach as many potential victims as possible. Their ruses have become more elaborate, with some citing a nonexistent "federal student tax" that they claim their targets have neglected to pay. But you can deter the phony tax collectors by following some basic precautions.

Warning Signs

- It's a phone call. The IRS communicates mostly through the mail, including in cases of delinquent taxes. It will generally make contact by phone or in person only after a taxpayer has received multiple written notices.
- The pretend IRS official demands immediate payment and threatens to call police and have you arrested — things the IRS says it never does.

Do's

- Do hang up immediately, unless you have reason to think you actually owe taxes.
- Do forward any unsolicited emails in which someone claims to be from the IRS or the Treasury Department to phishing@irs.gov. Do not click on any links or open attachments.
- Do consider filing a fraud alert or freezing your credit with the three major credit-reporting bureaus if a scammer knows part of your Social Security number.
- Do ask for identification if you're visited by someone claiming to be from the IRS. Actual employees carry two official credentials: a "pocket commission" and an HSPD-12 card, a standard ID for federal workers. An IRS employee will provide, on request,

Dont's

- Don't provide or confirm personal or financial information over the phone to someone who claims to be a government official.
- Don't respond to a purported IRS email or text message asking for your information. The IRS doesn't do that.
- Don't agree to pay a tax bill with a prepaid debit card or wire transfer. Scammers prefer these methods because they're difficult to trace and can be used almost anywhere.
- Don't give credit or debit card numbers to a caller claiming to be an IRS official. The IRS says it never asks for such information over the phone.
- Don't assume a caller who tells you to verify his or her phone number by checking the IRS website is on the level. Caller IDs can be rigged to display the number of a real IRS office.
- Don't be bullied. A scammer will issue threats and demands, but according to the IRS, if you actually owe back taxes, you will get a bill in the mail and have an opportunity to appeal or to question the amount.
