## **TREASURER'S LINES - Paul Ferrigno**

Medicare Part B Differential was one of topics of discussion at our April, May and June Verrazano 10-13 membership meetings. Medicare Part B Differential Forms were distributed to all that required them.

For those not in attendance and may yet be unaware of the Medicare Part B Reimbursement Differential, the article below by SBA Fund Administrator, Errol Ogman is of utmost importance.

It reads as follows:

On April 12, 2019, most of our Medicare eligible members received their Medicare Part B Reimbursement. This deposit was sent via Electronic Fund Transfer (EFT) or direct-deposited as a separate transaction into the same account you have designated for your monthly pension.

Members who do not participate in direct deposit are scheduled to receive a paper check to the address you have on file at the Pension Section in June 2019.

The 2018 standard Medicare Part B Reimbursement was \$134 per person per month. This equals \$1608 for single members and \$3216 for a member with an enrolled dependent spouse.

It has been brought to our attention that some individuals who were Medicare-eligible prior to 2016 were reimbursed at an incorrect rate.

To recapture the correct amount due, members must prepare the attached 2018 Medicare Part B Reimbursement Differential Form and provide required back-up documentation.

### **REQUIRED DOCUMENTATION**

- \* If you are receiving Social Security Benefits, submit your Form SSA-1099
- \* If you are NOT receiving Social Security Benefits, submit CMS--500 Notice of Medicare Payment due or Proof of monthly Medicare Part B payments, such as bank statements, if you are directly billed for Medicare Part B premiums.

If you were enrolled in Medicare Part B effective after 2016, then you are already receiving the full payment and do not need to complete the Medicare Part B Differential Form.

If you are applying for IRMAA, you will be receiving the differential payment once IRMAA 2018 payments are processed in October 2019.

Copy of Medicare Part B Differential Form can be found on another page of this NYPD Verrazano 10-13 news publication.

The following number 212-513-0470 may be dialed and approximately 45 seconds into the message it is stated that those eligible for the differential will have the differential payment issued in October of 2019.



## **CORRESPONDING SECRETARY'S LINES - Vincent Montagna**



I found the following article online and thought it might be of interest to our membership. It does not apply only to New York residents. **42 U.S.C. § 5207 - U.S. Code - Unannotated Title 42. The Public Health and Welfare § 5207. Firearms policies**

### **(a) Prohibition on confiscation of firearms**

No officer or employee of the United States (including any member of the uniformed services), or person operating pursuant to or under color of Federal law, or receiving Federal funds, or under control of any Federal official, or providing services to such an officer, employee, or other person, while acting in support of relief from a major disaster or emergency, may--

- (1) temporarily or permanently seize, or authorize seizure of, any firearm the possession of which is not prohibited under Federal, State, or local law, other than for forfeiture in compliance with Federal law or as evidence in a criminal investigation;
- (2) require registration of any firearm for which registration is not required by Federal, State, or local law;
- (3) prohibit possession of any firearm, or promulgate any rule, regulation, or order prohibiting possession of any firearm, in any place or by any person where such possession is not otherwise prohibited by Federal, State, or local law; or
- (4) prohibit the carrying of firearms by any person otherwise authorized to carry firearms under Federal, State, or local law, solely because such person is operating under the direction, control, or supervision of a Federal agency in support of relief from the major disaster or emergency.

### **(b) Limitation**

Nothing in this section shall be construed to prohibit any person in subsection (a) from requiring the temporary surrender of a firearm as a condition for entry into any mode of transportation used for rescue or evacuation during a major disaster or emergency, provided that such temporarily surrendered firearm is returned at the completion of such rescue or evacuation.

### **(c) Private rights of action**

#### **(1) In general**

Any individual aggrieved by a violation of this section may seek relief in an action at law, suit in equity, or other proper proceeding for redress against any person who subjects such individual, or causes such individual to be subjected, to the deprivation of any of the rights, privileges, or immunities secured by this section.

#### **(2) Remedies**

In addition to any existing remedy in law or equity, under any law, an individual aggrieved by the seizure or confiscation of a firearm in violation of this section may bring an action for return of such firearm in the United States district court in the district in which that individual resides or in which such firearm may be found.

#### **(3) Attorney fees**

In any action or proceeding to enforce this section, the court shall award the prevailing party, other than the United States, a reasonable attorney's fee as part of the costs.

Moreover, as congressional Research Service correctly pointed out in a 2007 report on National Emergency Powers: "With exception of Habeas corpus clause, the Constitution makes no allowance for the suspension of any of its provisions during a national emergency." This of course, includes the Second Amendment.

### Your deadline is 2020, but now's the time to upgrade your driver's license

Pull out your driver’s license. Take a good look at it.

If you don’t see a black-circled star or a picture of an American flag, your license won’t allow you to board any commercial flight or even enter certain federal buildings as of October 2020.

But you might not want to wait long to act, given the tougher standards required for an upgraded ID and in case you’ve misplaced your birth, marriage or Social Security documents. Besides, your license might expire before the October 2020 deadline.

“If you ask me, what’s the one thing you’ve learned as clerk? It’s that people are not prepared,” said Erie County Clerk Michael “Mickey” Kearns. “This is a complicated transaction.”






More than 200,000 Erie County driver’s licenses will expire before the October 2020 deadline, a higher-than-average number. Add to that the crush of people who will wait until the last minute to upgrade their ID for a trip to Disney World or to see an ailing aunt in Charlotte.

Finally, many will grapple with the dizzying array of travel ID options and the official, original documents that must be gathered for each type of application, administered by different state and federal agencies. That includes REAL ID, an “enhanced” license and other “trusted traveler” programs.

If you already have a valid passport or enhanced ID, you’re ahead of the game. But for other local travelers, and even passport holders, now is the time to evaluate your future travel needs.

For all those reasons, the Erie County Clerk’s Office, the Niagara Frontier Transportation Authority and the Transportation Security Administration have teamed up to launch a 500-day awareness campaign. The NFTA has hung banners at the airport and will raise awareness through website and social media campaigns.

*Three main types of NY drivers licenses. (Courtesy of the NY DMV)* Kearns, meanwhile, said the Clerk’s Office plans 250 visits to libraries, government buildings, private companies and senior centers among other locations to raise awareness of the coming change.

The Clerk’s Office has also hired more personnel, established an online reservation service and opened Saturday hours at two auto bureau locations to help deal with the increased demand for services.

Here’s a Q&A on what you need to know.

**Q: Why is this change happening?**

A: After the Sept. 11 terrorist attacks, Congress passed the REAL ID Act to establish minimum security standards for state-issued IDs and driver’s licenses. The provisions of this act have been phased in over time but will be fully enforced beginning Oct. 1, 2020.

**Q: What does that mean for me?**

A: If you only hold a standard driver’s license, you will need to have a REAL ID or other higher form of identification, such as an enhanced license or passport, to fly domestically and to enter secure federal buildings and military bases.

A REAL ID or enhanced license requires an in-person visit to a local Department of Motor Vehicles Office. The application process can be cumbersome, so it’s important to have all required documents in advance. The county’s auto bureaus allow customers to reserve a time online to minimize or eliminate the wait for service.

Residents enrolled in other travel programs, including TSA Precheck, NEXUS, Global Entry and SENTRI, do not need a REAL ID.

Each of these programs has different eligibility and application requirements, costs and travel benefits. Required proofs of identity can vary for each type of program. For those who have considered signing up for TSA Precheck or NEXUS in the past, now is the time to give that serious consideration.

**Q: Do these ID requirements apply to children?**

A: No, the TSA does not require ID for children under the age of 18.

**Q: Will a standard driver's license still be an option?**

A: Yes. You can apply for a standard driver's license, which is still a valid form of ID, but it will cost the same as a REAL ID. A standard ID may be the only option for some if the State Legislature passes a law allowing immigrants living in the country illegally to obtain driver's licenses.

**Q: What will this cost?**

A: If your license is up for renewal, the cost for either a standard license or REAL ID is \$64.50. If your license is not up for renewal but you need to make the changeover midcycle, you will be charged \$12.50. The \$12.50 fee applies to any midcycle change to your license.

**Q: I fly domestically and want a REAL ID. What do I need to apply?**

A: If you already have a valid New York driver's license with a current address and it is not yet up for renewal, the least documentation that most adults will need in order to obtain a REAL ID, aside from your current license, is one proof of your Social Security number, such as a Social Security card or W-2 form, and two proofs of your state residency.

There are roughly 30 types of residency proofs, but the most common would include a bank statement or utility bill with your current address.

If your driver's license is up for renewal, then you will also need to supply one additional form of ID, such as a passport, birth certificate, naturalization certificate, permanent resident or employment authorization certificate.

If you do not have these, other proofs are acceptable to the DMV, but it gets more complicated. And if you changed your name, such as after marriage, divorce or remarriage, you're in for more headaches. You will have to produce a marriage certificate, divorce decree or other court document showing each change of name.

The New York DMV has an interactive document guide online to help you figure out what documents you need to change over your driver's license.

**Q: What's the difference between a REAL ID and an enhanced driver's license?**

A: One difference is cost. If you are renewing your license, an enhanced license is \$30 more than a standard or REAL ID. An enhanced license permits travel by land or sea to and from Canada, Mexico and certain Caribbean countries. Only U.S. citizens can apply for an enhanced license. But the proofs required to apply for either a REAL ID or an enhanced license are otherwise the same.

**In addition to the above you can add the following icons to your license.**

**NY State Adventure License FAQs**

**1. What is the adventure license?** The adventure license is a way for holders of a NY State DMV issued photo document (driver license, learner permit or non-driver identification card) to have any of the various lifetime sporting/recreational licenses, privileges or certifications you have purchased from the Department of Environmental Conservation (DEC) and/or the Office of Parks and Historical Preservation (Parks) added to your DMV issued photo document.

**2. What lifetime sporting/recreational licenses, privileges or credentials can be added to my DMV issued photo document?**

You may add icons for the following lifetime licenses/privileges/certifications: Sportsman, Boating Safety, Small/Big Game, Fishing, Bow Hunting, Muzzle Loading, Trapping, and the Empire Passport. Only lifetime purchased licenses, privileges or certifications may be added to the NY State DMV issued photo documents - annual licenses cannot be added.



**3. What will my DMV photo document look like with the icons?**

For Boating Safety Certificate and Empire Passport holders, contact Parks via their website: [www.parks.ny.gov](http://www.parks.ny.gov).

For Lifetime Sportsman, Small/Big Game, Bow Hunting, Trapping, Muzzle Loading, or Fishing, contact DEC via their website: [www.dec.ny.gov](http://www.dec.ny.gov).

For US Military Veteran's see below.

**4. If I already have a lifetime sporting/recreational license, privilege or certification how do I have it added to my DMV photo document?** You may request the icons be added to your DMV photo document in two ways; online using the New York State website or by visiting a NY State Department of Motor Vehicles office and presenting the required proof.

**5. Is there an additional fee to have icons added to my DMV photo document?** There are no additional fees if you request the icons be added at the time of your photo document renewal. If you wish to have the icons added prior to renewal, you will be required to pay the amendment fee as required by the Vehicle and Traffic Law (\$12.50 for driver licenses/permits and \$5.00 for non-driver identification cards).

### Veteran status designation on a photo document

If you are a qualified U.S. military veteran who was honorably discharged, and you have a NY State driver license, learner permit or non-driver photo ID card, you can have the word “Veteran” printed on the upper left hand of your photo document.

**There is no additional fee for the veteran status designation** on your document, but all regular transaction fees will apply. After you receive the veteran designation, it will automatically be on all of your future DMV documents (when you replace or renew).

### **To apply, you must provide proof of an honorable discharge**

Acceptable proofs area

- a U.S. Department of Defense Form DD-214 that indicates an honorable discharge
- a form DD-215 that indicates an honorable discharge
- if discharged before January 1,1950, an Honorable Discharge form WD AGO 53, WD AGO 55, WD AGO 53-55, NAVPERS 553, NAVMC 78PD or NAVCG 553, or an “Enlisted Separation Paper”
- a Certification of Military Service (NA FORM 13038) that indicates a discharge that is either “honorable” or “under honorable conditions”

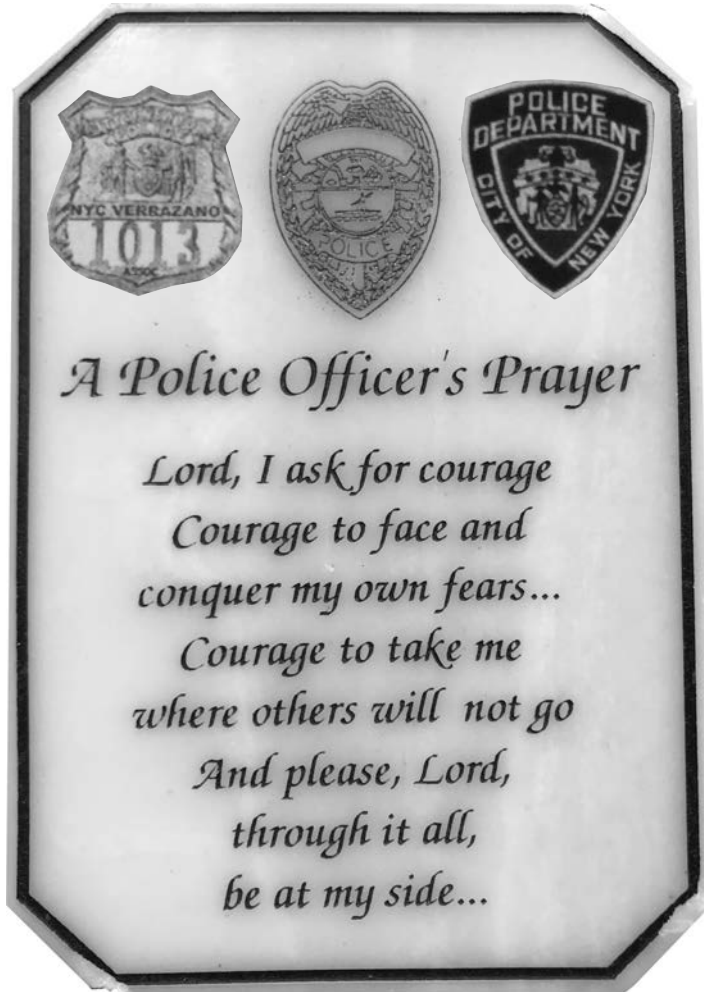
