out of Assemblyman Peter Abate's Committee on Government Employee's. State Senator Diane Savino, in response to an Allience letter and phone calls, assured Tony that she would expedite the Senate Bill S5543-A out of committee. ### Corresponding Secretary's Notes

Being the representative for the Verrazano 10-13 at the Brooklyn- Staten Island 10-13's Award Meeting was a pleasure long in coming. We finally seemed to bridge the gap and it was heartwarming to see and hear the response yours truly received as they announced my presence. We now can say we, in Brooklyn and Staten Island have overcome the problems and look forward to working with each other for the mutual benefit of all our members. I'll have the photos and other information in the next edition of the RMP. History was truly made.

One thing about the lousy winter, I did get to catch up on my reading. One article I briefed through and have since researched was one on a Blue Alert. It's a bill that if passed will have the same effect as the Amber Alert has with missing children. If a Police Office, or Law Enforcement Officer, is seriously injured or killed a Blue Alert will go out with as much information as possible to the public over radio and TV, in an attempt to apprehend the perp. We know it's worked for the children I think it would be a great tool for the guys in blue.

After making a few telephone calls from the local FOP office, to the New York State Headquarters, to the National Headquarters and finally to the original sponsors, the Georgia Fraternal Order of Police. I spoke with a young Georgia state representative that not only gave me the information but faxed me an actual copy of the bill which is before the Georgia State Legislature, SB 397. In effect the bill calls for a "Blue Alert System to speed the apprehension of violent criminals who kill or seriously injure law enforcement officers". I have contacted a few of our State Representatives, and a few hopefuls for November, in regards to this law being introduced in New York. So far the reaction has been positive but with the current situation of the New York State budget any sit down has been postponed to a later date. I also have copies of the bill ready to go to other local 10-13's, the NY State 10-13 Association, Tony Perrone of the NYS Public Employees and other law enforcement agencies. Maybe we should wait until after November!

I'll keep you posted on how this proposal develops. Until then, have a great summer and don't forget to support our golf outing. I know we'll pick up at least one foursome...Thanks, Brooklyn-Staten Island 10-13 Association.

#### HEART ATTACK WARNING SIGNS

Some heart attacks are sudden and intense, but most of them start slowly, with mild pain or discomfort. Here are signs that can mean a heart attack is happening:

Chest Discomfort - Most heart attacks involve discomfort in the center of the chest that lasts more than a few minutes, or that goes away and comes back. It can feel like uncomfortable pressure, squeezing, fullness or pain.

Discomfort in other areas of the upper body - Symptoms can include pain or discomfort in one or both arms, the back, neck, jaw or stomach.

Shortness of breath - This feeling often comes along with chest discomfort. But it can occur with or without chest discomfort. Other signs - These may include breaking out in a cold sweat, nausea or light-headedness.

If you or someone you're with has one or more of these signs, call 9-1-1...Get to the hospital right away. If you're the one having symptoms, and you can't access the emergency medical services (EMS), have someone drive you to the hospital right away. Don't drive yourself, unless you have absolutely no other option.

#### STROKE WARNING SIGNS

Stroke is a medical emergency. Every second counts, because time lost is brain lost! Know these stroke warning signs and teach them to others.

- Sudden numbness or weakness of the face, arm or leg, especially on one side of the body.
- Sudden confusion, trouble speaking or understanding.
- · Sudden trouble seeing in one eye or both eyes.
- Sudden trouble walking, dizziness, loss of balance or coordination.
- Sudden, severe headache with no known cause.

If you or someone with you has one or more of these signs, don't delay! Immediately call 9-1-1 or the emergency medical services (EMS) number so an ambulance - ideally with advanced life support - can be sent to you. Also, check the time so you'll know when the first symptoms appeared. It's very important to take immediate action. If given within three hours of the start of symptoms, a clot-busting drug can reduce long term disability for the most common type of stroke.

# The NYCPD Verrazano 10-13 Memorial High School / College Scholarship 2010 / 2011

#### APPLICATIONS:

The application is available in this newsletter or may be attained by contacting our office. It must be completed on provided application or an exact duplicate in size. Non-conforming applications will be discarded.

#### SPONSORSHIP:

Applicants must be sponsored by a member of the NYC Verrazano 10-13 Association in good standing for the past three (3) consecutive years.

#### ELIGIBILITY:

Son, daughter or a grandchild of a member is eligible for a scholarship and must be attending or enrolled in a College or University on a full-time basis (At least 12 credits) for the 2010-2011 school year. Each child can only win once, but a member can sponsor another child after waiting three years. High school students must be attending a tuition paying school.

#### ONE ENTRY PER APPLICANT:

Only one application per applicant is permitted. If more than one application is received for the same applicant, all applications for that applicant may be discarded.

#### VERIFICATION OF ATTENDANCE:

Winners will be required to verify school enrollment.

#### NUMBER OF SCBOLARSIDPS:

For the 2010-2011 school year, three (3) College and one (1) High School scholarship, will be awarded each in the amount of \$500.00.

#### SCHOLARSHIP DRAWINGS:

Drawings will be on a lottery basis in order to give each applicant an equal chance of selection. Scholarship awards will be drawn at the NYCPD Verrazano 10-13 Association General Meeting on October 20, 2010 by the Scholarship Committee and viewed by the membership in attendance. All applications must be received prior to the drawing date. NO APPLICATIONS will be accepted at the meeting.
