# *Vice President's Message*

## **FIRST RESPONDERS AND CIVILIAN SAVE LIFE OF VERRAZANO MEMBER**

On March 8, 2008, Verrazano 10-13 member Joseph Romagnolo and his wife Julia started their day as usual, by going to a local gym for their daily workout, located near their Highland Beach, Florida residence. What transpired next, set off a chain of events, that produced eleven (11) heroes; to whom the Romagnolo's will always be grateful.

Joe had just finished working out on a treadmill, and proceeded to a weight machine for his next workout. Almost immediately, Joe went into cardiac arrest, and started to turn blue. Julia, who was at the other side of the gym, saw a crowd of people around someone on the floor. She soon would realize that it was her husband, who was unconscious and not breathing. If not for the quick thinking, and actions of Walter Stansell of Maryland (who was also training at the gym), it is quite possible, that Joe would not have recovered. Mr. Stansell, an Army veteran, quickly started CPR on Joe and continued until the arrival of emergency personnel. Police Officers Yvette Ortiz, Laura Beck and Matthew McGarry of the Boca Raton Police Department soon arrived and continued giving CPR. Joe responded to the initial defibrillator shock the officers administered. Shortly afterward, his heart beat again stopped. A few moments later, members of Boca Raton Fire Rescue Services responded. They took charge of the situation, and continued to administer CPR.

The following members of the Boca Raton Fire Rescue Squad were present at the scene

Captain Michelle Murphy, Lieutenant Pat Bayne, Firefighters/Paramedics Pat Lao, Eric Alexander, Sean Moss, Bill Swoope and Kenny Clark. FF Eric Alexander, under the supervision of Lt. Pat Bayne, manned the defibrillator and paddled Joe in an attempt to restart his heart. His initial attempt yielded no response, with Joe still showing no heart beat. FF Alexander did not give up and after his third attempt, the shock sent to Joe's heart successfully restarted it; and he began to breathe. Still unconscious, Joe was removed to Boca Raton Community Hospital. Julia, still not sure if Joe would survive, was taken to the hospital by another team of Boca Raton Officers; P.O.s Snifflet and Williams. They remained with Julia until the hospital's Patient Advocate arrived.

It was a short time after Joe arrived at the hospital, that he regained consciousness with no signs of any brain or heart damage. The physical damage he sustained was much soreness to his ribs from the CPR machine's chest compressions, a laceration to the side of his face, and a split tongue. Joe made a full recovery and was fitted with a defibrillator/pacemaker implant. I'm happy to report that upon his return to New York, Joe was given a clean bill of health by his doctors.

For Walter Stansell's part, he modestly said, "while in Viet Nam I administered CPR on a number of occasions, but not always with this kind of result". It was made clear by the emergency personnel who responded, that Mr. Stansell's efforts were instrumental in bringing Joe back from the dead.

The Executive Board and the members of the NYCPD Verrazano 10-13 Association owe each and every one of these responders a debt of gratitude for saving the life, of one of our own. They each proved that they are truly worthy of the title "HERO".

*Note:* Several days later, Firefighter Erik Alexander stopped by the hospital to thank Joe for not dying.

## Recording Secretary's Notes

The meeting was called to order by President Rich Comnesso with a salute to the flag and a moment of silence for all sick and departed members. Special mention for the past president of the National 10-13, Tony Perrone, who underwent an operation. Board of Directors present were Rich Comnesso, President; Tony DeNatale, Vice President; Tony Franzese, Treasurer; Marie Zolfo, Secretary; and Joe Cammarata, Corresponding Secretary.

President Comnesso went over the minutes of the Board Meeting that was held on March 11<sup>th</sup>. Issues addressed at that meeting were:

Newsletter - The members were informed that the newsletter would go back to being a quarterly newsletter for the calendar year. The next newsletter will be published in April. Sponsors that are remiss on paying their dues were removed from the sponsor list. The Board is also looking at a new publishing and a more professional looking program for the newsletter.

National Raffle - Vice President DeNatale will be sending out the raffles for the National Raffle. There will be 400 raffles sold with the first prize being \$10,000.



**Election Year** - The members were informed that all of the Board positions will be open for election. Members who are interested should send a letter to Vice President DeNatale.

**Golf Outing** - Members were informed that this year's golf outing is to be held at Bunker Hill on June 9, 2008 and it might be catered. Members were asked to get their foursomes in and sponsorship of holes.

**Trustees** - Members were informed that Trustees need to get more involved and that they will be assigned certain tasks.

**Web page** - Members were informed that Verrazano 10-13 items on the internet go through Eddie Reuss. Sgt. at Arms, Joe Masella, will be getting information regarding the start up of our own web page. This web page will be just for the Verrazano 10-13 Association and will announce fundraisers, outings, etc.

President Comnesso reiterated that if members are interested in attending the golf outing, they should get their foursomes in. If we have enough foursomes, Bunker Hill will close down the golf course and we can have a full shotgun start.

President Comnesso also spoke about the Atlantic City trip and that the connection we had at Harrah's has left. Bally's may not be offering us the buffet and if that's the case, we won't be going there. We should have an answer by Friday. The date for AC is tentatively for Friday May 9<sup>th</sup>, or the following Friday.

President Comnesso and Vice President DeNatale attended the Alliance meeting in Albany on March 18, 2008. Tony DeNatale reported to the members that the Alliance is a group of over 40 organizations throughout New York State and is comprised of over 500,000 members. The Alliance has, over the years, lobbied for such bills as the Health Protection Bill, COLA increases and various Veteran's bills.

Tony DeNatale reported to the members that Spitzer had vetoed the Health Protection Bill, but had suggested a Task Force be formed to look into the necessity for such legislation. This is a one

year bill that the teachers get signed every year. Last year's Bill did not include police officers and firefighters, but did include fire officers. We were not included because our benefits are covered by the Administrative Code, so it is thought that we do not need this Bill, but that can be changed by the City Council. Assemblyman Joe Lento, Brooklyn, wants to include police officers and firefighters. Patterson voted every time in favor of our Bill. Lobby Day is June 11<sup>th</sup>, and the membership was asked to go to Albany for this matter. Tony DeNatale also spoke about there not being a ruling on three quarter disability pensions being taxed. He also emphasized that the write off for up to \$3,000 for health coverage is only for optional benefits.

Tony DeNatale mentioned to the membership that the National Convention will be held at the Friar Tuck Inn in July and that we get back a portion of the National Raffle money. Tony DeNatale said that if you do not want your super raffle ticket, bring it in and that it will be reissued. Also, this is the year for retirees to make changes in their health benefits.

Treasurer Tony Franzese reported to the membership that there is \$7700 in the General Checking Account that does not include the cost of this meeting. There is \$3,200 in the Savings Account and \$820 in the Special Checking account. Franzese said that we had \$881 in donations last year.

Franzese told the membership that there are color brochures for sponsors to our golf outing. Franzese reminded the membership that the golf outing is our biggest fundraiser.

The college scholarship will be coming out in the next newsletter and that this year we will try to have three \$500 scholarships. The drawing will be at the September meeting.

The \$100 50/50 was won by Ralph Caldarola, and the \$20 50/50 was won by Ed Parsons. Both contributed half back.

Members enjoyed a combination St. Patrick's and St. Joseph's Day meal. Pizza was also ordered.
