The Verrazano 10-13 is finally making a move to legally have us listed as a "Non For Profit" organization. Thanks to the help of John Donohue, we are well on our way. All the paperwork has been filed by Attorney John Friscia, who is also one of our sponsors. Many changes had to be made to conform with the guidelines set forth by the Government. A new Constitution and By Laws was drawn up by the By Laws Committee headed by John Donohue. On the committee were Terry Bennett, Bob Walsh, Ed Reuss and Frank Martarella. This move was attempted by our prior administration, but for some reason was not followed through. We started from scratch and received a new ID number. I can not begin to tell you the work that was done by John and his committee. Once the By Laws are in print, the membership will vote on the same.



At our February meeting, the names of the four (4) scholarship winners were drawn. They are as follows:

The Verrazano 10-13 had planned all along to issue four (4) scholarships. There was a miscommunication between our organization and the National 10-13. We were under the assumption that the National was donating a scholarship, due to the conversation between Anthony Franzese, Joseph Cammarata and National President Jim Ferguson. As it turns out, the National claims that no guarantee was made. The Board of Directors of the Verrazano 10-13 decided to still give the four (4) scholarships as promised. 

Vice President's Message

It seems that the rumor mill is being fueled by recent editorials in our local newspapers and letters to the New York State Legislature. In particular, let me refer to an editorial in the "New York Post" entitled, "Share the Pain." The article states.... "the pensions and other personal-service cost for public employees are skyrocketing, dragging down government budgets." The writer calls this a "pass" being given to government employees, while everyone else suffers. Where was the writer of this editorial when I took the PD test in 1968 and was hired as a police trainee at \$80 bi-weekly? Surely I, like all of my comrades, and our counterparts in the fire department; gave no thought at all of the toll working for this city, would have taken on us. It seems that the only people who think that police and fire retirees have found Shangri-La in the afterlife of retirement; are editorial writers and labor negotiators for the city.

I'd like to know where the writer received his facts? He notes that there are at last count, more than 10,000 retired cops under the age of fifty (50). I would hope that the number was higher. This would indicate that the cops today, are smarter than we were. Remember, we were the generation of cops that would say.... "I can't retire now; my kid is just

starting high school." (or even college) The author also stated that more than two thousand (2000) cops are retiring yearly, while only one thousand (1000) lose their pension upon death. That figure of one thousand (1000) does not bode too well in support of his earlier statement; that we are expected to collect our pension for 40 years on the average. His lashing out, directed toward the fire department, was just as 'good.' It seems the average FD retiree is getting an average of "\$85,000, with 72 percent having higher paying disability pensions." Maybe we can offer the "Post" a little advice, if they feel they can negotiate our retirements. Let's have all the cops stop what they're doing (handling accidents, hostage situations, searches for lost children, etc.) when their shift ends and have firefighters roll up their hoses; to save the city a few bucks, at the expense of someone's life.

I execrate the individuals that pretend to weep every time a police officer or firefighter dies in the line of duty; when the first chance they get, they blame us for causing the city's financial crunch. When was the last time a politician, or a reporter has blamed one another for the city's woes?

Suffice to say, rumors will flow as sure as waste runs through our sewers. Should we expect that the mayor and governor will try to trim the cash cow we have so deservingly earned, for our retirement pasture; after giving our all; to allow New York City to be titled; "one of the safest cities in the world" ? You bet we should!...That's gratitude for you ! Don't you think?

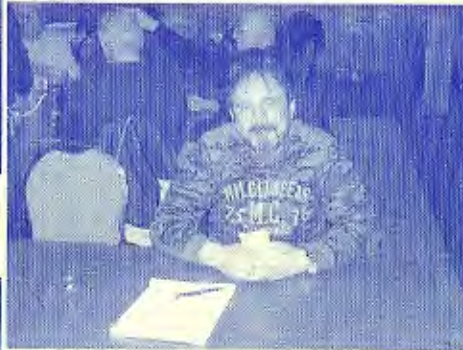



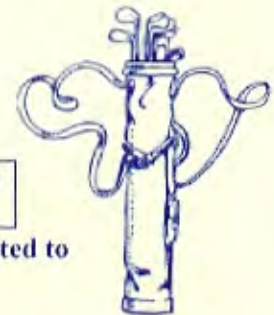
